5.2 Test Procedure & Measurement Data

5.2.1 Radiated Emissions

Test Requirement: FCC Part15 C Section 15.227

Test Method: ANSI C63.4: 2003

Measurement Distance: 3m (Semi-Anechoic Chamber)

Requirements: Carrier Power will not exceed 80dBuV/m at 3m (Average).

Out of band emissions shall not exceed:

40.0 dB μ V/m between 30MHz & 88MHz

43.5 dB μ V/m between 88MHz & 216MHz

46.0 dB μ V/m between 216MHz & 960MHz

54.0 dB μ V/m above 960MHz

Detector: 9KHz to 30MHz RBW=9KHz VBW=30KHz

30MHz to 1000MHz RBW=100KHz VBW=300KHz

Above 1000MHz RBW=1MHz VBW=3MHz

Test Procedure:

1. The EUT is placed on a turntable, which is 0.8m above ground plane.
2. The turntable shall be rotated for 360 degrees to determine the position of maximum emission level.
3. EUT is set 3m away from the receiving antenna, which is moved from 1m to 4m to find out the maximum emissions.
4. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
5. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
6. Repeat above procedures until the measurements for all frequencies are complete.
7. The radiation measurements are performed in X, Y, Z axis positioning. Only the worst case is shown in the report.

27.145MHz Mode

Test Procedure: For testing performed with the loop antenna, testing was performed in accordance to ANSI C63.4 section 8.2.1. The center of the loop was positioned 1 m above the ground and positioned with its plane vertical at the specified distance from the EUT. During testing the loop was rotated about its vertical axis for maximum response at each azimuth and also investigated with the loop positioned in the horizontal plane.

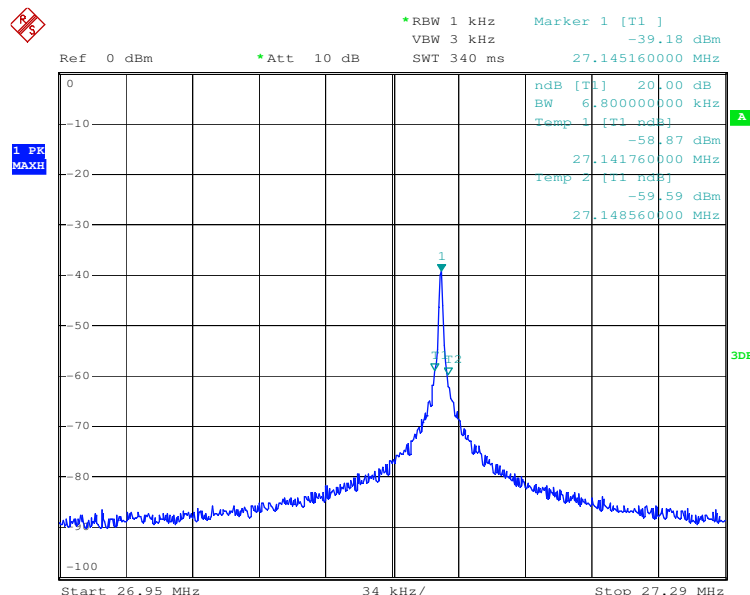
Operation within the band 26.960 – 27.280 MHz

Requirements: Intentional radiators operating under the alternative provisions to the general emission limits, as contained in §§ 15.217 through 15.257 and in subpart E of this part, must be designed to ensure that the 20 dB bandwidth of the emission is contained within the frequency band designated in the rule section under which the equipment is operated. The requirement to contain the 20 dB bandwidth of the emission within the specified frequency band includes the effects from frequency sweeping, frequency hopping and other modulation techniques that may be employed as well as the frequency stability of the transmitter over expected variations in temperature and supply voltage. If frequency stability is not specified in the regulations, it is recommended that the fundamental emission be kept within at least the central 80% of the permitted band in order to minimize the possibility of out-of-band operation.

Method of measurement:

The useful radiated emission from the EUT was detected by the spectrum analyser with peak detector. The vertical Scale is set to 10dB per division. The horizontal scale is set to 34KHz per division.
