

For transmitters designed to operate with a 12.5 kHz channel bandwidth, any emission must be attenuated below the power (P) of the highest emission contained within the authorized bandwidth as follows:

- 1) On any frequency from the centre of the authorized bandwidth f0 to 5.625 kHz removed from f₀: 0dB
- On any frequency removed from the centre of the authorized bandwidth by a displacement frequency (f_d in kHz) of more than 5.625 kHz but no more than 12.5 kHz: At least 7.27(f_d−2.88 kHz) dB.
- On any frequency removed from the centre of the authorized bandwidth by a displacement frequency (f_d in kHz) of more than 12.5 kHz: At least 50 + 10 log (P) dB or 70 dB, whichever is the lesser attenuation.

- 3 Key the transmitter, and set the level of the unmodulated carrier to a full scale reference line. This is the 0dB reference for the measurement.
- 4 Modulate the transmitter with a 2500 Hz sine wave at an input level 16 dB greater than that necessary to produce 50% of rated system deviation(Rated system deviation is 2.5 kHz for 12.5kHz channel spacing). The input level shall be established at the frequency of maximum response of the audio modulating circuit. Transmitters employing digital modulation techniques that bypass the limiter and the audio low-pass filter shall be modulated as specified by the manufacturer





- 3) Set the test receiver to measure peak positive deviation. Set the audio bandwidth for \leq 0.25 Hz to \geq 15,000 Hz. Turn the de-emphasis function off.
- 4) Apply a 1000 Hz modulating signal to the transmitter from the audio frequency generator, and adjust the level to obtain 60% of full rated system deviation, this level is as a reference (0dB) and vary the input level from –20 to +20dB.
- 5) Measure both the instantaneous and steady-state deviation at and after the time of increasing the audio input level
- 6) Repeat step 4-5 with input frequency changing to 300Hz, 1004Hz, 1500Hz and 2500Hz in sequence.

- 5. The EUT shall be replaced by a substitution antenna. In the chamber, an substitution antenna for the frequency band of interest is placed at the reference point of the chamber. An RF Signal source for the frequency band of interest is connected to the substitution antenna with a cable that has been constructed to not interfere with the radiation pattern of the antenna. A power (P_{Mea}) is applied to the input of the substitution antenna, and adjust the level of the signal generator output until the value of the receiver reach the previously recorded (P_r). The power of signal source (P_{Mea}) is recorded. The test should be performed by rotating the test item and adjusting the receiving antenna polarization.
- 6. A amplifier should be connected to the Signal Source output port. And the cable should be connect between the Amplifier and the Substitution Antenna. 


