Two scans were taken: one with Line 1 connected to Analyzer / Receiver and Line 2 connected to a 50 ohm load; the second scan had Line 1 connected to a 50 ohm load and Line 2 connected to the Analyzer / Receiver.
- 7 Analyzer / Receiver scanned from 150 kHz to 30MHz for emissions in each of the test modes.
- 8 During the above scans, the emissions were maximized by cable manipulation.







#### **TEST PROCEDURE**

- 1 The EUT was placed on a turn table which is 0.8m above ground plane.
- 2 Maximum procedure was performed by raising the receiving antenna from 1m to 4m and rotating the turn table from  $0^{\circ}$  to 360°C to acquire the highest emissions from EUT
- 3 And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
- 4 Repeat above procedures until all frequency measurements have been completed.

Transmitter Radiated Spurious Emission:






