1.3 TEST METHODOLOGY

The radiated emission testing was performed according to the procedures of ANSI C63.4; TIA/EIA 603 and FCC CFR 47 2.1046, 2.1047, 2.1049, 2.1051, 2.1053 and 2.1055.

1.4 TEST FACILITY

The fully anechoic chamber test site and conducted measurement facility used to collect the radiated data is located on the address of SHENZHEN HUATONGWEI INTERNATIONAL INSPECTION CO., LTD Huatongwei Building, Keji Rd. 12 S., High-tech Park, Nanshan District, Shenzhen, Guangdong, P.R.China

Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test Receivers.

Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."

The EUT (MOBILE RADIO) has been tested under normal operating condition. Three channels (the top, the middle and the bottom) are chosen for testing at each channel separation (12.5 KHz/ 25KHz).

4. CONDUCTED EMISSION TEST


4.1 MEASUREMENT PROCEDURE

The EUT was tested according to ANSI C63.4 - 2003. The frequency spectrum from 0.15 MHz to 30 MHz was investigated. The LISN used was 50 ohm / 50 u Henry as specified by section 5.1 of ANSI C63.4 - 2003. Cables and peripherals were moved to find the maximum emission levels for each frequency.

Note: The EUT will not be operated during charging the battery with the power adapter.







25 kHz Channel Spacing, 174MHz, 2500 Hz Audio Modulation Only


Occupied Bandwidth of Middle Channel

25 kHz Channel Spacing, 156 MHz, 2500 Hz Audio Modulation Only


Occupied Bandwidth of Bottom Channel






12.5 kHz Channel Spacing, 174 MHz, 2500 Hz Audio Modulation Only


Occupied Bandwidth of Middle Channel

6. RADIATED SPURIOUS EMISSION

6.1 PROVISIONS APPLICABLE

According to Section 90.210,, the power of each unwanted emission shall be less than Transmitted Power as specified below for transmitters designed to operate with 12.5 KHz channel bandwidth:

- 1).On any frequency removed from the center of the authorized bandwidth fo to 5.625 KHz removed from fo: Zero dB
- On any frequency removed from the center of the authorized bandwidth by a displacement frequency (fd in KHz) fo of more than 5.625 KHz but no more than 12.5 KHz: At least 7.27dB
- 3). On any frequency removed from the center of the authorized bandwidth by a displacement frequency (fd in KHz) fo of more than 12.5 KHz: At least 50+10 log (P) dB or 70 dB, which ever is lesser attenuation.

For transmitters designed to transmit with 25 KHz channel separation and equipped with an audio low-pass filter, the power of any emission must be attenuated below the unmodulated carrier power (P) as following:

- On any frequency removed from the assigned frequency by more than 50 percent, but no more than 100 percent of the authorized bandwidth: At least 25 dB.
- 2). On any frequency removed from the assigned frequency by more than 100 percent, but no more than 250 percent of the authorized bandwidth: At least 35 dB.
- 3). On any frequency removed from the assigned frequency by more than 250 percent of the authorized bandwidth: At least 43+10Log (P) dB.

6.2 MEASUREMENT PROCEDURE


- 1). On a test site, the EUT shall be placed on a turntable, and in the position closest to the normal use as declared by the user.
- 2). The test antenna shall be oriented initially for vertical polarization located 3m from the EUT to correspond to the transmitter.
- 3). The output of the antenna shall be connected to the measuring receiver and either a peak or quasi-peak detector was used for the measurement as in dicated on the report. The detector selection is based on how close the emission level was approaching the limit.
- 4). The transmitter shall be switched on; if possible, without the modulation and the measurement receiver shall be tuned to the frequency of the transmitter under test.
- 5). The test antenna shall be raised and lowered through the specified range of height until the measuring receiver detects a maximum signal level.
- 6). The transmitter shall than be rotated through 360° in the horizontal plane, until the

maximum signal level is detected by the measuring receiver.


- 7). The test antenna shall be raised and lowered again through the specified range of height until the measuring receiver detects a maximum signal level.
- 8). The maximum signal level detected by the measuring receiver shall be noted.
- 9). The measurement shall be repeated with the test antenna set to horizontal polarization.
- 10). Replace the antenna with a proper Antenna (substitution antenna).
- 11). The substitution antenna shall be oriented for vertical polarization and, if necessary, the length of the substitution antenna shall be adjusted to correspond to the frequency of
- of the substitution antenna shall be adjusted to correspond to the frequency of transmitting.
- 12). The substitution antenna shall be connected to a calibrated signal generator.
- 13). If necessary, the input attenuator setting of the measuring receiver shall be adjusted in order to increase the sensitivity of the measuring receiver.
- 14). The test antenna shall be raised and lowered through the specified range of the height to ensure that the maximum signal is received.
- 15). The input signal to substitution antenna shall be adjusted to the level that produces a level detected by the measuring receiver, that is equal to the level noted while the transmitter radiated power was measured, corrected for the change of input attenuation setting of the measuring receiver.
- 16). The input level to the substitution antenna shall be recorded as power level in dBm, corrected for any change of input attenuator setting of the measuring receiver.
- 17). The measurement shall be repeated with the test antenna and the substitution antenna oriented for horizontal polarization


(Block diagram of configuration)


8.2 MEASUREMENT METHOD

8.2.1 Modulation Limit

- 1). Configure the EUT as shown in figure 1, adjust the audio input for60% of rated system deviation at 1KHz using this level as a reference (0dB) and vary the input level from -20 to +20dB. Record the frequency deviation obtained as a function of the input level.
- 2). Repeat step 1 with input frequency changing to 300, 1004, and 2500Hz in sequence.

8.2.2 Audio Frequency Response

- 1). Configure the EUT as shown in figure 1.
- 2). Adjust the audio input for 20% of rated system deviation at 1 KHz using this level as a reference (0dB).
- 3). Vary the Audio frequency from 100 Hz to 10 KHz and record the frequency deviation.
- 4) Audio Frequency Response =20log10 (Deviation of test frequency/Deviation of 1 KHz reference).

9. FREQUENCY STABILITY MEASUREMENT

9.1 PROVISIONS APPLICABLE

- a). According to FCC Part 2 Section 2.1055 (a)(1), the frequency stability shall be measured with variation of ambient temperature from -30 ℃ to +60 ℃ centigrade.
- b). According to FCC Part 2 Section 2.1055 (a)(2), for battery powered equipment, the frequency stability shall be measured with reducing primary supply voltage to the battery operating end point, which is specified by the manufacture.
 c). According to §90.213, the frequency stability limit is 2.5 ppm for 12.5KHz channel separation and 5 ppm for 25KHz channel separation.


9.2 MEASUREMENT PROCEDURE

The EUT was set in the climate chamber and connected to an external DC power supply. The RF output was directly connected to Spectrum Analyzer ESI 26. The coupling loss of the additional cables was recorded and taken in account for all the measurements. After temperature stabilization (approx. 20 min for each stage), the frequency for the lower, the middle and the highest frequency range was recorded. For Frequency stability Vs. Voltage the EUT was connected to an DC power supply and the voltage was adjusted in the required ranges. The result was recorded.


Transmitter Frequency Behaviour @ 12.5 KHz Channel Separation-----Off - On




Transmitter Frequency Behaviour @ 12.5 KHz Channel Separation-----On - Off







