Please address following issues.

Q#1: Please provide a block diagram which has included all applicable oscillators in the device per Part 2.1033.

<Aven>The attached is the revised block diagram.

Q#2: As indicated in the user manual, 14 channels are available for this mini-PCI card which is not allowed. Also, the typical output power indicated in the user manual is 21mW which is about 20mW different from the measured result. Please address.

<Aven>The attached is the revised user manual.

Q#3: As indicated in section 2.6 of user manual, user is allowed to install this mini-PCI card which doesn't agree with modular approval. Noted that this device can only be installation by OEM integrators.

<Aven> Section 2.6 was deleted from the user manual.

Q#4: As indicated in the test report, 3 planes of x, y, z axes were verified during the test. Please show out how the y and z axes were investigated.
