### TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.4: 2003 and FCC CFR 47 15.207, 15.209 and 15.247.

#### **EUT CONFIGURATION**

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

#### **EUT EXERCISE**

The EUT was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

According to its specifications, the EUT must comply with the requirements of the Section 15.207, 15.209 and 15.247 under the FCC Rules Part 15 Subpart C.

#### GENERAL TEST PROCEDURES

#### **Conducted Emissions**

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 13.1.4.1 of ANSI C63.4 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-peak and average detector modes.

#### **Radiated Emissions**

The EUT is placed on a turn table, which is 0.8 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 13.1.4.1 of ANSI C63.4.

#### 3.5 DESCRIPTION OF TEST MODES

The EUT has been tested under operating condition.

Software used to control the EUT for staying in continuous transmitting and receiving mode is programmed.

IEEE802.11b: Channel 1(2412MHz), Channel 6(2437MHz) and Channel 11(2462MHz) with 11Mbps highest data rate (worst case) are chosen for the final testing.

IEEE802.11g: Channel 1(2412MHz), Channel 6(2437MHz) and Channel 11(2462MHz) with 6Mbps data rate (the worst case) are chosen for the final testing.

All emissions tests were made with the worst-case data rates.




# 6dB Bandwidth (CH Mid)





- Use a video trigger with the trigger level set to enable triggering only on full power pulses. Transmitter must operate at full control power for entire sweep of every sweep. ### PPSD (CH Low)



#### 30MHz ~ 2.9GHz




