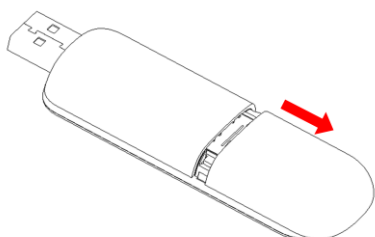
Introduction

The USB modem is a multi-mode 3G modem. With a USB interface connecting to your laptop or desktop computer, it supports data and SMS services through the mobile phone network, helping you realize mobile communication anytime and anywhere.

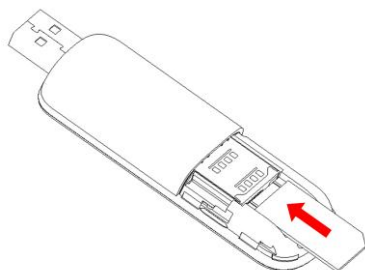
Hardware Installation

Installing the SIM/USIM Card

1. Remove the back cover on the modem.



2. Hold your SIM/USIM card with the cut corner oriented as shown and then slide it into the card holder with the metal contacts facing the modem.



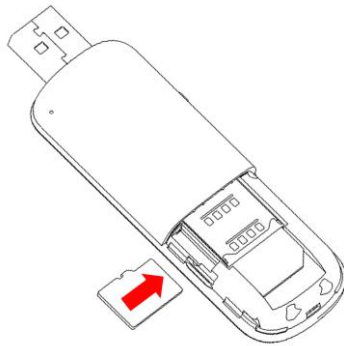
3. Replace the back cover.

Installing the Memory Card

Only microSD card is supported by the modem and do not insert other types of memory cards into the modem.

The maximum capacity of the microSD card supported is 32 GB.

Insert the microSD card, orientated as shown, into the microSD card slot until you hear a click.



Notes:

The  logo is a trademark of the SD Card Association.

Connecting to Your Computer

Plug the retractable USB of the modem to the USB port of your computer. Make sure that it is tightly inserted.

If your PC runs a Windows operating system, it will automatically detect and recognize the modem and display a new icon in the taskbar, indicating that the PC and the modem have been connected properly.

Software Installation

On different operating systems, the software installation procedures may be different. Please follow the general guide below and the system prompts during installation.

• For Windows XP, Vista and Windows 7

When you connect the modem to your PC correctly, the system automatically recognizes the modem as a new CD-ROM drive and launch the software installation wizard. If the system does not launch the installation wizard automatically, please start it by running the executable file in the new CD-ROM directory.

• For Mac OS

The system will automatically display a new CD-ROM icon on the desktop, when you connect the modem to your Mac correctly. Double click the installation software package in the CD-ROM, and follow the system prompts to complete the software installation.

Functions

Open the installed software and click the following buttons to access each function.

LED Light

The LED lights up when the modem is connected to the PC.

Color	Modem Status
Red	Power on, but not registered to a network
Blue solid	Registered to a 3G network
Blue blinking	Active data transfer on the 3G network
Green solid	Registered to a 2G network
Green blinking	Active data transfer on the 2G network

Warning and notice

To the owner

- Some electronic devices are susceptible to electromagnetic interference sent by modem if inadequately shielded, such as the electronic system of vehicles. Please consult the manufacturer of the device before using the modem if necessary.
- Operating of laptop and desktop PCs and the modem may interfere with medical devices like hearing aids and pacemakers. Please always keep them more than 20 centimeters away from such medical devices when they are turned on. Turn the modem off if necessary. Consult a physician or the manufacturer of the medical device before using the modem.
- **Operating of laptop and desktop PCs please keep this modem more than 5mm away from your body.**
- Be aware of the usage limitation when using a modem at places such as oil warehouses or chemical factories, where there are explosive gases or explosive products being processed. Turn off your modem if required.
- The use of electronic transmitting devices is forbidden in aircrafts, at petrol stations and in hospitals. Please observe and obey all warning signs and switch off your modem in these conditions.
- Do not touch the inner antenna area if not necessary. Otherwise it will affect your modem's performance.
- Store the modem out of the reach of little children. The modem may cause injury if used as a toy.
- Do not touch the metallic parts of the modem so as to avoid a burn, when the modem is working.

Health and safety information

Radio Frequency (RF) Energy

This USB MODEM meets the government's requirements for exposure to radio waves.

This USB MODEM is designed and manufactured not to exceed the emission limits for exposure to radio frequency (RF) energy set by the Federal Communications Commission of the U.S. Government:

The exposure standard for wireless mobile phones employs a unit of measurement known as the Specific Absorption Rate, or SAR. The SAR limit set by the FCC is 1.6W/kg. *Tests for SAR are conducted using standard operating positions accepted by the FCC with the USB MODEM transmitting at its highest certified power level in all tested frequency bands. Although the SAR is determined at the highest certified power level, the actual SAR level of the USB MODEM while operating can be well below the maximum value. This is because the USB MODEM is designed to operate at multiple power levels so as to use only the power required to reach the network. In general, the closer you are to a wireless base station antenna, the lower the power output.

The highest SAR value for the USB MODEM as reported to the FCC when tested for Body-worn measurements is 1.17 W/kg with 5mm air gap. While there may be differences between the SAR levels of various phones and at various positions, they all meet the government requirement.

The FCC has granted an Equipment Authorization for this model phone with all reported SAR levels evaluated as in compliance with the FCC RF exposure guidelines. Using your USB Modem

- Please use original accessories or accessories that are authorized. Using any unauthorized accessories may affect your modem's performance, and violate related national regulations about telecom terminals.
- Avoid using the modem near or inside metallic structures or establishments that can emit electromagnetic waves. Otherwise it may influence signal reception.
- The modem is not waterproof. Please keep it dry and store in a shady and cool place.
- Do not use the modem immediately after a sudden temperature change. In such case, it will produce dew inside and outside the modem, so don't use it until it becomes dry.
- Handle the modem carefully. Do not drop, bend or strike it. Otherwise the modem will be damaged.
- No dismantling by non-professionals and only qualified technicians can undertake repair work.
- Operating temperature range of -10°C ~ +60°C and humidity range of 5% ~ 95% are recommended.
