The worst radiated emission was found in Mode A & D, the worst cases, were chosen for final test.

- 2. Above 1 GHz, the channel 1, 6, and 11 were tested individually.
- 3. Transfer rate, 11Mbps with CCK technique and 6Mbps with OFDM technique, the worst case, were chosen for final test.

3.3 GENERAL DESCRIPTION OF APPLIED STANDARDS

The EUT is a Wireless-G Broadband Router with 4-port Switch. According to the specifications of the manufacturer, it must comply with the requirements of the following standards:

47 CFR Part 15, Subpart C. (15.247)

ANSI C63.4: 2001

All tests have been performed and recorded as per the above standards.

NOTE: The EUT is also considered as a kind of computer peripheral, because the connection to computer is necessary for typical use. It has been verified to comply with the requirements of 47 CFR Part 15, Subpart B, Class B (DoC). The test report has been issued separately.

The EUT has been tested as an independent unit together with other necessary accessories or support units. The following support units or accessories were used to form a representative test configuration during the tests.





2. TEST PROCEDURES

- a. The EUT/HOST was placed 0.4 meters from the conducting wall of the shielded room with EUT/HOST being connected to the power mains through a line impedance stabilization network (LISN). Other support units were connected to the power mains through another LISN. The two LISNs provide 50 ohm/ 50uH of coupling impedance for the measuring instrument.
- b. Both lines of the power mains connected to the EUT/HOST were checked for maximum conducted interference.
- c. The frequency range from 150 kHz to 30 MHz was searched. Emission levels over 10dB under the prescribed limits could not be reported

4.1.3 TEST SETUP



Note: 1. Support units were connected to second LISN.

2. Both of LISNs (AMN) 80 cm from EUT and at the least 80 cm from other units and other metal planes support units.

4.1.4 EUT OPERATING CONDITIONS

- a. Placed the EUT on the testing table.
- b. The support units (1-6) act as a Server PC system to communicate with EUT via UTP cable.
- c. Prepared other computer systems (support unit 7) to act as a communication partner and placed them outside of testing area.
- d. The communication partner run test program "Super Terminating" to enable EUT under transmission/receiving condition continuously via one UTP cable and wireless transmission.
- e. PC sends "H" messages to modem.
- f. PC sends "H" messages to printer, and the printer prints them on paper.





4.2.3 TEST PROCEDURES


- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 10 meter open area test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- c. The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- f. If the emission level of the EUT in peak mode was 10 dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10 dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.

NOTE:

- 1. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 120kHz for Peak detection (PK) and Quasi-peak detection (QP) at frequency below 1GHz.
- 2. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 1 MHz for Peak detection at frequency above 1GHz.
