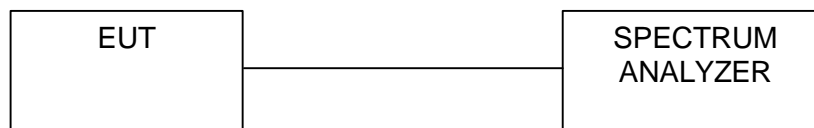
4.5.3 TEST PROCEDURE

The transmitter output was connected to the spectrum analyzer through an attenuator, the bandwidth of the fundamental frequency was measured with the spectrum analyzer using 3kHz RBW and 30kHz VBW, set sweep time=span/3kHz. The power spectral density was measured and recorded. The sweep time is allowed to be longer than span/3KHz for a full response of the mixer in the spectrum analyzer.

4.6.3 TEST PROCEDURE

The transmitter output was connected to the spectrum analyzer via a low lose cable. Set both RBW and VBW of spectrum analyzer to 100kHz for CCK technique and RBW = 1MHz and VBW = 300Hz for OFDM technique with suitable frequency span including 100MHz bandwidth from band edge. The band edges was measured and recorded.

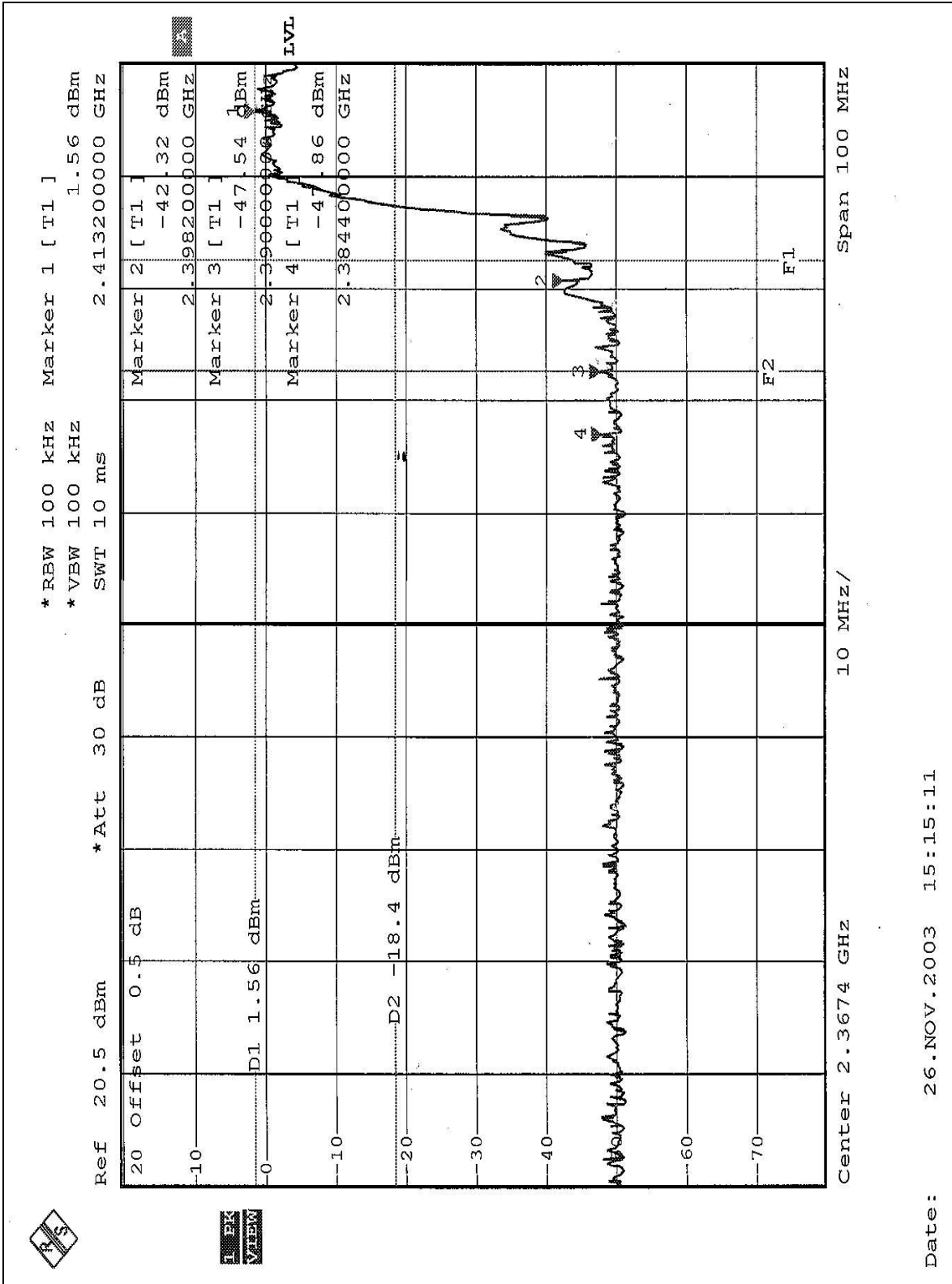
The spectrum plots are attached on the following 2 pages. D2 line indicates the highest level, D1 line indicates the 20dB offset below D2. It shows compliance with the requirement in part 15.247(C).

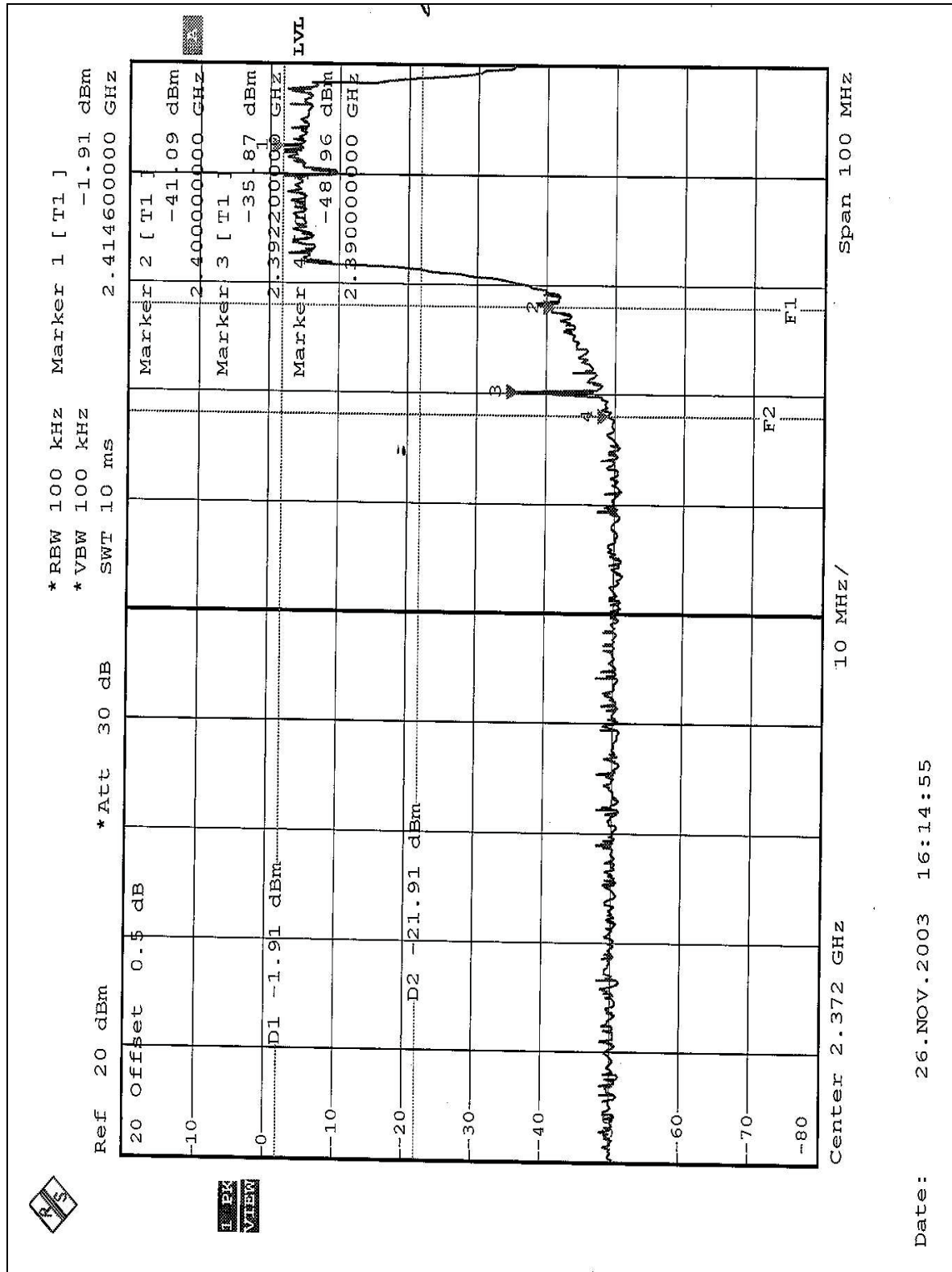
NOTE 1: The band edge emission plot of the CCK technique on the first page shows 49.1dB delta between carrier maximum power and local maximum emission in restrict band 2.3900GHz. The emission of carrier strength list in the test result of channel 1 at the item 4.2.7 is 93.07dBuV/m, so the maximum field strength in restrict band is $93.07-49.1=43.97$ dBuV/m which is under 54dBuV/m limit.

NOTE 2: The band edge emission plot of the CCK technique on the second page shows 48.82dB delta between carrier maximum power and local maximum emission in restrict band 2.4837GHz. The emission of carrier strength list in the test result of channel 11 at the item 4.2.7 is 93.21dBuV/m, so the maximum field strength in restrict band is $93.21-48.82=44.39$ dBuV/m which is under 54dBuV/m limit.

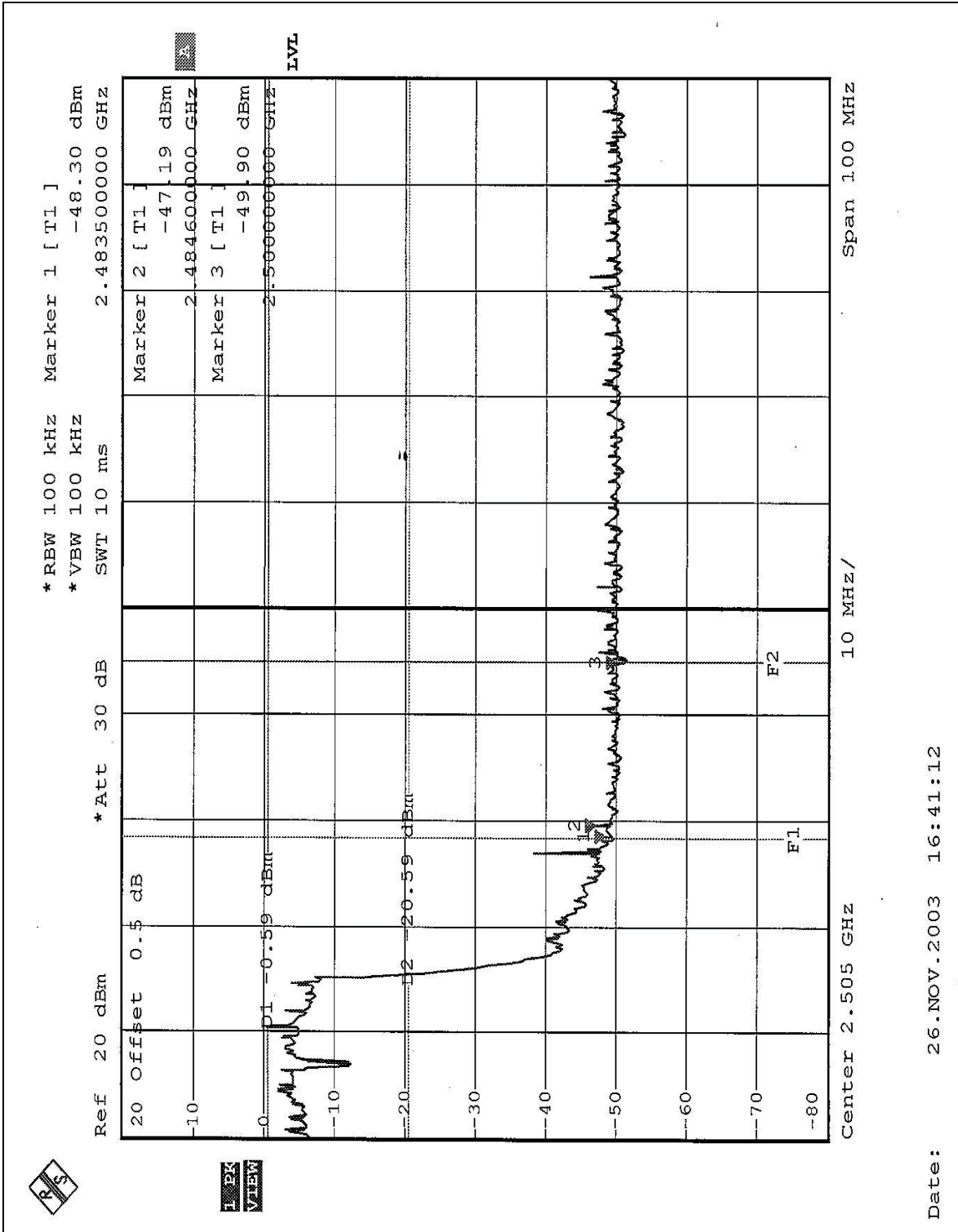
NOTE 3: The band edge emission plot of the OFDM technique on the third page shows 47.05dB delta between carrier maximum power and local maximum emission in restrict band 2.3900GHz. The emission of carrier strength list in the test result of channel 1 at the item 4.2.7 is 94.29dBuV/m, so the maximum field strength in restrict band is $94.29-47.05=47.24$ dBuV/m which is under 54dBuV/m limit.

NOTE 4: The band edge emission plot of the OFDM technique on the fourth page shows 46.6dB delta between carrier maximum power and local maximum emission in restrict band 2.4846GHz. The emission of carrier strength list in the test result of channel 11 at the item 4.2.7 is 94.99dBuV/m, so the maximum field strength in restrict band is $94.99-46.6=48.39$ dBuV/m which is under 54dBuV/m limit.

4.7.1 STANDARD APPLICABLE

For intentional device, according to FCC 47 CFR Section 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

And according to FCC 47 CFR Section 15.247 (b), if transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.

4.7.2 ANTENNA CONNECTED CONSTRUCTION

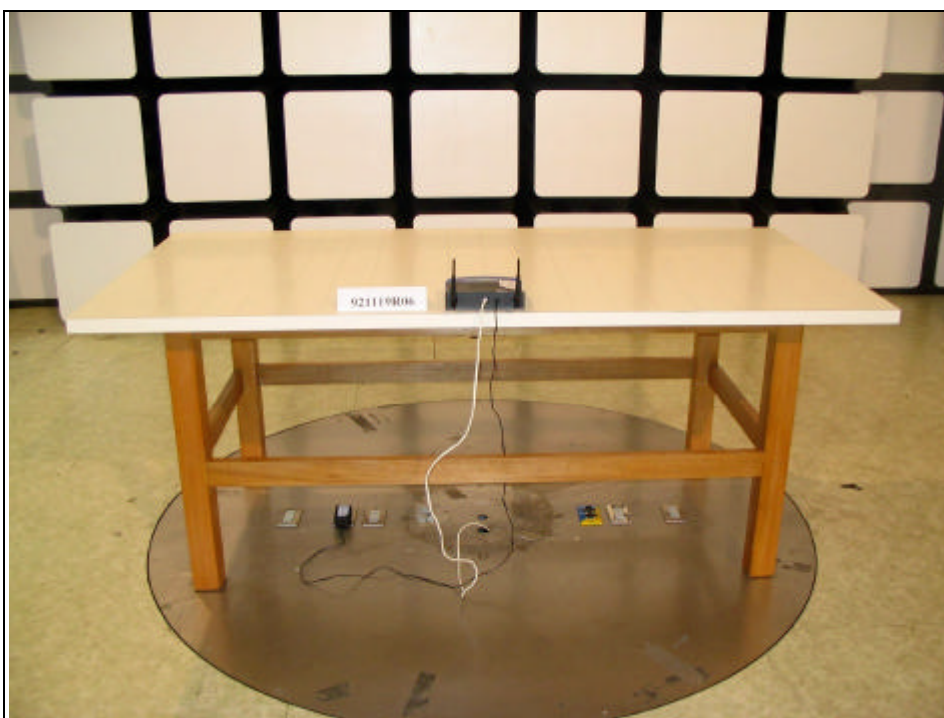
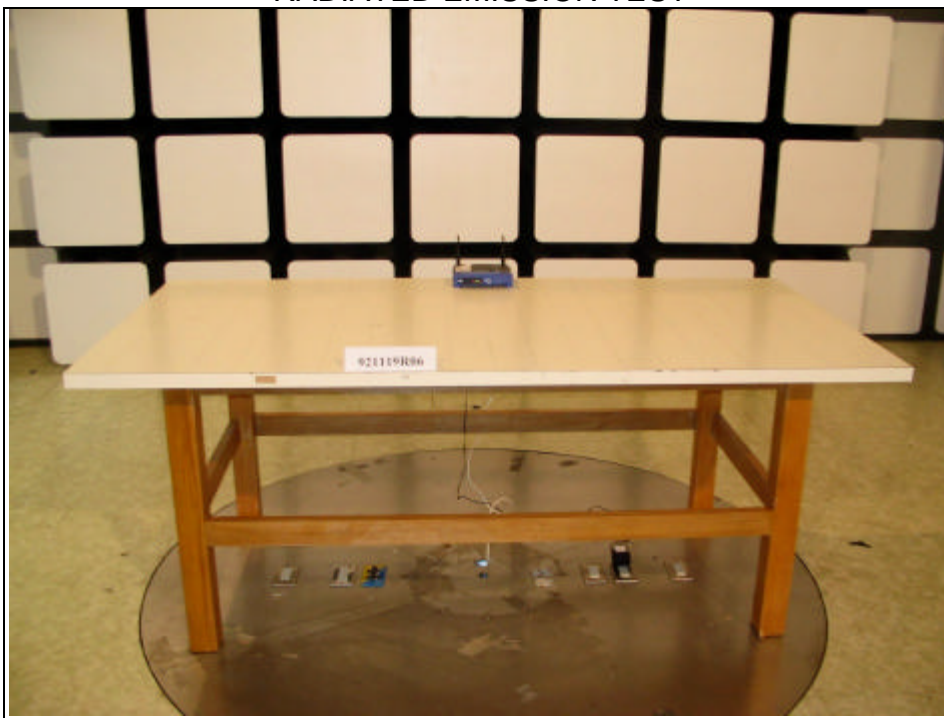
The antenna type used in this product is Dipole Antenna with reverse TNC connector. The maximum Gain of this antenna is only 2dBi.
