The aggregate duration of control signals will not count quiet periods in between transmissions.</p> <p><b>Note 3:</b> During the U-NII Detection Bandwidth detection test, radar type 1 is used and for each frequency step the minimum percentage of detection is 90 percent. ## 3.4 PARAMETERS OF DFS TEST SIGNALS

Step intervals of 0.1 microsecond for Pulse Width, 1 microsecond for PRI, 1 MHz for chirp width and 1 for the number of pulses will be utilized for the random determination of specific test waveforms.

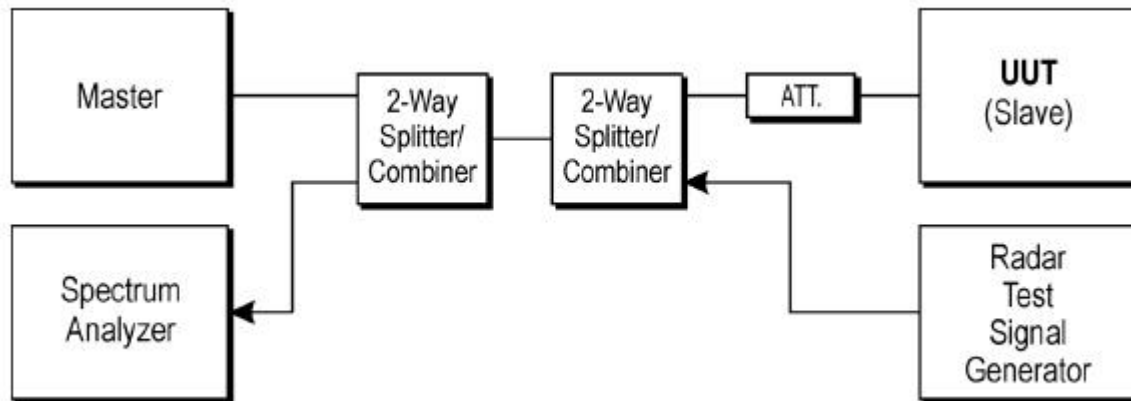

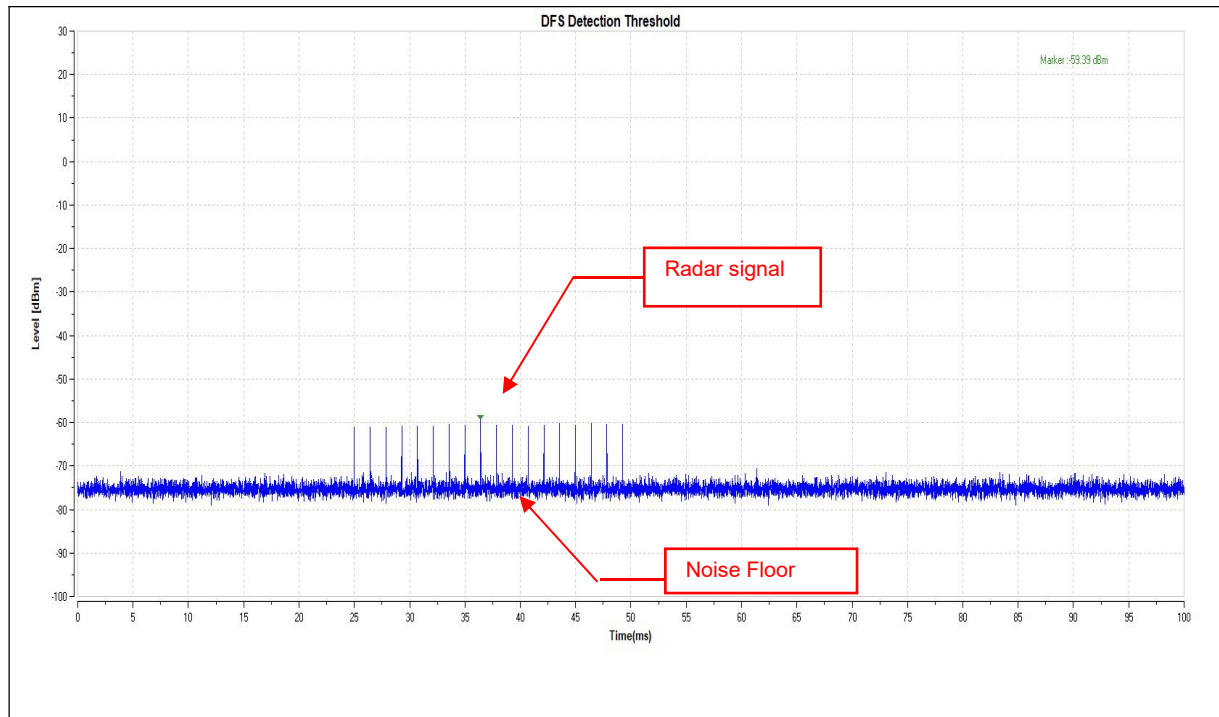

### 4.1 Test Setup of DFS



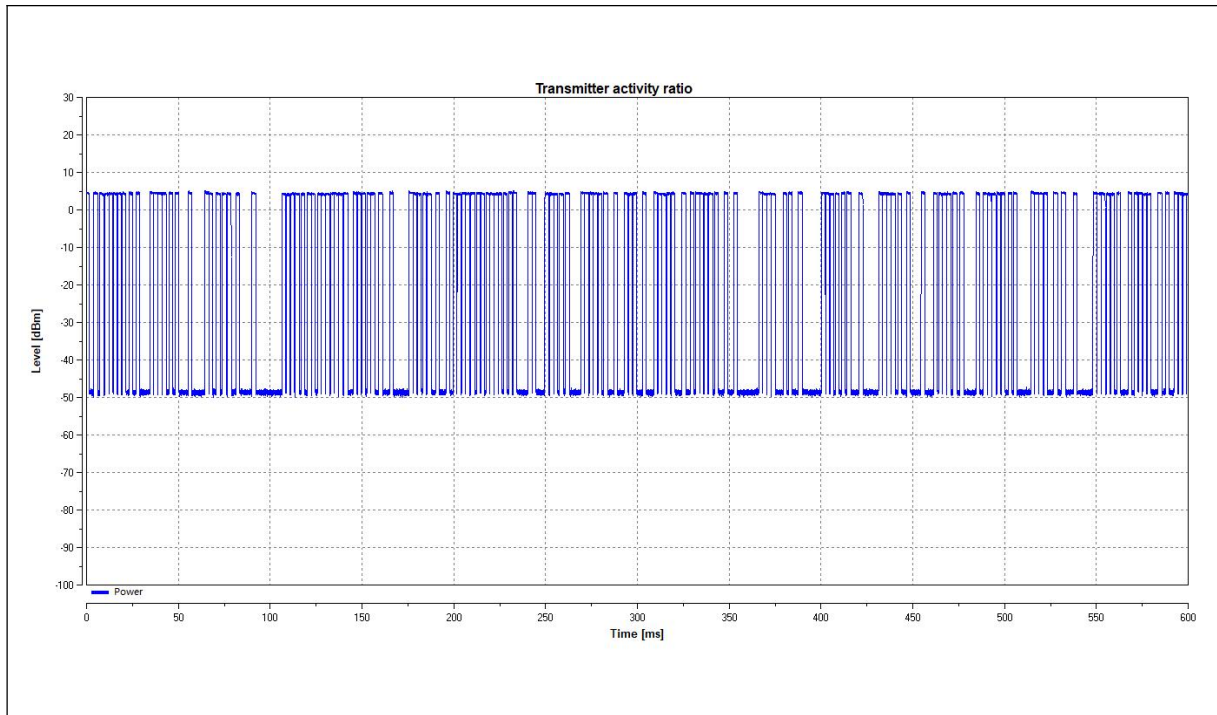
## 4.2 DFS Detection Threshold

The Required detection threshold is  $-59.05.00\text{dBm} = -64 + 4.95\text{dBi}$ . The conducted radar burst level is set to  $-59.39\text{dBm}$ .



## 4.3 Channel loading

The radar signal was the same as transmitted channels, and injected into the antenna port of AP (master) with radar signal, measured the channel shutdown. The slave transmitted the test data to master, the transmitted duty cycle is 20.413%.

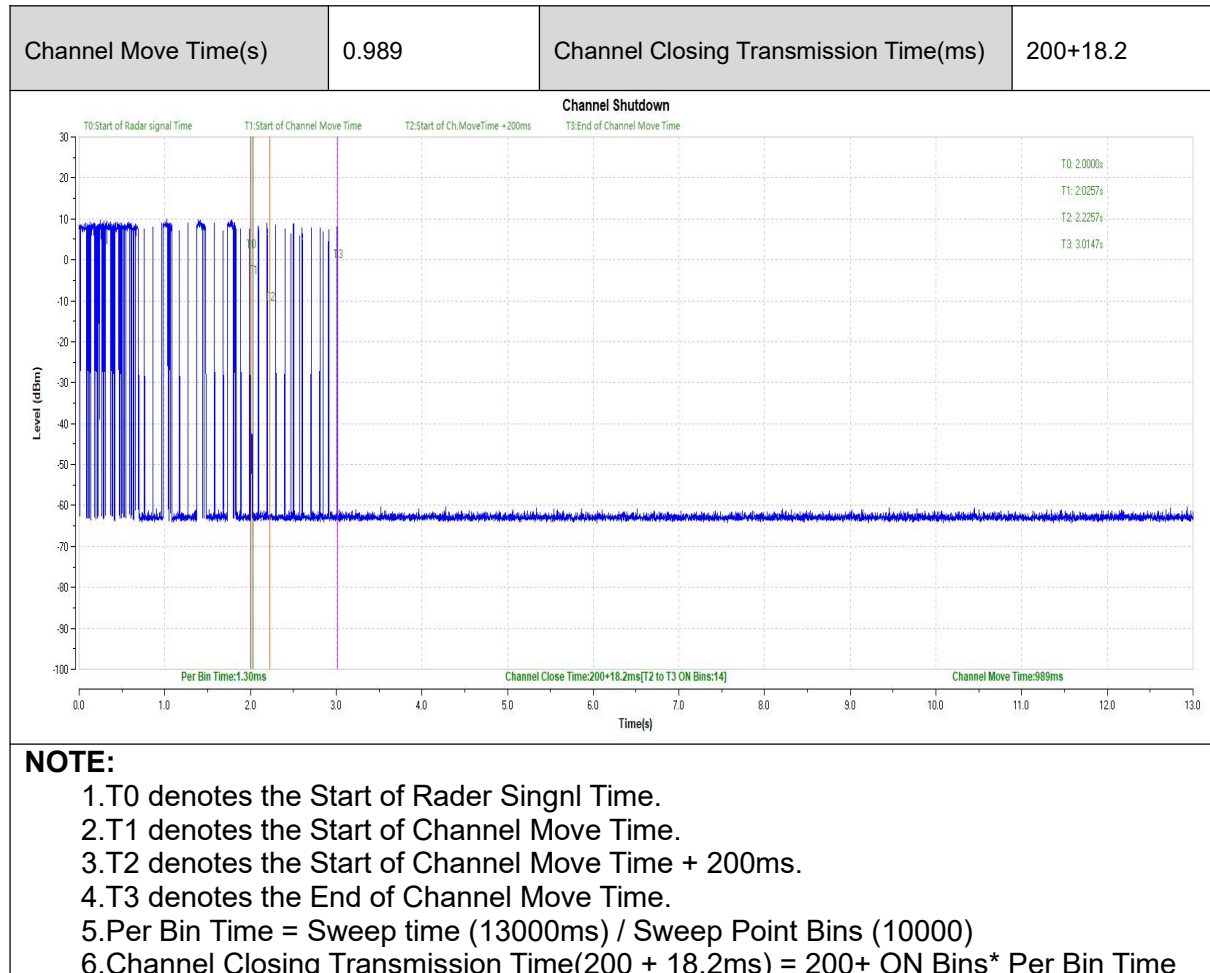


Note: Traffic signal: from slave transmit to master.

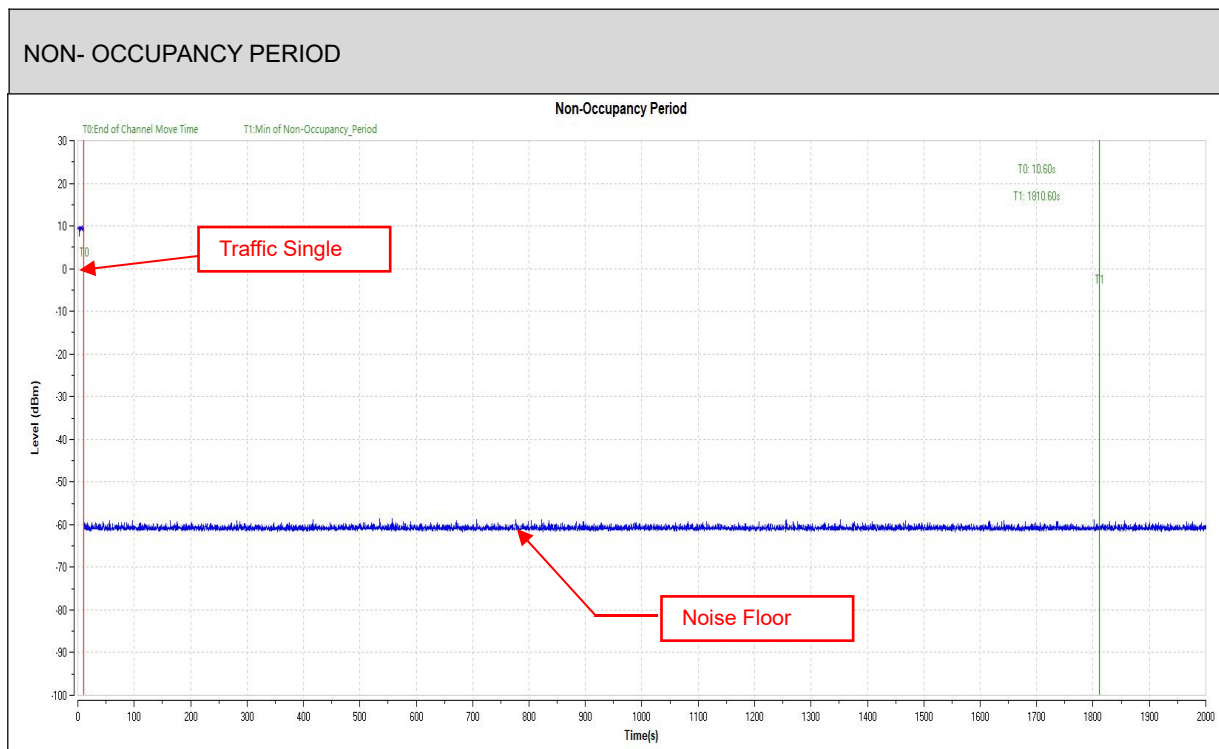

## 4.5 Non-Occupancy Period

- 1) Test results demonstrating an associated client link is established with the master on a test frequency
- 2) The client and DFS-certified master device are associated, and system testing will be performed with channel-loading for a non-occupancy period test.
- 3). The device transmits one type of radar as specified in the DFS Order.
- 4) The test frequency has been monitored to ensure no transmission of any type has occurred for 30 minutes;  
Note: If the client moves with the master, the device is considered compliant if nothing appears in the client non-occupancy period test. For devices that shut down (rather than moving channels), no beacons should appear;
- 5)An analyzer plot that contains a single 30-minute sweep on the original test frequency.



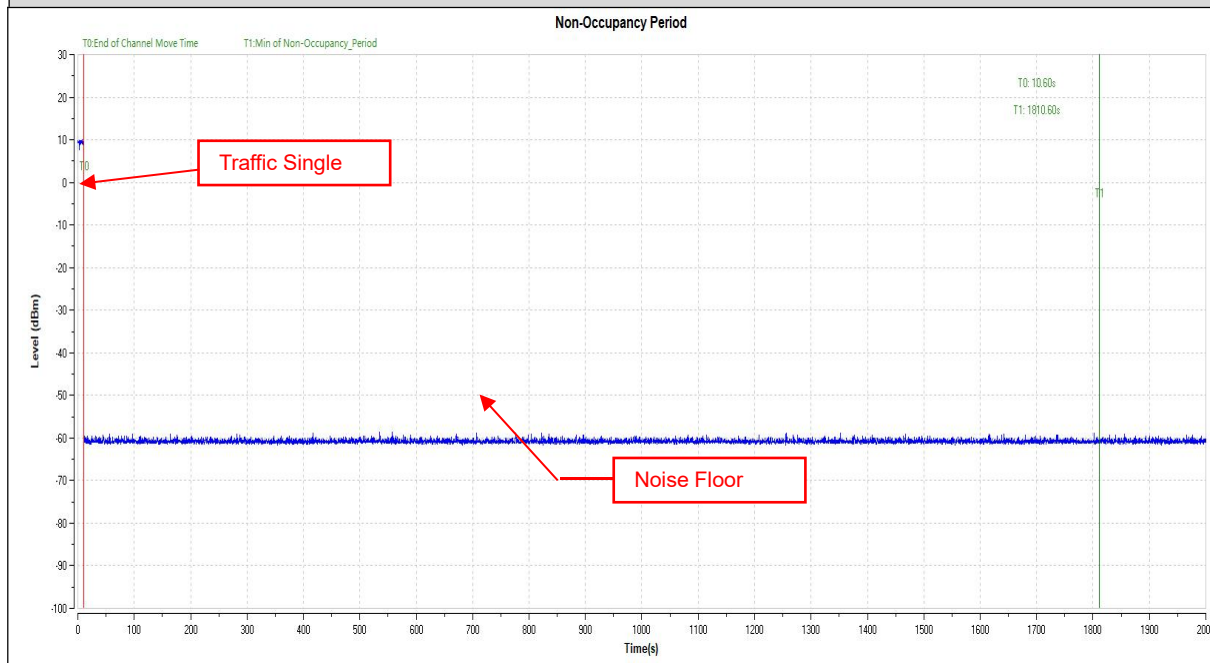
