# **3. TEST METHODOLOGY**

The tests documented in this report were performed in accordance with ANSI C63.4 and FCC CFR 47 2.1046, 2.1047, 2.1049, 2.1051, 2.1053, 2.1055, 2.1057, 15.107, 15.109 and 15.207, 15.209,15.247.

### 3.1 EUT CONFIGURATION

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

### 3.2 EUT EXERCISE

The EUT was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

According to its specifications, the EUT must comply with the requirements of the Section 15.107 and 15.109 under the FCC Rules Part 15 Subpart B and Section 15.207, 15.209, 15.247 under the FCC Rules Part 15 Subpart C.

### **3.3 GENERAL TEST PROCEDURES**

#### **Conducted Emissions**

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 13.1.4.1 of ANSI C63.4 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-peak and average detector modes.

#### **Radiated Emissions**

The EUT is placed on a turn table, which is 0.8 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this hand-held transmitter (EUT) was rotated through three orthogonal axes according to the requirements in Section 13.1.4.1 of ANSI C63.4.

### **3.5 DESCRIPTION OF TEST MODES**

The EUT has been tested under operating condition.

Software used to control the EUT for staying in continuous transmitting and receiving mode is programmed.

Channel 1 (2412MHz), Channel 6 (2437MHz) and Channel 11 (2462MHz) with 11Mbps highest data rate (worst case) are chosen for the final testing with the methodologies and configurations upon the FCC grant conditions on applying both mobile (modular) and laptop (stand-alone) device.



# 4. INSTRUMENT CALIBRATION

The measuring equipment, which was utilized in performing the tests documented herein, has been calibrated in accordance with the manufacturer's recommendations for utilizing calibration equipment, which is traceable to recognized national standards.



# 5. FACILITIES AND ACCREDITATIONS

### **5.1FACILITIES**

All measurement facilities used to collect the measurement data are located at

The sites are constructed in conformance with the requirements of ANSI C63.7, ANSI C63.4 and CISPR Publication 22.

### **5.2EQUIPMENT**

Radiated emissions are measured with one or more of the following types of linearly polarized antennas: tuned dipole, biconical, log periodic, bi-log, and/or ridged waveguide, horn. Spectrum analyzers with pre-selectors and quasi-peak detectors are used to perform radiated measurements.

Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test Receivers.

Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."

### **5.3LABORATORY ACCREDITATIONS AND LISTING**

The test facilities used to perform radiated and conducted emissions tests are accredited by National Voluntary Laboratory Accreditation Program for the specific scope of accreditation under Lab Code: 200600-0 to perform Electromagnetic Interference tests according to FCC PART 15 AND CISPR 22 requirements. 






#### Test Plot

#### 6dB Bandwidth (CH Low)




#### 6dB Bandwidth (CH Mid)





#### Peak power (CH Low)




#### Peak power (CH Mid)

#### PPSD (CH Low)




In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement. Attenuation below the general limits specified in Section 15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in Section 15.205(a), must also comply with the radiated emission limits specified in Section 15.209(a) (see Section 15.205(c)).

### **TEST PROCEDURE**

Conducted RF measurements of the transmitter output were made to confirm that the EUT antenna port conducted emissions meet the specified limit and to identify any spurious signals that require further investigation or measurements on the radiated emissions site.

The transmitter output is connected to the spectrum analyzer. The resolution bandwidth is set to 100 KHz. The video bandwidth is set to 100 KHz.

Measurements are made over the 30MHz to 26GHzrange with the transmitter set to the lowest, middle, and highest channels.





#### 30MHz ~ 2.9GHz








#### CH Mid

#### 30MHz ~ 2.9GHz





### **TEST PROCEDURE**

- 1. The EUT is placed on a turntable, which is 0.8m above ground plane.
- 2. The turntable shall be rotated for 360 degrees to determine the position of maximum emission level.



# 7.7 POWERLINE CONDUCTED EMISSIONS

# **LIMIT**

For an intentional radiator which is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed 250 microvolts (The limit decreases linearly with the logarithm of the frequency in the range 0.15 MHz to 0.50 MHz). The limits at specific frequency range is listed as follows:

Compliance with this provision shall be based on the measurement of the radio frequency voltage between each power line (LINE and NEUTRAL) and ground at the power terminals.

## **Test Configuration**

- 1. The conducted emission tests were performed in the test site, using the setup in accordance with the ANSI C63.4.
- 2. The EUT was plug-in the host PC via PCMCIA port. The host PC system was placed on the center of the back edge on the test table. The peripherals like modem, monitor printer, K/B, and mouse were placed on the side of the host PC system. The rear of the EUT and peripherals were placed flushed with the rear of the tabletop.
- 3. The keyboard was placed directly in the front of the monitor, flushed with the front tabletop. The mouse was placed next to the Keyboard, flushed with the back of keyboard.
- 4. The spacing between the peripherals was 10 centimeters.
- 5. External I/O cables were draped along the edge of the test table and bundle when necessary.
- 6. The host PC system was connected with 110Vac/60Hz power source.

The EUT is set to transmit in a continuous mode.

## **TEST PROCEDURE**

- 1. The EUT was placed on a table, which is 0.8m above ground plane.
- 2. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
- 3. Repeat above procedures until all frequency measured were complete.



## **TEST RESULTS**

The initial step in collecting conducted data is a spectrum analyzer peak scan of the measurement range. Significant peaks are then marked as shown on the following data page, and these signals are then quasi-peaked.


