#### 1 General Information

#### 1.1 General Description

The equipment under test (EUT) is a transmitter for MLS RC Soccer Game. Operating at 49.860 MHz which is controlled by a crystal. The EUT is powered by 9V size battery. It has two control stick in the EUT. When the forward, backward, turn left and turn right stick is pushed once, it will transmit a radio signal for receiver go difference direction.

The brief circuit description is listed as follows:

- X1, Q1 and associated circuit act as oscillator.
- Q2 and associated circuit act as RF amplify.
- U1 and associated circuit act as encoder.

#### 2 Description of the radiated emission test

#### 2.1 Test Procedure

Radiated emissions measurements are investigated and taken pursuant to the procedures of ANSI C63.4 – 2001.

The equipment under test (EUT) was placed on a non-conductive turntable with dimensions of 1.5 m x 1m and 0.8 m high above the ground. 3m from the EUT, a broadband antenna mounting on the mast received the signal strength. The turntable was rotated to maximize the emission level. The antenna was then moving along the mast from 1m up to 4m until no more higher value was found. Both horizontal and vertical polarization of the antenna were placed and investigated.

The device was rotated through three orthogonal axes to determine which attitude and configuration produce the highest emission during measurement.

#### 2.2 Test Result

Peak Detector data was measured unless otherwise stated.

\* Emissions appearing within the restricted bands shall follow the requirement of section 15.205.

It was found that the EUT meet the FCC requirement.

#### 5.1 Bandwidth

The plot on saved in TestRpt 2.pdf shows the fundamental emission is confined in the specified band. The field strength of any emission appearing between the band edges and up to 10 kHz above and below the band edges (49.81 and 49.91 MHz) is at least 26dB below the carrier level. It meets the requirement of Section 15.235(b).

#### 5.2 The duty cycle is simply the on-time divided by the period :

The duration of one cycle = 79.1ms

Effective period of the cycle =  $(58 \times 530 \mu s) + (4 \times 1.74 ms)$ 

= 32.48ms

Duty Cycle = 32.48 ms / 79. lms

= 0.411

Therefore, the average factor is found by  $20 \log_{10} 0.411 = -7.7 dB$
