The following attestation addresses the requirements to support modular approval pursuant to §15.212 of the Commission's Rules:

Unless the transmitter module will be battery powered, it must comply with the AC line conducted requirements found in §1 5.207. AC or DC power lines and data input/output lines connected to the module must not contain ferrites, unless they will be marketed with the module (see §15.27(a)). The length of these lines shall be the length typical of actual use or, if that length is unknown, at least 10 cen-	X

quirements that ordinarily apply to a complete transmitter and the manufacturer		
must provide adequate instructions along with the module to explain any such re-	X	
quirements. A copy of these instructions must be included in the application for		
equipment authorization.		
(viii) The modular transmitter must comply with any applicable RF exposure require-	Х	
ments in its final configuration.
