

## 2. SYSTEM TEST CONFIGURATION

### 2.1. EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

### 2.2. EUT Exercise

The EUT (Transmitter) was operated in the continuous transmission mode employed with the simulator of the Base Station that fixates at test default channels to fix the Tx frequency which was for the purpose of the measurements.

### 2.3. Test Procedure

#### 2.3.1 Conducted Measurement at Antenna Port

According to measurement procured ANSI C63.26-2015, the EUT is placed on a turn table which is 0.8 m above ground plane. A low loss of RF cable was used to connect the antenna port of EUT to measurement equipment.

#### 2.3.2 Radiated Emissions (ERP/EIRP)

According to measurement procured ANSI C63.26-2015, The EUT is placed on a turn table, for emission measurements below 1 GHz is 0.8 m above ground plane, for emission measurements above 1 GHz, the table height shall be 1.5 m. The turn table shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both Horizontal and Vertical. In order to find out the max. emission, the relative positions of this hand-held transmitter (EUT) was rotated through three orthogonal axes and measurement procedures for electric field radiated emissions above 1 GHz the EUT measurement is to be made "while keeping the antenna in the 'cone of radiation' from that area and pointed at the area both in azimuth and elevation, with polarization oriented for maximum response." is still within the 3dB illumination BW of the measurement antenna according to the requirements in Section 8 and 13.

### 2.4. Measurement Results Explanation Example

#### For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuation factor between EUT conducted port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly EUT RF output level.

Fig. 2-1 Configuration of Tested System (Fixed Channel-Conducted)

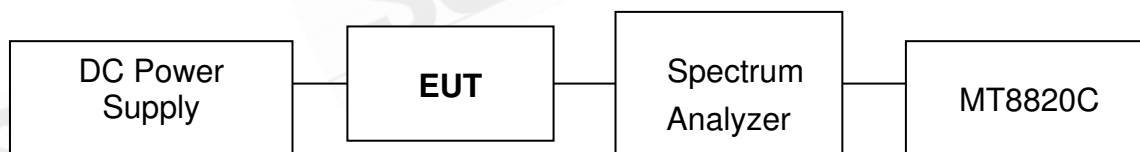
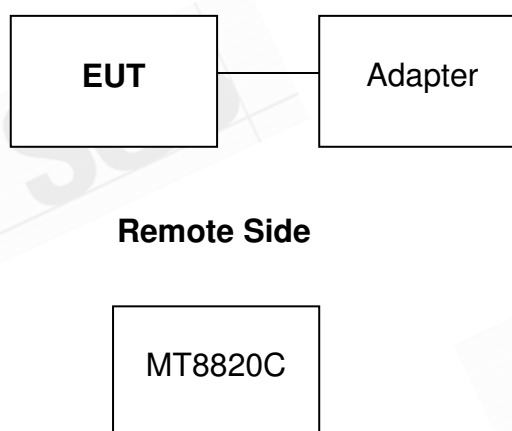


Fig. 2-2 Configuration of Tested System (Fixed Channel-Radiated)

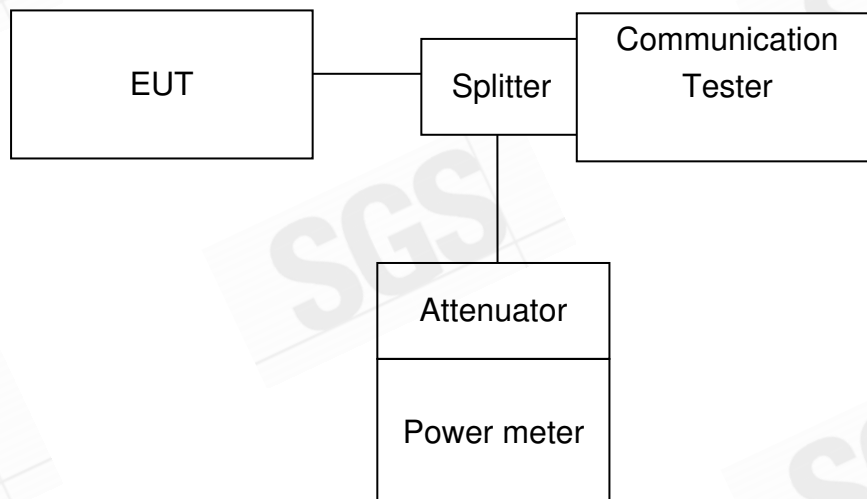

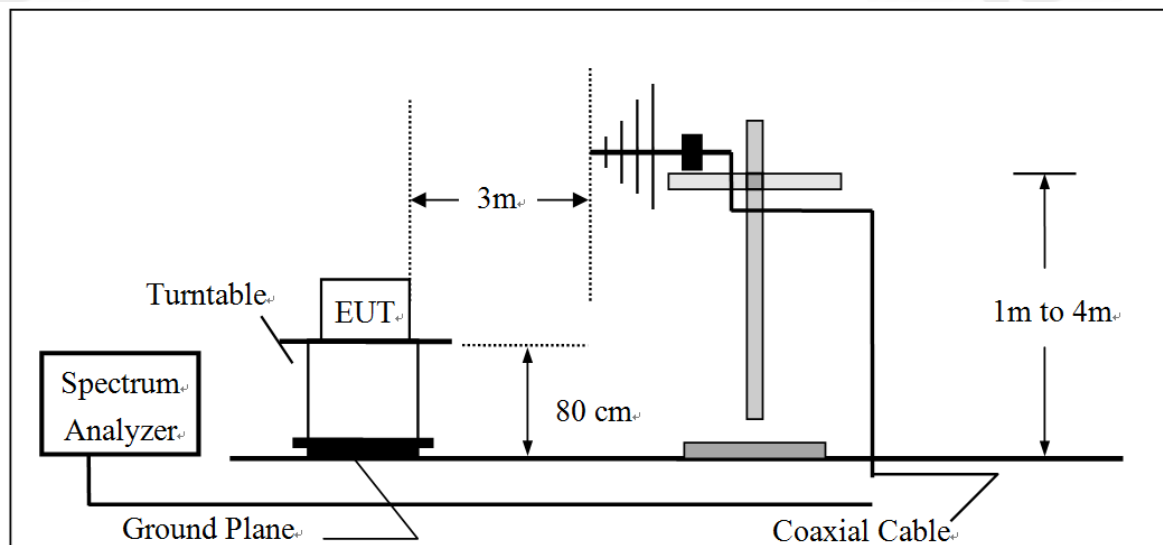

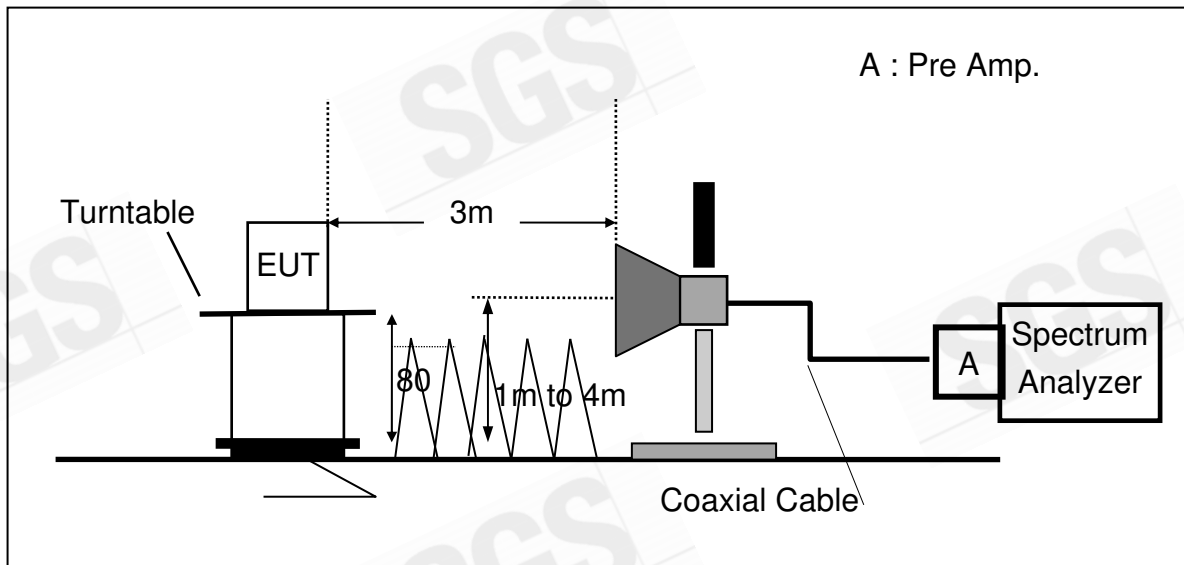

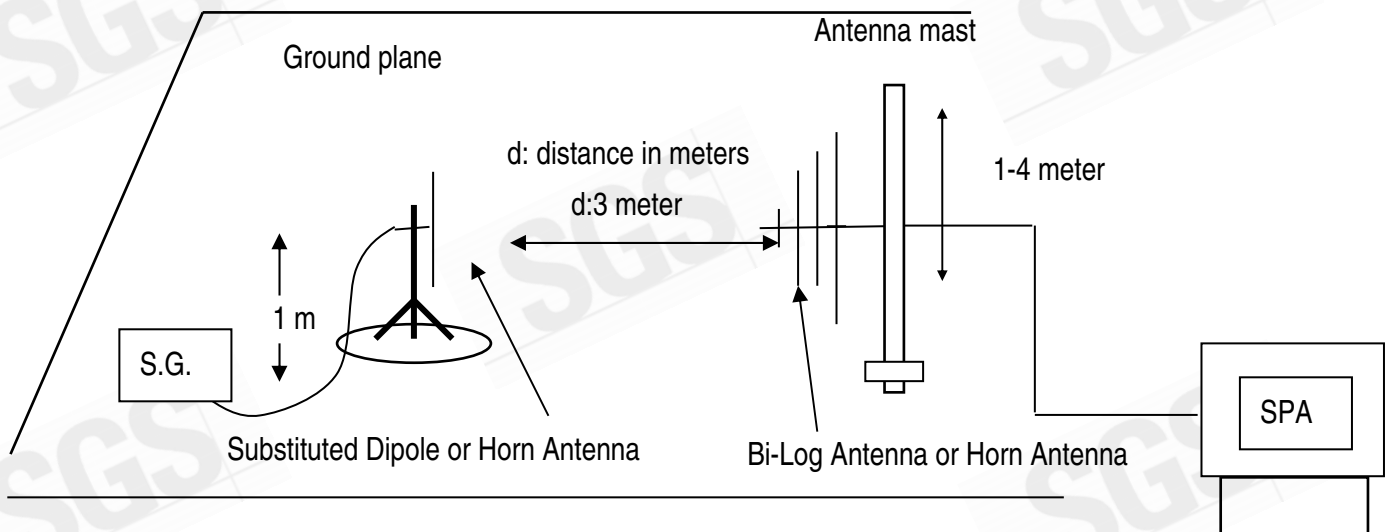

### 7.3. Measurement Procedure

1. The testing follows the Measurement Procedure of FCC KDB 971168 D01
2. The EUT was placed on a non-conductive turntable using a non-conductive support. The radiated emission at the fundamental frequency was measured at 3 m with a test antenna and EMI spectrum analyzer.

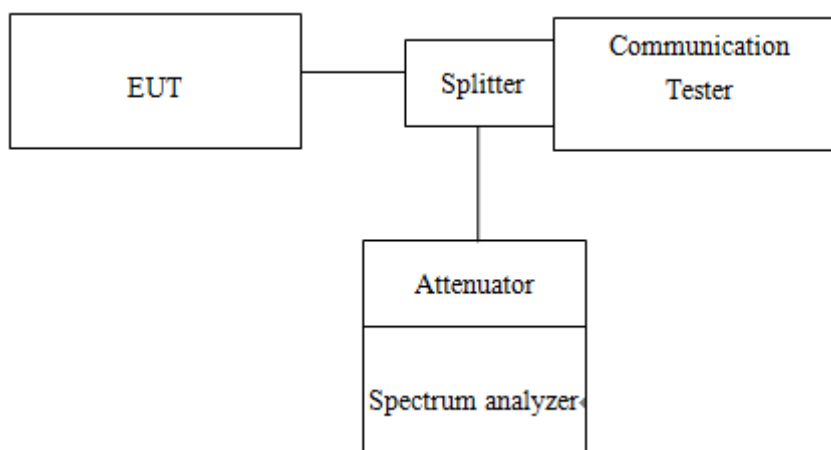

## 8. OCCUPIED BANDWIDTH MEASUREMENT

### 8.1. Standard Applicable

The occupied bandwidth is the frequency bandwidth such that, below its lower and above its upper frequency limits, the mean powers radiated are each equal to 0.5 percent of the total mean power.

### 8.3. Measurement Procedure

#### **99% & 26dB Bandwidth with detector peak**

The EUT's output RF connector was connected with a short cable to the spectrum analyzer, RBW was set to about 1% of emission BW, VBW= 3 times RBW, -26dBc display line was placed on the screen (or 26dB bandwidth), the occupied bandwidth is the delta frequency between the two points where the display line intersects the signal trace. Then set RBW to 99% bandwidth, RBW= 1%, VBW= 3 RBW, with span > 2 \* Signal BW, set % Power = 99%.

#### **99% Bandwidth with detector sample**

The EUT's output RF connector was connected with a short cable to the spectrum analyzer, RBW was set to about 1% ~ 5% of emission BW, VBW= 3 times RBW, -20dBc display line was placed on the screen (or 20dB bandwidth). Set RBW to 99% bandwidth, RBW= 1% ~ 5%, VBW= 3 RBW, with span > 2 \* Signal BW, set % Power = 99%.

## 9. OUT OF BAND EMISSION AT ANTENNA TERMINALS

### 9.1. Standard Applicable

FCC §22.917(a), Out of band emissions. The power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least  $43 + 10 \log(P)$  dB.

§90.691 Emission mask requirements for EA-based systems.

(a) Out-of-band emission requirement shall apply only to the “outer” channels included in an EA license and to spectrum adjacent to interior channels used by incumbent licensees. The emission limits are as follows:

### 10.3. Measurement Procedure:

The EUT was placed on a non-conductive; the measurement antenna was placed at a distance of 3 meters from the EUT. During the tests, the antenna height and the EUT azimuth were varied in order to identify the maximum level of emissions from the EUT. This maximization process was repeated with the EUT positioned in each of its three orthogonal orientations.

The frequency range up to tenth harmonic was investigated for each of three fundamental frequencies (low, middle and high channels). Once spurious emission was identified, the power of the emission was determined using the substitution method.

The spurious emissions attenuation was calculated as the difference between radiated power at the fundamental frequency and the spurious emissions frequency.

$$\text{ERP (dBm)} = \text{SG Level(dBm)} + \text{Antenna Gain(dBd)} + \text{Cable Loss(dB)}$$

### 11.3. Measurement Procedure

The equipment under test was connected to an external AC or DC power supply and input rated voltage. RF output was connected to a frequency counter or spectrum analyzer via feed through attenuators. The EUT was placed inside the temperature chamber. Set the spectrum analyzer RBW low enough to obtain the desired frequency resolution and measure EUT 25°C operating frequency as reference frequency. Turn EUT off and set the chamber temperature to -30°C. After the temperature stabilized for approximately 30 minutes recorded the frequency. Repeat step measure with 10°C increased per stage until the highest temperature of +50°C reached.

Set chamber temperature to 25 °C. Use a variable AC power supply / DC power source to power the EUT and set the voltage to rated voltage. Set the spectrum analyzer RBW low enough to obtain the desired frequency resolution and recorded the frequency.

Reduce the input voltage to specify extreme voltage variation (+/- 15%) and endpoint as declared by the manufacturer, record the maximum frequency change.

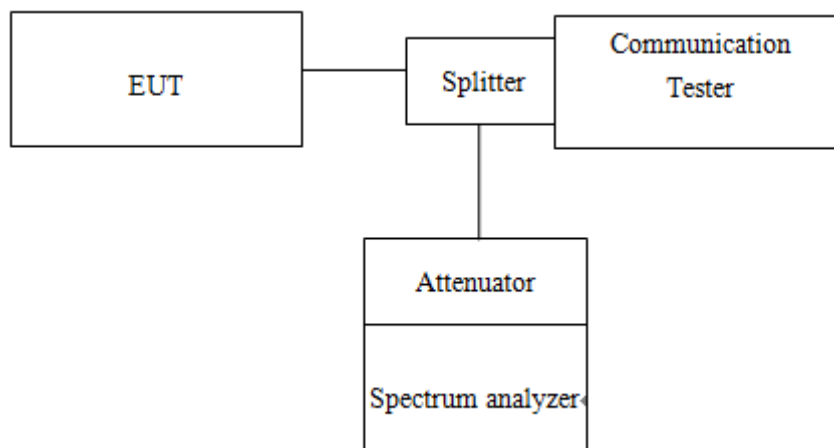
