

6.1.3 Test Method and Setup

- For transmitters other than single sideband, independent sideband and controlled carrier radiotelephone, ERP shall be measured when the transmitter is adjusted in accordance with the tune-up procedure to give the values of current and voltage on the circuit elements specified in 2.1033(c)(8). Connect the Fixed Wireless Terminal to the wireless communication tester Agilent 8960 via the air interface. The band class is set as US Cellular.
- Test the Radiated maximum output power by the Agilent 8960 received from test antenna.
- Use substitution method to verify the maximum output power. The EUT is substituted by a dipole antenna. The dipole is connected to a signal generator. And then adjust the output level of the signal generator to get the same received power recorded in step (b) on Agilent 8960, and record the power level of Signal Generator. Of course, the cable loss at the test frequency should be compensated.




Figure 1. Test Set-up




Figure 2. Test Set-up




Figure 3. Test Set-up

The band class is set as US Cellular; Fixed Wireless Terminal was controlled to transmit maximum power. Measure and record the occupied bandwidth of the Fixed Wireless Terminal by the Agilent E4440A.




Figure 4. Test Set-up




Figure 5. Test Set-up




Figure 6. Test Set-up

(a) Measurements were made to detect spurious emissions radiated directly from the cabinet, control circuits, power leads, or intermediate circuit elements under normal conditions of installation and operation. Curves or equivalent data were supplied showing the magnitude of each harmonic and other spurious emission. For this test, single sideband, independent sideband, and controlled carrier transmitters shall be modulated under the conditions specified in paragraph 2.1049(c) as appropriate. For equipment operating on frequencies below 890 MHz, an Open Field Test is normally required with the measuring instrument antenna located in the far field at all test frequencies. In the event it is either impractical or impossible to make open field measurements (e.g. a broadcast transmitter installed in a building) measurement will be accepted of the equipment as installed. Such measurements must be accompanied by a description of the site where the measurements were made showing the location of any possible source of reflections, which might distort the field strength measurements. Information submitted shall include the relative radiated power of each spurious emission with the reference to the

rated power output of the transmitter, assuming all emissions are radiated from half-wave dipole antennas.

(b) Measurements specified in paragraph (a) of this section shall be made for the following equipment:

- (1) Those in which the spurious emission are required to be 60 dB or more below the mean power of the transmitter.
- (2) All equipment operating on frequencies higher than 25 MHz
- (3) All equipment where the antenna is an integral part of, and attached directly to the transmitter.
- (4) Other types of equipment as required, when deemed necessary by the Commission.

Huawei Fixed Wireless Terminal is equipment with non-integral antenna. And it should test according to part (b) of above section.

BTS simulator is connected to a communication antenna, by which communicate with the Fixed Wireless Terminal inside the test site. The BTS simulator controls the Fixed Wireless Terminal to transmit at maximum power which defined in specification of product when in traffic mode. The Fixed Wireless Terminal operates on a typical channel.

The test procedure:

- (a) For transmitters other than single sideband, independent sideband and controlled carrier radiotelephone, ERP shall be measured when the transmitter is adjusted in accordance with the tune-up procedure to give the values of current and voltage on the circuit elements specified in 2.1033(c)(8). Connect the Fixed Wireless Terminal to the BTS simulator via the air interface. The band class is set as US Cellular.
- (b) Test the Radiated maximum output power by the Rohde and Schwarz ESIB26 Test Receiver from test antenna.
- (c) Use substitution method to verify the maximum output power. The EUT is substituted by a dipole antenna. The dipole is connected to a signal generator. And then adjust the output level of the signal generator to get the same received power recorded in step (b) on ESIB26 Test Receiver, and record the power level of Signal Generator. Of course, the cable loss at the test frequency should be compensated.



Step 2: Substitution method to verify the maximum ERP




Figure 7. Test Set-up

Effects on frequency of transmitter keying (except for broadcast transmitters) and any heating element cycling at the nominal supply voltage and at each extreme also shall be shown.

(c) When deemed necessary, the Commission may require tests of frequency stability under conditions in addition to those specifically set out in paragraphs (a), (b), (c) of this section. (For example, measurements showing the effect of proximity to large metal objects, or of various types of antennas, may be required for portable equipment.)

The EUT can only work in such extreme voltage 3.5V and 4.2V, so here the EUT is tested in the 3.5V and 4.2V.




Figure 8. Test Set up




Figure 9. TM1 Test Graph




Figure 10. TM3 Test Graph




Figure 11. Test Set-up

7.2.3 Test Method and Setup

The test site semi-anechoic chamber has met the requirement of NSA tolerance 4dB according to the standards: ANSI C63.4 (2003). The test distance was 3m.The EUT was set-up on insulator 80cm above the Ground Plane. The set-up and test methods were according to ANSI C63.4.The Radiated Disturbance measurements were made using a Rohde and Schwarz ESMI Test Receiver and control software ES-K1.

A preliminary scan and a final scan of the emissions were made from 30 MHz to 1GHz by using test script of software; the emissions were measured using a Quasi-Peak Detector. The maximal emission

value was acquired by adjusting the antenna height, polarisation and turntable azimuth in accordance with the software setup. Normally, the height range of antenna was 1m to 4m, the azimuth range of turntable was 0° to 360°, The receive antenna has two polarizations Vertical and Horizontal.

Huawei Fixed Wireless Terminal was communicated with the BTS simulator through Air interface. The Fixed Wireless Terminal operated on the typical channel and the Fixed Wireless Terminal worked in idle mode, transmitter was not work in this test.




Figure 12. Test set up
