GENERAL DESCRIPTION

2.0 General Description

2.1 Product Description

The Equipment Under Test (EUT) is a Huawei RCU R22 with Bluetooth technology operating in 2402-2480MHz. The EUT is powered by 2*AAA Battery (DC 3.0V). For more detailed features description, please refer to the user's manual.

Bluetooth Version: 4.2 (only BLE)

Antenna Type: Integral antenna

Antenna Gain: 0 dBi Max

Modulation Type: GFSK

2.2 Related Submittal(s) Grants

This is an application for certification of transceiver for the Huawei RCU R22 which has Bluetooth function (BLE).

2.3 Test Methodology

Radiated emission measurement was performed according to the procedures in ANSI C63.10 (2013) and KDB 558074 D01 v05. Radiated emission measurement was performed in semi-anechoic chamber. For radiated emission measurement, preliminary scans were performed in the semi-anechoic chamber only to determine the worst case modes. All radiated tests were performed at an antenna to EUT distance of 3 meters, unless stated otherwise in the “**Justification Section**” of this Application. All other measurements were made in accordance with the procedures in part 2 of CFR 47.

2.4 Test Facility

The Semi-anechoic chamber used to collect the radiated data is **Intertek Testing Services Shenzhen Ltd. Longhua Branch** and located at 101, 201, Building B, No. 308 Wuhe Avenue, Zhangkengjing Community, GuanHu Subdistrict, LongHua District, Shenzhen, P.R. China. This test facility and site measurement data have been fully placed on file with File Number: CN1188.

EXHIBIT 3

SYSTEM TEST CONFIGURATION

3.0 System Test Configuration

3.1 Justification

For emissions testing, the equipment under test (EUT) setup to transmit continuously to simplify the measurement methodology. Care was taken to ensure proper power supply voltages during testing. During testing, all cables were manipulated to produce worst case emissions. The EUT was powered by DC 3V from new AAA battery during the test.

For maximizing emissions, the EUT was rotated through 360°, the EUT was placed on the styrene turntable with 0.8m up to 1GHz and 1.5 m above 1GHz. The antenna height and polarization are varied during the search for maximum signal level. The antenna height is varied from 1 to 4 meters. Radiated emissions are taken at three meters unless the signal level is too low for measurement at that distance. If necessary, a pre-amplifier is used and/or the test is conducted at a closer distance.

The unit was operated standalone and placed in the centre of the turntable.

All readings are extrapolated back to the equivalent three meter reading using inverse scaling with distance. Analyzer resolution is 100 kHz or greater for frequencies below 1000 MHz. The resolution is 1 MHz or greater for frequencies above 1000 MHz. The spurious emissions more than 20 dB below the permissible value are not reported.

Radiated emission measurement were performed the lowest radio frequency signal generated in the device which is greater than 9 kHz to the tenth harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower.

3.2 EUT Exercising Software

The EUT exercise program (provided by client) used during testing was designed to exercise the various system components in a manner similar to a typical use.

3.3 Special Accessories

No special accessory attached.

3.4 Measurement Uncertainty

When determining of the test conclusion, the Measurement Uncertainty of test has been considered.

Uncertainty and Compliance – Unless the standard specifically states that measured values are to be extended by the measurement uncertainty in determining compliance, all compliance determinations are based on the actual measured value.

4.2 Minimum 6 dB RF Bandwidth, FCC Rule 15.247(a) (2):

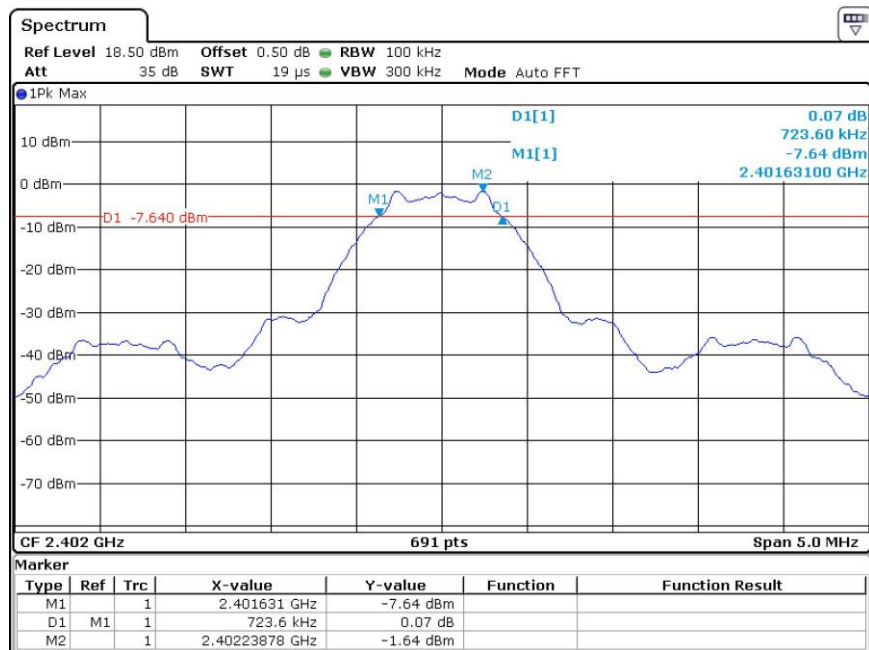
The antenna port of the EUT was connected to the input of a spectrum analyzer. Analyzer RBW was set to 100 KHz according to FCC KDB 558074 D01 v05. For each RF output channel investigated, the spectrum analyzer center frequency was set to the channel carrier. A PEAK output reading was taken, a DISPLAY line was drawn 6 dB lower than PEAK level. The 6dB bandwidth was determined from where the channel output spectrum intersected the display line.

Limit: The 6 dB Bandwidth is at least 500 kHz.

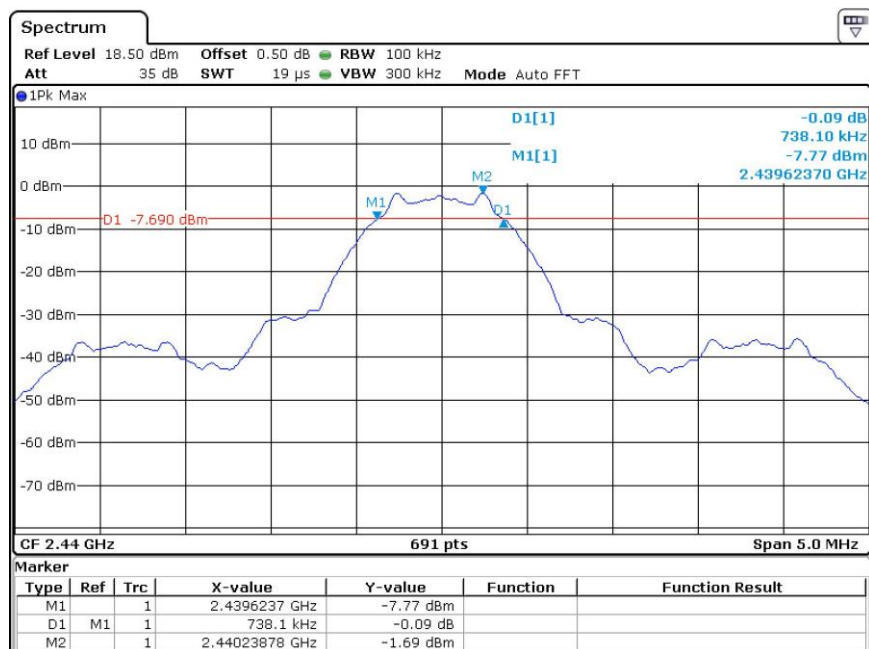

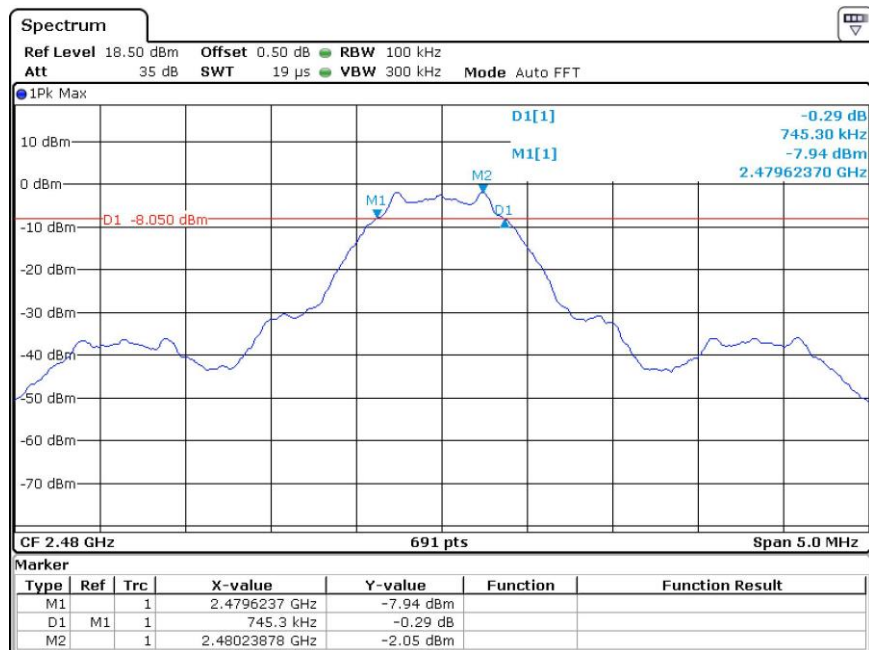
Low Channel

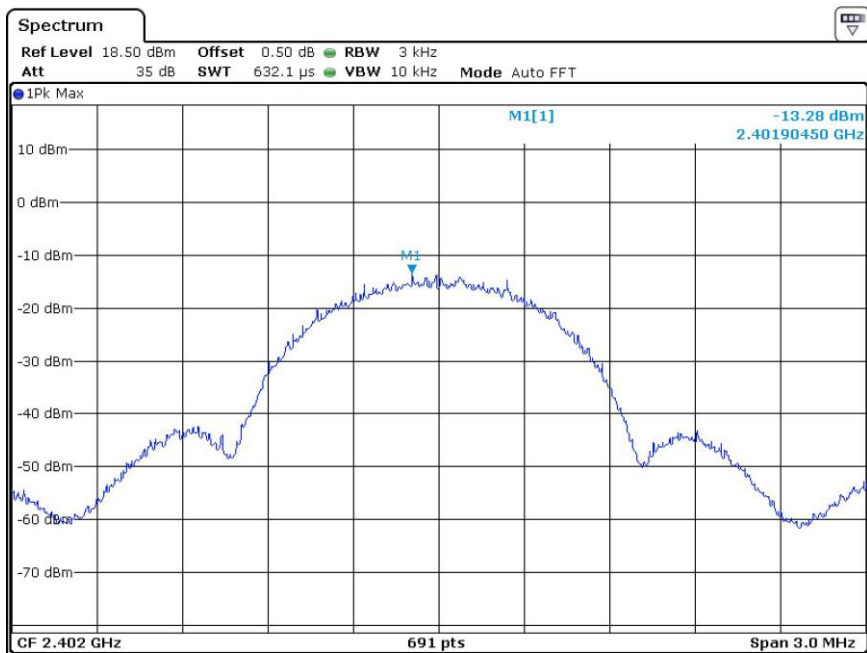

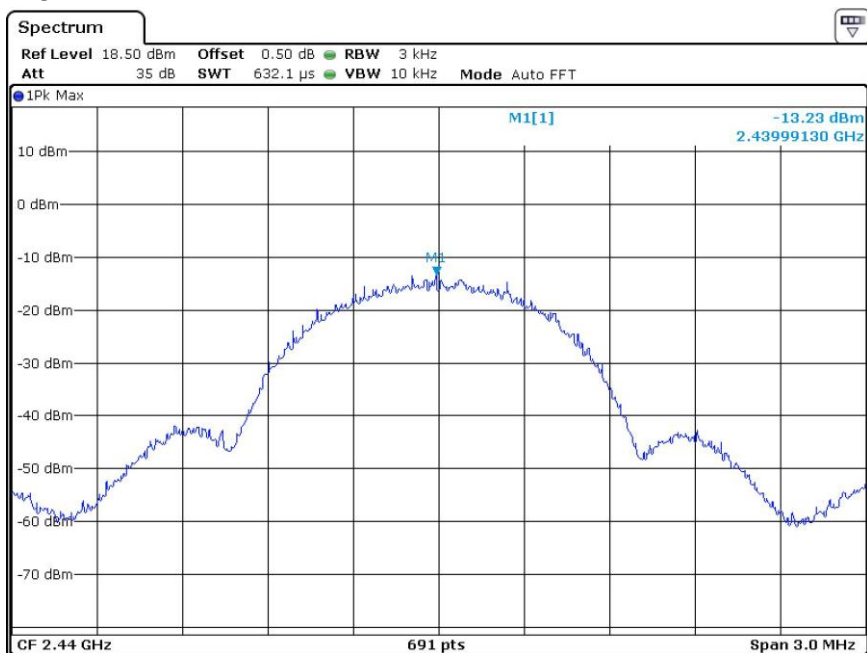

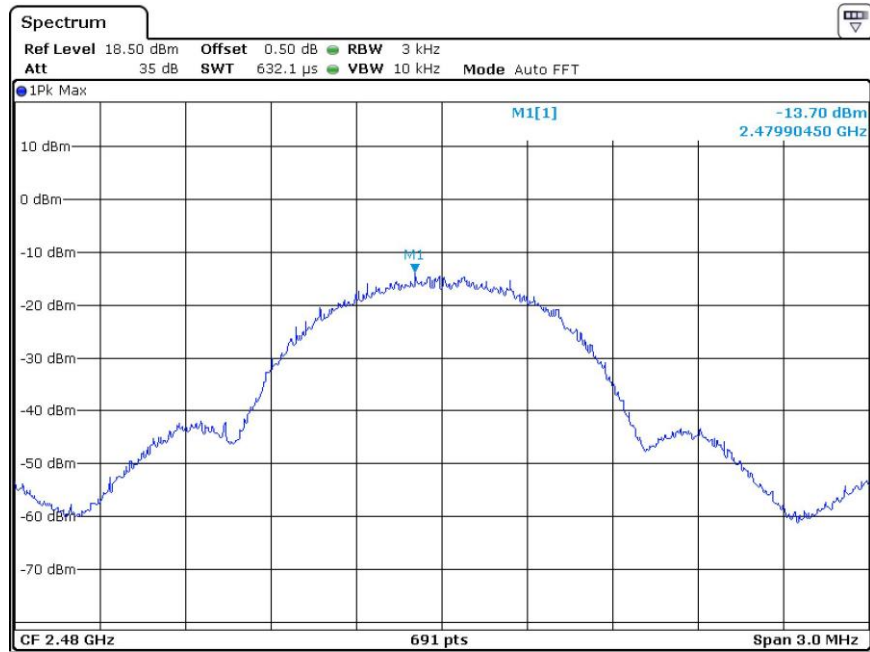
Low Channel

4.4 Out of Band Conducted Emissions, FCC Rule 15.247(d)

In any 100 kHz bandwidth outside the EUT passband, the RF power produced by the modulation products of the spreading sequence, the information sequence, and the carrier frequency shall be at least 20dB below that of the maximum in-band 100 kHz emission, or else shall meet the general limits for radiated emissions at frequencies outside the passband, whichever results in lower attenuation. 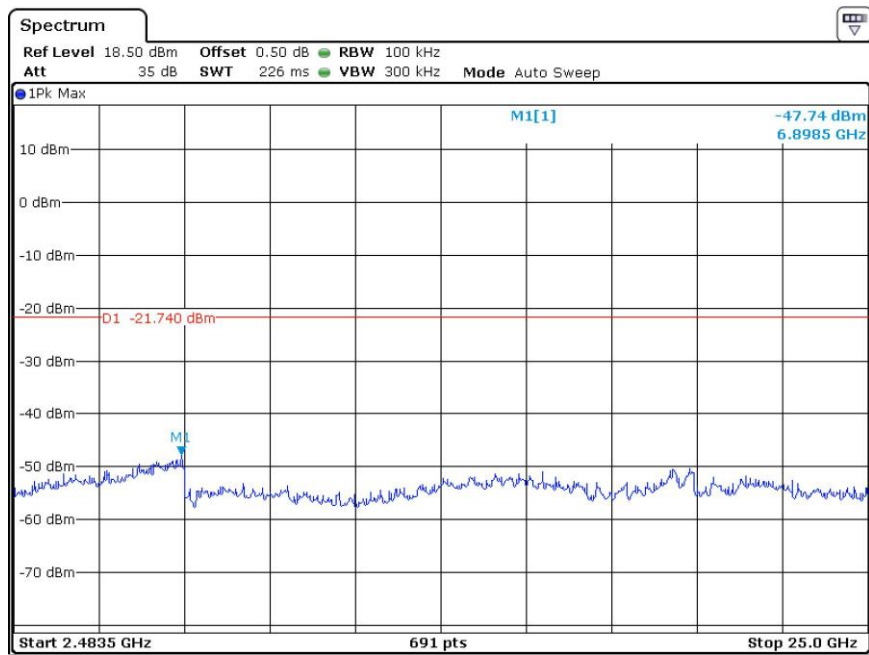
Low Channel Reference Level: -1.66 dBm



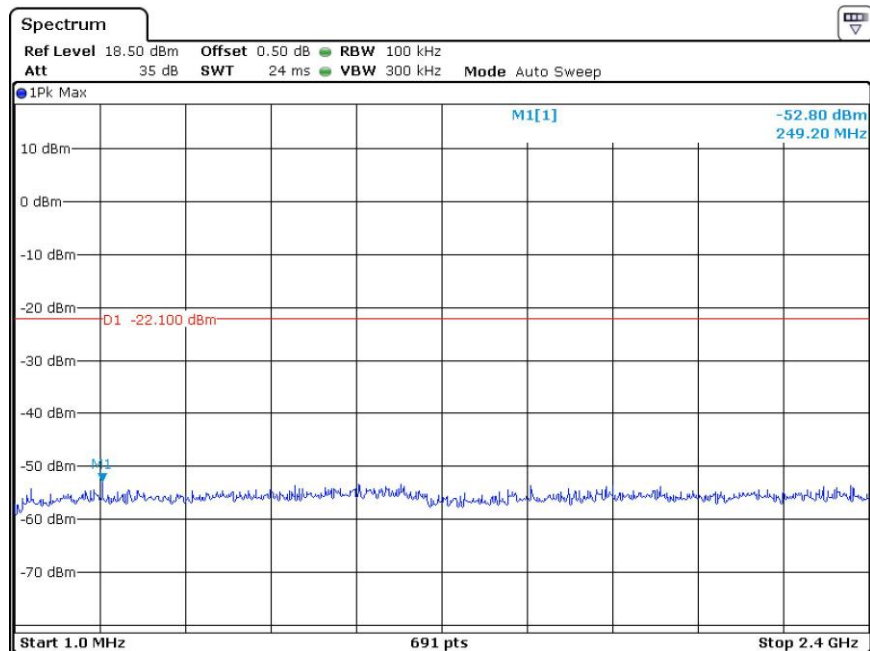
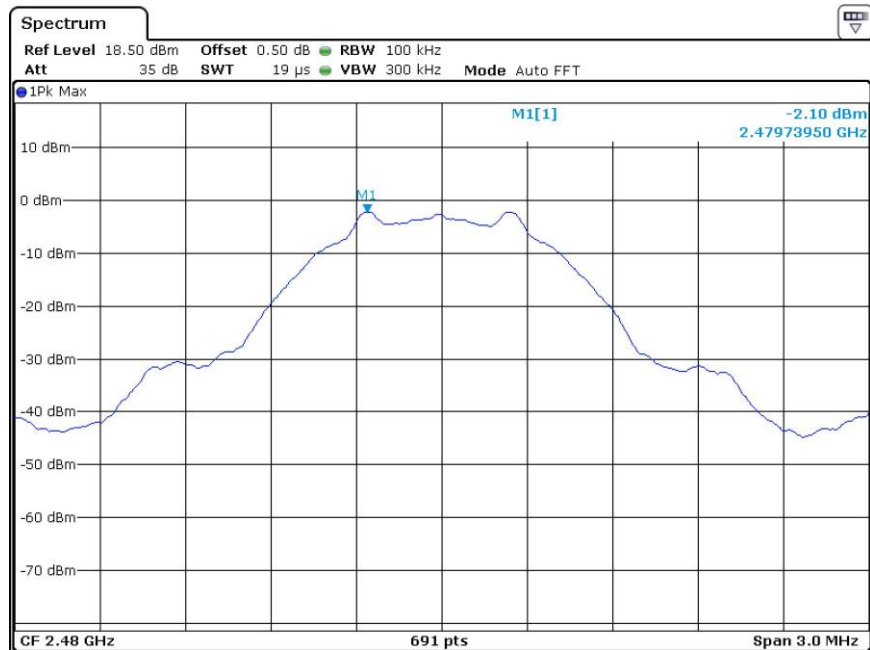


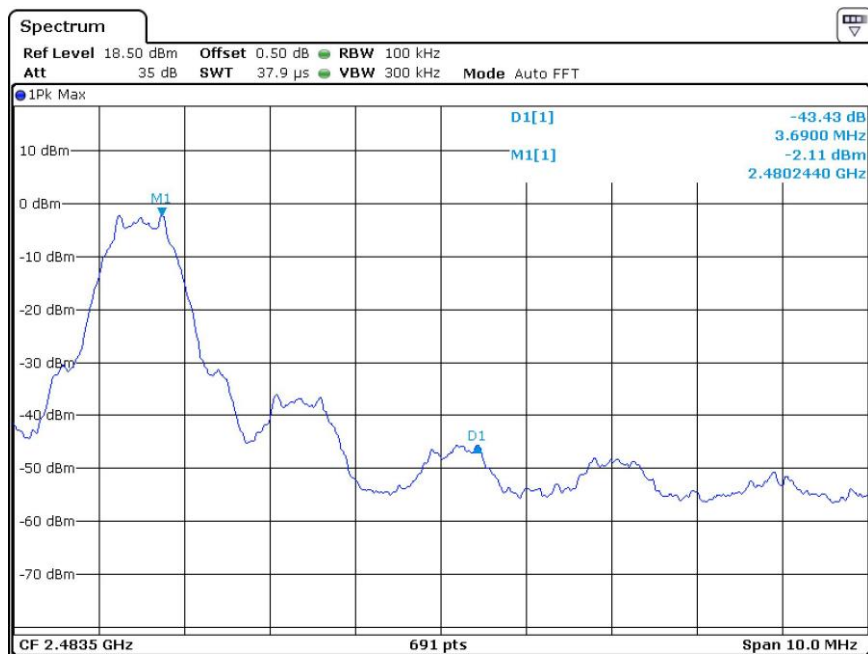
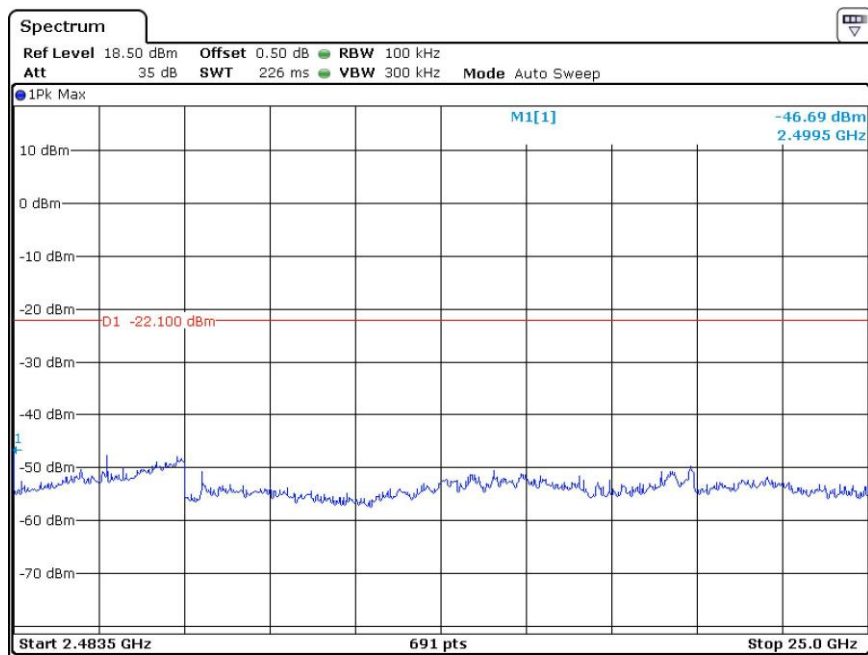
Middle Channel Reference Level: -1.74 dBm

4.7 Field Strength Calculation

The field strength is calculated by adding the reading on the Spectrum Analyzer to the factors associated with preamplifiers (if any), antennas, cables, pulse desensitization and average factors (when specified limit is in average and measurements are made with peak detectors). A sample calculation is included below.

$$FS = RA + AF + CF - AG + PD$$

Where

- FS = Field Strength in dB μ V/m
- RA = Receiver Amplitude (including preamplifier) in dB μ V
- CF = Cable Attenuation Factor in dB
- AF = Antenna Factor in dB
- AG = Amplifier Gain in dB
- PD = Pulse Desensitization in dB

In the radiated emission table which follows, the reading shown on the data table may reflect the preamplifier gain. An example of the calculations, where the reading does not reflect the preamplifier gain, follows:

$$FS = RA + AF + CF - AG + PD$$

Example

Assume a receiver reading of 62.0 dB μ V is obtained. The antenna factor of 7.4 dB and cable factor of 1.6 dB is added. The amplifier gain of 29 dB is subtracted. The pulse desensitization factor of the spectrum analyzer was 0 dB. The net field strength for comparison to the appropriate emission limit is 42 dB μ V/m. This value in dB μ V/m was converted to its corresponding level in μ V/m.

$$\begin{aligned} RA &= 62.0 \text{ dB}\mu\text{V} \\ AF &= 7.4 \text{ dB} \\ CF &= 1.6 \text{ dB} \\ AG &= 29.0 \text{ dB} \\ PD &= 0 \text{ dB} \\ FS &= 62 + 7.4 + 1.6 - 29 + 0 = 42 \text{ dB}\mu\text{V/m} \end{aligned}$$

$$\text{Level in } \mu\text{V/m} = \text{Common Antilogarithm } [(42 \text{ dB}\mu\text{V/m})/20] = 125.9 \mu\text{V/m}$$

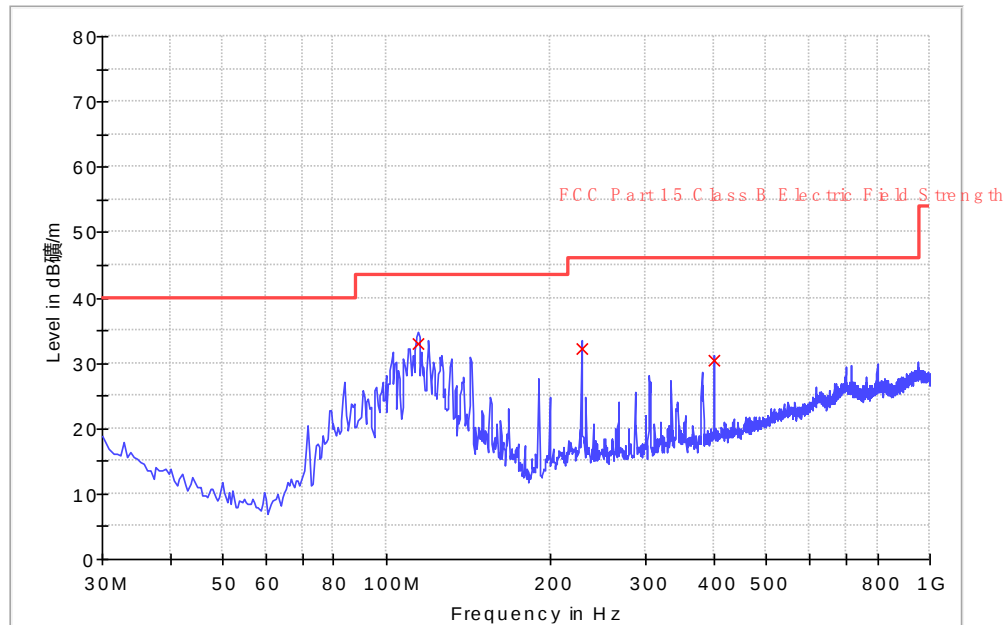

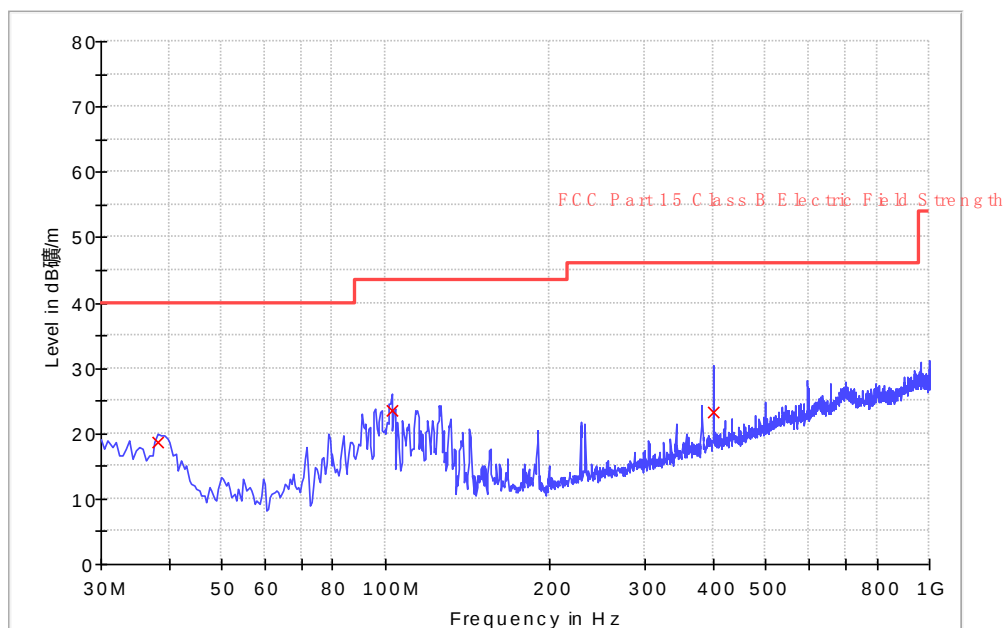
