

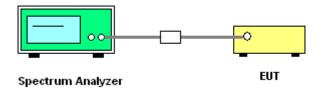



6 dB Bandwidth Plot on Channel 00







99% Bandwidth Plot on Channel 00






99% Occupied Bandwidth Plot on Channel 19



- 5. Detector = peak, Sweep time = auto couple, Trace mode = max hold, Allow trace to fully stabilize. Use the peak marker function to determine the maximum power level.
- 6. Measure and record the results in the test report.
- 7. The Measured power density (dBm)/ 100kHz is a reference level and used as 20dBc down limit line for Conducted Band Edges and Conducted Spurious Emission.




PSD 100kHz Plot on Channel 00

PSD 100kHz Plot on Channel 19





PSD 100kHz Plot on Channel 39







PSD 3kHz Plot on Channel 19





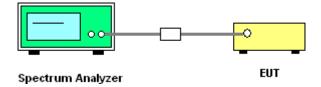

Unwanted Emissions measured in any 100 kHz bandwidth outside of the authorized frequency band shall be attenuated by at least 20 dB relative to the maximum in-band peak PSD level in 100 kHz when maximum peak conducted output power procedure is used. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, the attenuation required under this paragraph shall be 30 dB instead of 20 dB.
- 5. Measure and record the results in the test report.
- 6. The RF fundamental frequency should be excluded against the limit line in the operating frequency band.




Low Band Edge Plot on Channel 00




Conducted Spurious Emission Plot on Bluetooth LE 1Mbps GFSK Channel 00

Conducted Spurious Emission Plot on Bluetooth LE 1Mbps GFSK Channel 00







Conducted Spurious Emission Plot on Bluetooth LE 1Mbps GFSK Channel 19







3.5.3 Test Procedures



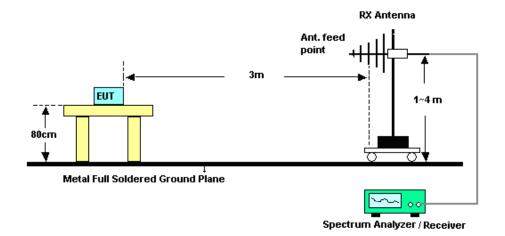


For radiated emissions below 30MHz



3.7 Antenna Requirements

3.7.1 Standard Applicable

If directional gain of transmitting antennas is greater than 6dBi, the power shall be reduced by the same level in dB comparing to gain minus 6dBi. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the rule.




