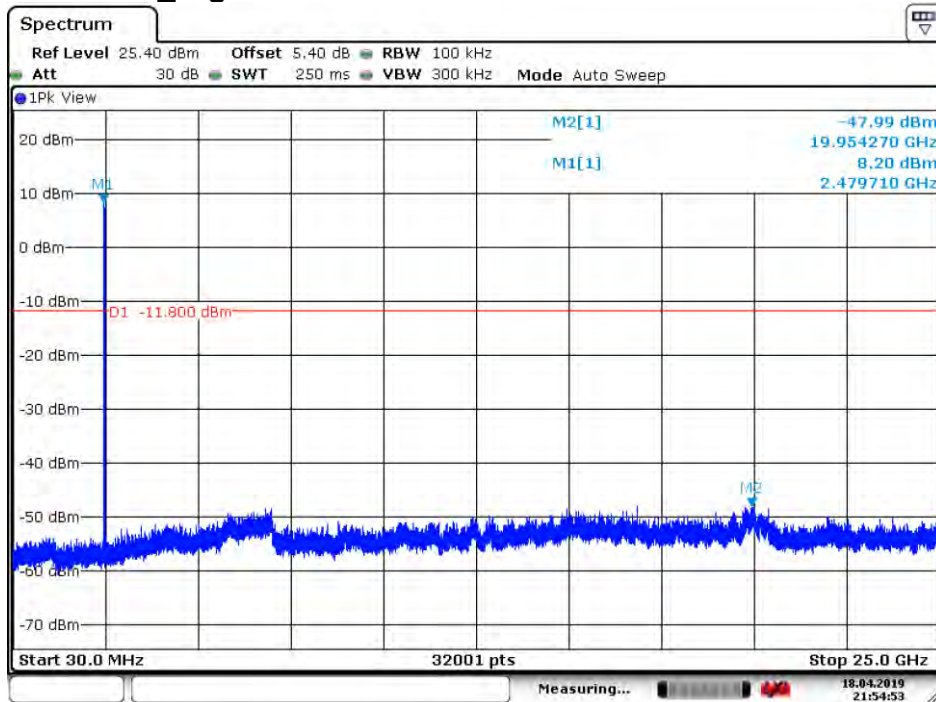


**4.10.1.2 GFSK\_Middle Channel**

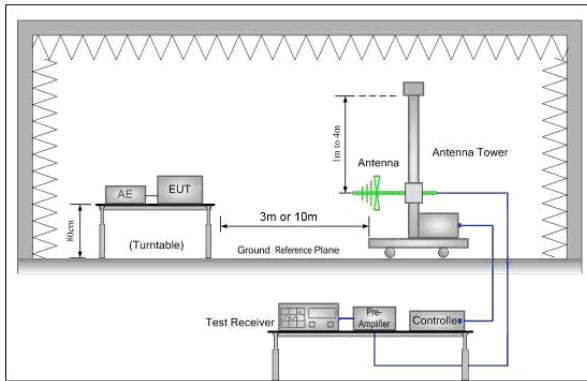


Figure 1. 30MHz to 1GHz

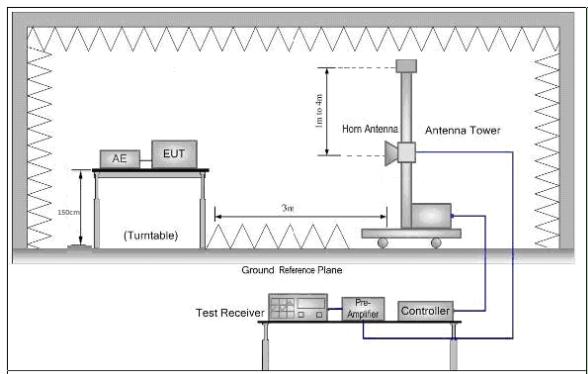


Figure 2. Above 1 GHz
