### Summary

This report is an application for Certification of a radar detector operating pursuant to 47 CFR 15.109(h). This report is designed to demonstrate the compliance with the requirements outlined in Part 15 (using the methods outlined in Part 2) of 47 CFR.

We found that the product met the above requirements without modification. The test sample was received in good condition.

### Test Methodology

Radiated emission testing was performed according to the procedures in ANSI C63.4 (2014). The testing was performed at a distance of 1 meter. The device's performance was investigated in the range 11.7-12.2GHz. The radar detector was powered by a variable power supply.

### Conditions Of Testing

The Test Report is issued solely by the Company, is intended for the exclusive use of Client and shall not be published, used for advertising purposes, copied or replicated for distribution to any other person or entity or otherwise publicly disclosed without the prior written consent of the Company. By submitting a request for services to the Company, Client consents to the disclosure to accreditation bodies of those records of Client relevant to the accreditation body's assessment of the Company's competence and compliance with relevant accreditation criteria. The Company shall not be liable for any loss or damage whatsoever resulting from the failure of the Company to provide its services within any time period for completion estimated by the Company. If Client anticipates using the Test Report in any legal proceeding, arbitration, dispute resolution forum or other proceeding, it shall so notify the Company prior to submitting the Test Report in such proceeding. The Company has no obligation to provide a fact or expert witness at such proceeding unless the Company agrees in advance to do so for a separate and additional fee.
- 2. The Test Report will set forth the findings of the Company solely with respect to the test samples identified therein.
