Summary

This report supports an application for Certification of a radar detector operating pursuant to: CFR Title 47 FCC Part 15.109(h)

We found that the ESCORT MAX 3 met the above requirements without modification. Test sample was received in good condition.

Test Methodology

Radiated emissions testing was performed in accordance with the procedures in ANSI C63.4-2014. Testing was performed at a distance of 1 meter. Emissions from the device were measured in the 11.7-12.2GHz frequency range. The device was powered by a 12Vdc supply during testing.

The Company shall not be liable for any loss or damage whatsoever resulting from the failure of the Company to provide its services within any time period for completion estimated by the Company. If Client anticipates using the Test Report in any legal proceeding, arbitration, dispute resolution forum or other proceeding, it shall so notify the Company prior to submitting the Test Report in such proceeding. The Company has no obligation to provide a fact or expert witness at such proceeding unless the Company agrees in a dvance to do so for a separate and additional fee.
