## Summary

This report is an application for Certification of a Radar Detector operating pursuant to 47 CFR 15.109, as amended by ET Docket No. 01-278; FCC 02-211, published in the Federal Register Vol. 67, No. 145 on Monday July 29, 2002.

## Test Methodology

Radiated emission testing was performed according to the procedures in ANSI C63.4 (2001). The testing was performed at a distance of 1 meter. Performance was investigated in the range 11.7-12.2GHz. The Passport SR7 was powered by a HP E3612A DC Power Supply. Since the device is a hand-held unit, the emissions were maximized around the three orthogonal axes and the maximum reading was recorded. The integrated antenna cannot be maximized separately.

#### Statement of Conformity

47 CFR 15.109(h) states that "*Radar detectors shall comply with the emissions limits...of* [section 15.109(a)] *over the frequency range of 11.7 – 12.2GHz.*" The applicable limit being  $500\mu$ V/m measured at a distance of 3m. The Escort Passport SR7 has been tested and found to comply with this requirement.

- Where the LABORATORY indicates that additional testing is advisable to obtain more valid or useful data, and where such 3.5 testing has not been authorized. CLIENT agrees to view such test reports as inconclusive and preliminary.
- The LABORATORY will supply technical service and prepare a report based solely on the sample submitted to the LABORATORY by the CLIENT. The CLIENT understands that application of the data to other devices is highly speculative 36 and should be applied with extreme caution.
- The LABORATORY agrees to exercise ordinary care in receiving, preserving and shipping (F.O.B. Littleton, MA) any sample to be tested, but assumes no responsibility for damages, either direct or consequential, which arise from loss, damage or 3.7 destruction of the samples due to the act of examination, modification or testing, or technical services or circumstances beyond LABORATORY's control.
- The LABORATORY will hold samples for thirty (30) days after tests are completed, or until the CLIENT's outstanding debts 3.8 to the LABORATORY are satisfied, whichever is later.

It is agreed that tests, reports, or analysis results may be disclosed to third party auditors of the laboratory at the laboratory facility in the course of accreditation maintenance audits. No reference to reports or technical services of the LABORATORY shall be made in any advertising or promotional literature without the express written permission of the LABORATORY.
- 3.11 The CLIENT acknowledges that all employees of LABORATORY operate under employment contracts with the LABORATORY and CLIENT agrees not to solicit employment of such employees or to solicit information related to other clients from said employees.
- 3.12 In recognition of the relative risks and benefits of the project to both CLIENT and LABORATORY, the risks have been allocated such that the CLIENT agrees, to the fullest extent permitted by law, to limit the liability of the LABORATORY to the CLIENT for any and all claims, losses, costs, damages of any nature whatsoever or claims expenses from any cause or causes, including attorneys' fees and costs and expert witness fees and costs, so that the total aggregate liability of the LABORATORY to the CLIENT shall not exceed \$100,000, or the LABORATORY'S total fee for services rendered on this project, whichever is greater. It is intended that this limitation apply to any and all liability or cause of action however alleged or arising, unless otherwise prohibited by law.
