

**Test Method:**

The sample was placed 0.8m above the ground plane on the OATS \*. Measurements in both horizontal and vertical polarities were performed. During the test, each emission was maximized by: having the EUT continuously working, investigate all operating modes, rotated about all 3 axis (X, Y & Z) to obtain worst position, manipulating interconnecting cables, rotating turntable, varying antenna height from 1m to 4m in both horizontal and vertical polarizations. The emissions worst-case are shown in Test Results of the following pages.







### Duty Cycle Correction During 100msec


Each function key sends a different series of characters, but each packet period (29.125msec) never exceeds a series of 4 long (900 $\mu$ sec) and 40 short (300 $\mu$ sec) pulses. Assuming any combination of short and long pulses may be obtained due to encoding the worse case transmit duty cycle would be considered  $4 \times 900\mu\text{sec} + 40 \times 300\mu\text{sec}$  per 29.125msec = 53.5% duty cycle. Figure A through C show the characteristics of the pulse train for one of these functions.

Remarks:

Duty Cycle Correction =  $20\log(0.535) = -5.4\text{dB}$

Figure B [Long Pulse]





Figure C [Short Pulse]


**Rear View of the product**
