### 3. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.4 and FCC CFR 47 2.1046, 2.1047, 2.1049, 2.1051, 2.1053, 2.1055, 2.1057, and 15.247.

#### 3.1EUT CONFIGURATION

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

#### 3.2EUT EXERCISE

The EUT (802.11b/g Wireless LAN CardBus PC Card) was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

According to its specifications, the EUT must comply with the requirements of the Section 15.247 under the FCC Rules Part 15 Subpart C.

## 3.3GENERAL TEST PROCEDURES

### **Conducted Emissions**

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 13.1.4.1 of ANSI C63.4: 2001, Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-peak and average detector modes.

### **Radiated Emissions**

The EUT is placed on a turn table, which is 0.8 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max emission, the relative positions of this hand-held transmitter (EUT) were rotated through three orthogonal axes according to the requirements in Section 13.1.4.1 of ANSI C63.4: 2001.

## **5.2EQUIPMENT**

Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test Receivers.

Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."


### 6dB Bandwidth (IEEE 802.11b / CH Low)




### 6dB Bandwidth (IEEE 802.11b / CH Mid)






### Peak power (IEEE 802.11b / Ch Low)



### Peak power (IEEE 802.11b / CH Mid)




# Peak power (IEEE 802.11b / CH High)






### Peak power (IEEE 802.11g / CH Low)




### Peak power (IEEE 802.11g / CH Mid)

# 7.3BAND EDGES MEASUREMENT


Detector mode: Average Polarity: Vertical




### Band Edges (IEEE 802.11g / CH High)

### PPSD (IEEE 802.11b / CH Low)




### PPSD (IEEE 802.11b / CH Mid)





### 30MHz ~ 2.9GHz









## **IEEE 802.11b / CH Mid**









## **IEEE 802.11g / CH Mid**

## 7.7POWERLINE CONDUCTED EMISSIONS

## **LIMIT**

For an intentional radiator which is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed 250 microvolts (The limit decreases linearly with the logarithm of the frequency in the range 0.15 MHz to 0.50 MHz). The limits at specific frequency range is listed as follows:

## **Test Configuration**

1. The conducted emission tests were performed in the test site, using the setup in accordance with the ANSI C63.4: 2001

- 2. The EUT was plug-in the host PC via USB port. The host PC system was placed on the center of the back edge on the test table. The peripherals like modem, monitor printer, K/B, and mouse were placed on the side of the host PC system. The rear of the EUT and peripherals were placed flushed with the rear of the tabletop.
- 3. The keyboard was placed directly in the front of the monitor, flushed with the front tabletop. The mouse was placed next to the Keyboard, flushed with the back of keyboard.
- 4. The spacing between the peripherals was 10 centimeters.
- 5. External I/O cables were draped along the edge of the test table and bundle when necessary.
- 6. The host PC system was connected with 110Vac/60Hz power source.

The EUT is set to transmit in a continuous mode.

## **TEST PROCEDURE**

- 1. The EUT was placed on a table, which is 0.8m above ground plane.
- 2. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
- 3. Repeat above procedures until all frequency measured were complete.

## **TEST RESULTS**

The initial step in collecting conducted data is a spectrum analyzer peak scan of the measurement range. Significant peaks are then marked as shown on the following data page, and these signals are then quasi-peaked.




