GENERAL INFORMATION

Product Description for Equipment Under Test (EUT)

The Xingtel Xiamen Group Co., Ltd.'s product, model: A1600BT BUN (FCC ID: QMHA1600BT) or the "EUT" in this report was a handset of DECT 6.0 Amplified Cordless Freedom Deluxe Phone, Which was measured approximately: 187 mm (L) x 60 mm (W) x 39 mm (H), input voltage: DC 3.6V battery and DC 7.5V adapter for charging

Input: AC 100-240 V, 50/60 Hz, 0.2A Max

Output: DC 7.5V, 0.3A

Note: The serial products, model A1600BT BUN, A1600BT and A1600E-BT are electrically identical, we select A1600BT BUN to test, the difference among them is only model number due to different combination, and please refers to the attached declaration letter.

Objective

This document is a test report based on the Electromagnetic Interference (EMI) tests performed on the EUT. The EMI measurements were performed according to the measurement procedure described in ANSI C63.17 - 2006, and ANSI C64.3 2009.

The tests were performed in order to determine compliance with FCC Part 15, Subpart D, and section 15.203, 15.315, 15.317, 15.319 and 15.323 rules.

Test Methodology

All measurements contained in this report were conducted with ANSI C63.17 - 2006, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz. All radiated and conducted emissions measurement was performed at Bay Area Compliance Laboratories Corp. (Shenzhen). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Test Facility

The Test site used by Bay Area Compliance Laboratories Corp. (Shenzhen) to collect test data is located on the 6/F, the 3rd Phase of WanLi Industrial Building, ShiHua Road, FuTian Free Trade Zone Shenzhen, Guangdong, China.

Test site at Bay Area Compliance Laboratories Corp. (Shenzhen) has been fully described in reports submitted to the Federal Communication Commission (FCC). The details of these reports have been found to be in compliance with the requirements of Section 2.948 of the FCC Rules on December 06, 2010. The facility also complies with the radiated and AC line conducted test site criteria set forth in ANSI C63.4-2009.

The Federal Communications Commission has the reports on file and is listed under FCC Registration No.: 382179. The test site has been approved by the FCC for public use and is listed in the FCC Public Access Link (PAL) database.

Additionally, Bay Area Compliance Laboratories Corp. (Shenzhen) is an ISO/IEC 17025 accredited laboratory, and is accredited by National Voluntary Laboratory Accredited Program (Lab Code 200707-0).

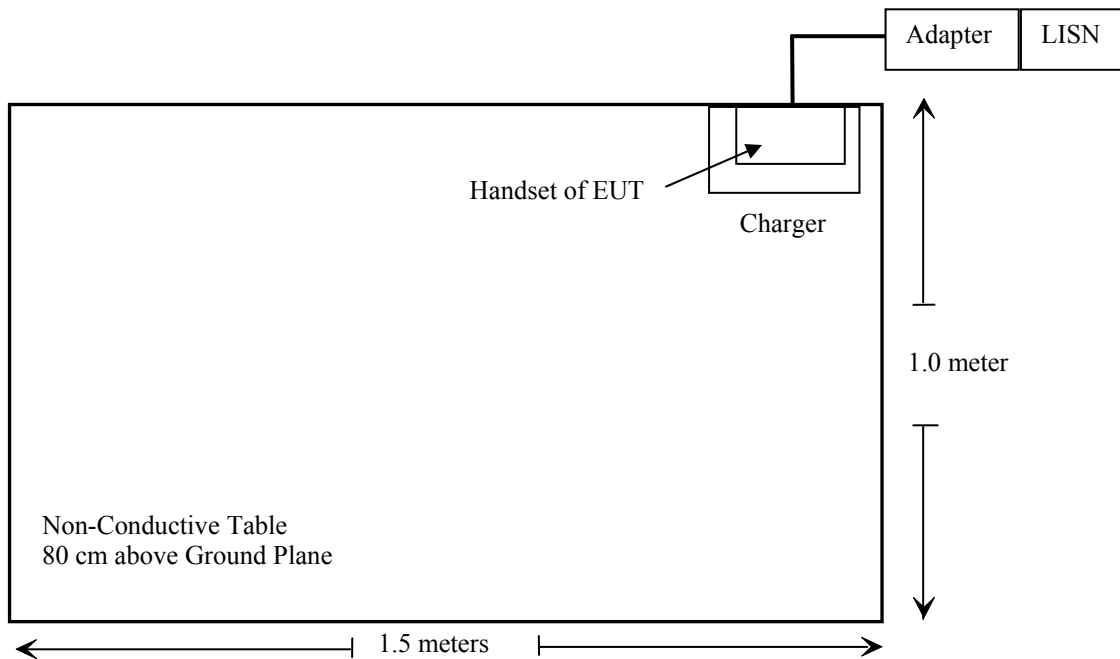

FCC §15.319 (i) & §2.1093 - RF EXPOSURE

Applicable Standard

According to §15.319 (i) Unlicensed PCS devices are subject to the radiofrequency radiation exposure requirements specified in § 1.1307(b), 2.1091 and 2.1093 of this chapter, as appropriate. All equipment shall be considered to operate in a “general population/uncontrolled” environment. Applications for equipment authorization of devices operating under this section must contain a statement confirming compliance with these requirements for both fundamental emissions and unwanted emissions. Technical information showing the basis for this statement must be submitted to the Commission upon request.

According to KDB 447498 D01 Mobile Portable RF Exposure v041) c): Unless excluded by specific FCC test procedures, portable devices with output power is $\leq 60/f(\text{GHz})$ mW shall include SAR data for equipment approval.

RF Exposure Evaluation

Max peak output power at antenna port:

1928.448 MHz: 16.21 dBm = 41.78 mW

The source-based average power at antenna port:

41.78 mW*duty cycle= 41.78*0.0414=1.73 mW (2.38 dBm)

The source-based average power:

2.38 dBm +antenna gain (0.5 dBi) = 2.88 dBm = 1.94 mW

Limit: $60/f(\text{GHz}) = 60/1.928.448 = 31.11$ mW

The source-based average power is less than $60/f(\text{GHz})$

So the SAR evaluation can be exempted.

FCC §15.317 & §15.203 - ANTENNA REQUIREMENT

Applicable Standard

According to FCC §15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.

Antenna Connector Construction

This product has an integrated antenna; please refer to the internal photos. The maximum gain is 0.5 dBi, fulfill the requirement of this section.

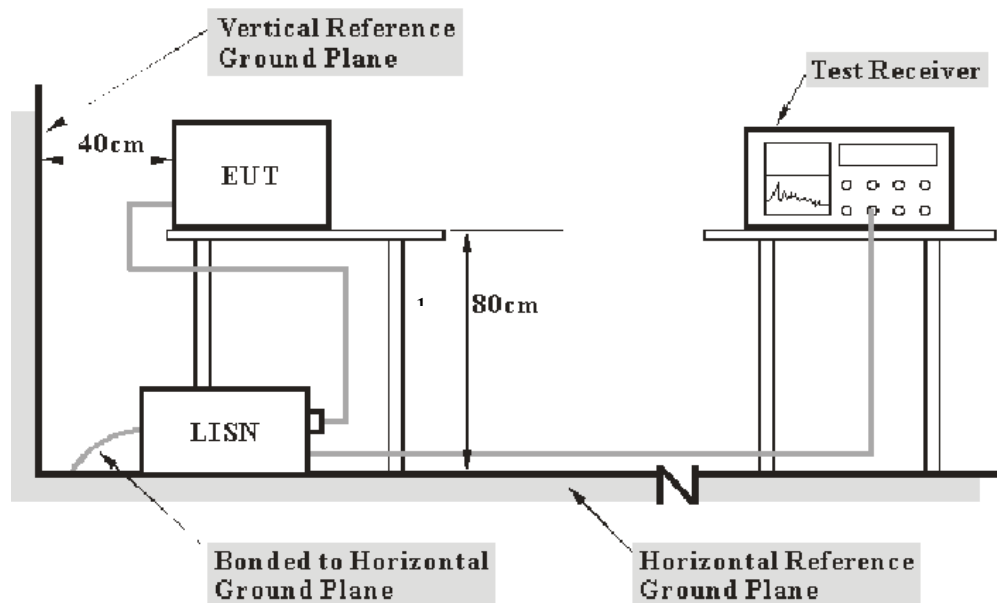

Measurement Uncertainty

All measurements involve certain levels of uncertainties, especially in field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, and LISN.

Based on CISPR 16-4-4, The Treatment of Uncertainty in EMC Measurements, the best estimate of the uncertainty of any conducted emissions measurement at Bay Area Compliance Laboratories Corp. (Shenzhen) is 2.4 dB ($k=2$, 95% level of confidence).

EUT Setup



- Note:**
1. Support units were connected to second LISN.
 2. Both of LISNs (AMN) 80 cm from EUT and at the least 80 cm from other units and other metal planes support units.

The setup of EUT is according with per ANSI C63.4-2009 measurement procedure. The specification used was with the FCC 15.315 and FCC 15.207 limits.

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

The adapter was connected to a 120 VAC/60 Hz power source.

EMI Test Receiver Setup

The EMI test receiver was set to investigate the spectrum from 150 kHz to 30 MHz.

During the conducted emission test, the EMI test receiver was set with the following configurations:

Maximizing procedure was performed on the six (6) highest emissions of the EUT.

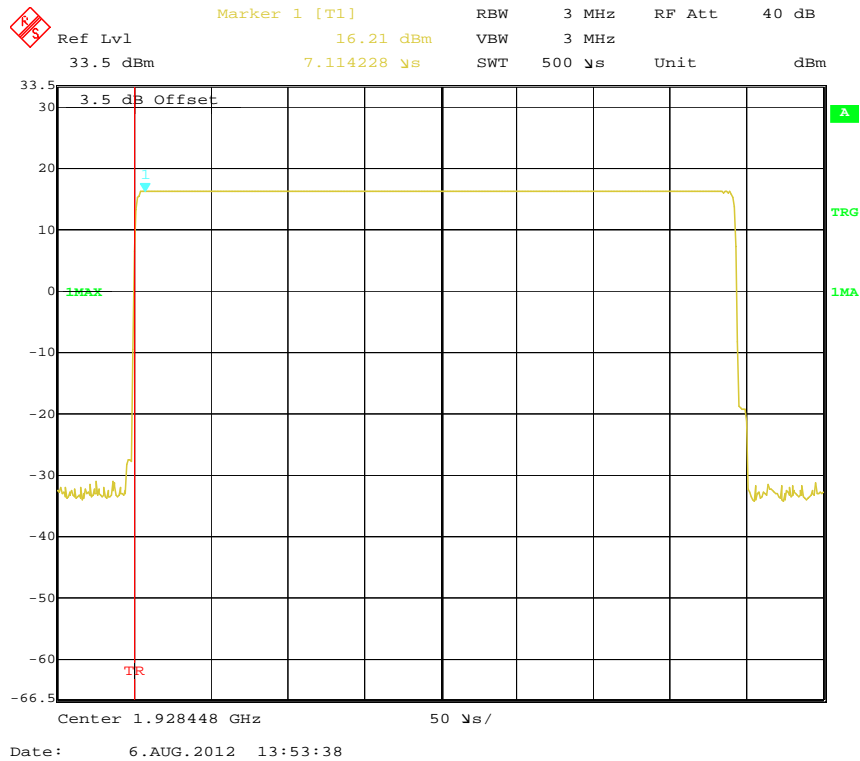

FCC §15.323 (d) - EMISSION INSIDE AND OUTSIDE THE SUB-BAND

Applicable Standard

Emissions inside the sub-band must comply with the following emission mask:

1. In the bands between 1B and 2B measured from the center of the emission bandwidth the total power emitted by the device shall be at least 30 dB below the transmit power permitted for that device;
2. in the bands between 2B and 3B measured from the center of the emission bandwidth the total power emitted by an intentional radiator shall be at least 50 dB below the transmit power permitted for that radiator;
3. in the bands between 3B and the sub-band edge the total power emitted by an intentional radiator in the measurement bandwidth shall be at least 60 dB below the transmit power permitted for that radiator.

Where B = emission bandwidth

Emission Outside the sub-band shall be attenuated below a reference power of 112 mw (20.5 dBm) as follows:

1. 30 dB between the sub-band and 1.25 MHz above or below the sub-band;
2. 50 dB between 1.25 and 2.5 MHz above or below the sub-band;
3. 60 dB at 2.5 MHz or greater above or below the sub-band.

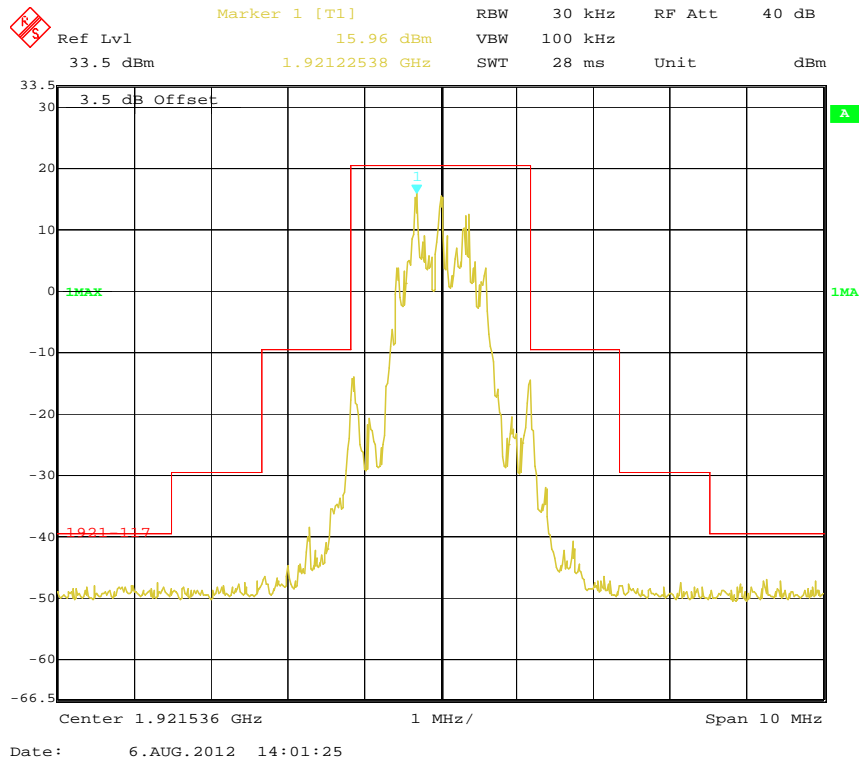

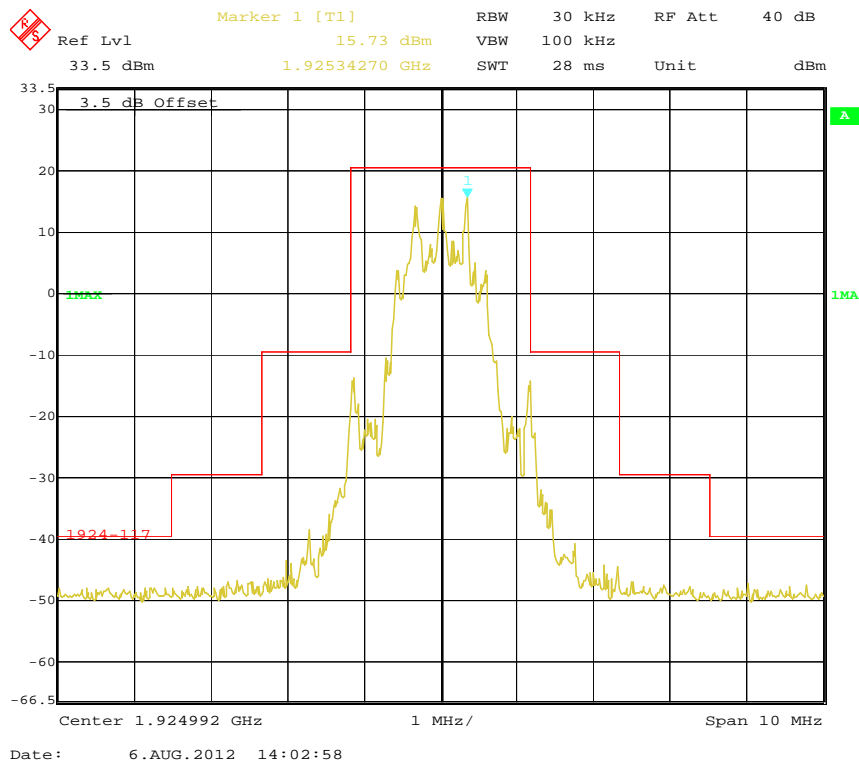

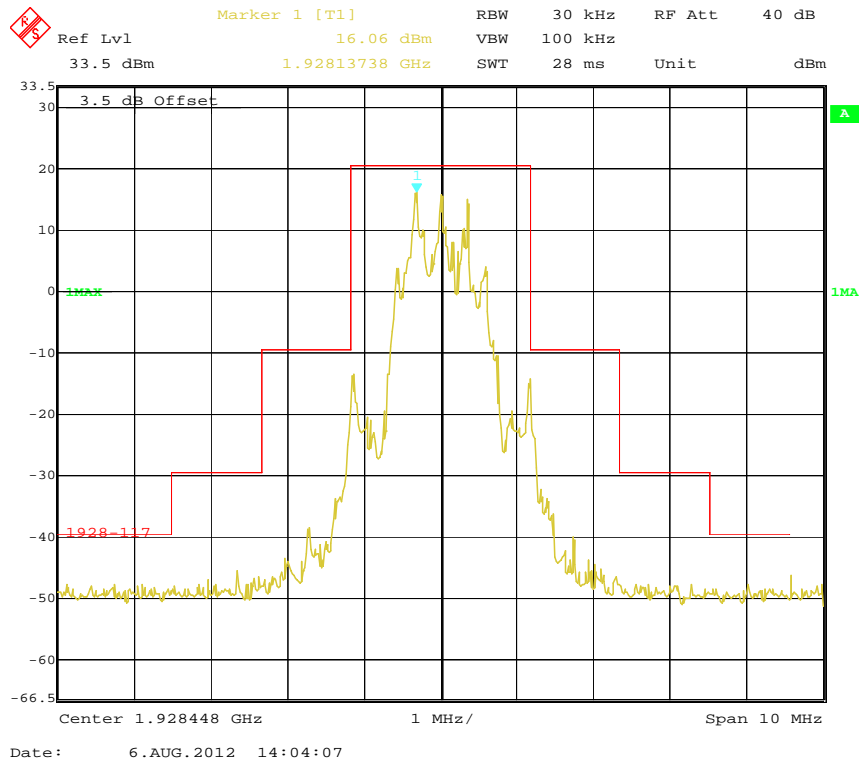
Low Channel (Unwanted Emission inside the Sub-band)



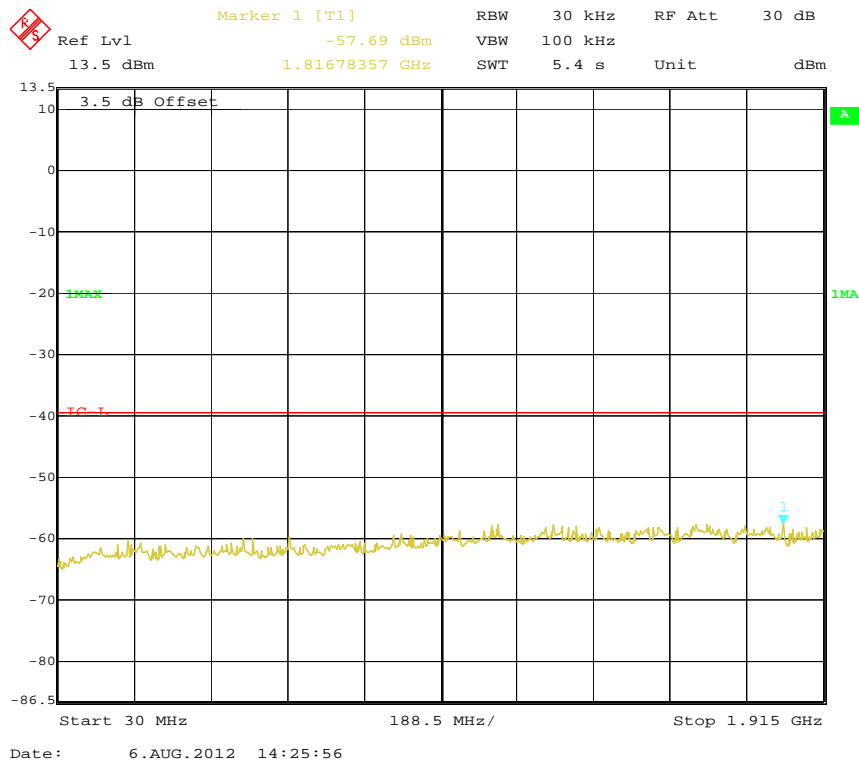
Middle Channel (Unwanted Emission inside the Sub-band)

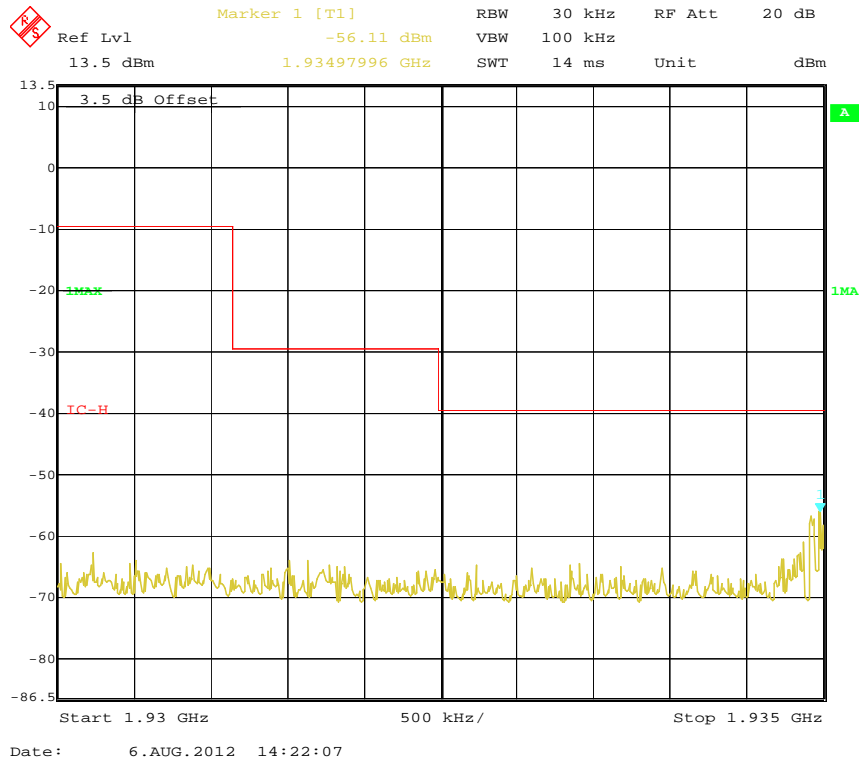
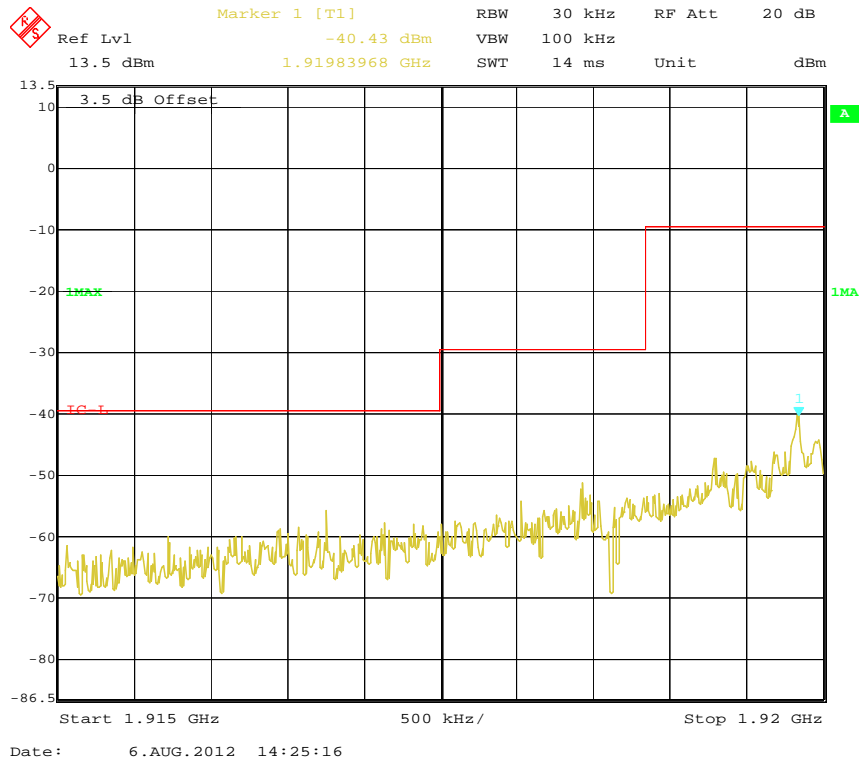


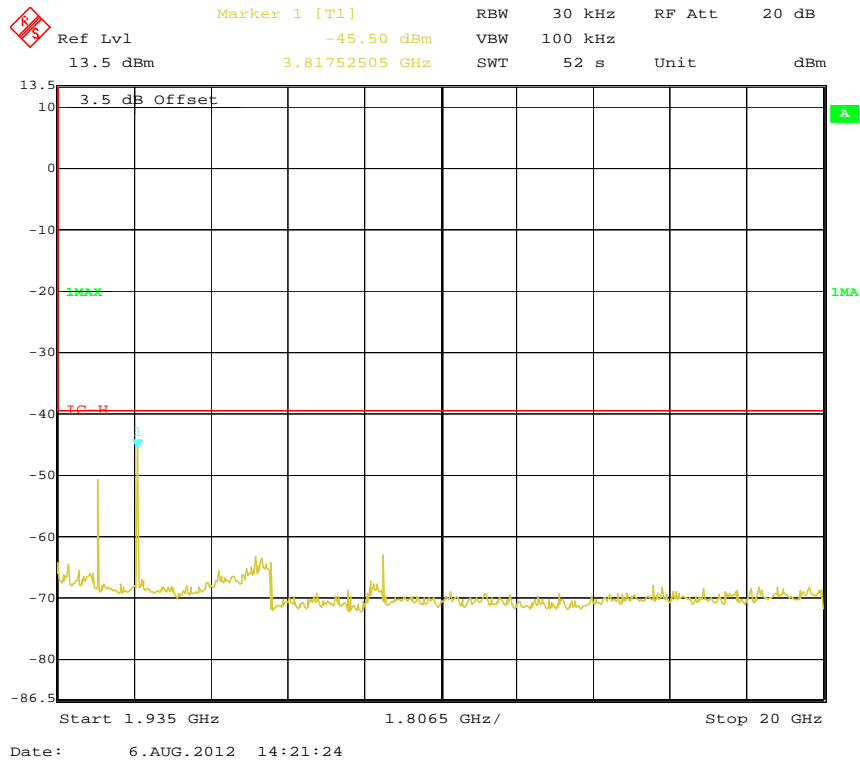

Measurement Uncertainty

All measurements involve certain levels of uncertainties, especially in field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, antenna factor calibration, antenna directivity, antenna factor variation with height, antenna phase center variation, antenna factor frequency interpolation, measurement distance variation, site imperfections, mismatch (average), and system repeatability.

Based on CISPR 16-4-4, The Treatment of Uncertainty in EMC Measurements, the best estimate of the uncertainty of a radiation emissions measurement at Bay Area Compliance Laboratories Corp. (Shenzhen) is 4.0 dB ($k=2$, 95% level of confidence).

EUT Setup



The radiated emission tests were performed in the 3 meters chamber test site, using the setup accordance with the ANSI C63.17 - 2006. The specification used was the FCC 15.209 and FCC 15.319(g) limits.

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

EMI Test Receiver & Spectrum Analyzer Setup

The system was investigated from 30 MHz to 20 GHz.

During the radiated emission test, the EMI test receiver & Spectrum Analyzer Setup were set with the following configurations:

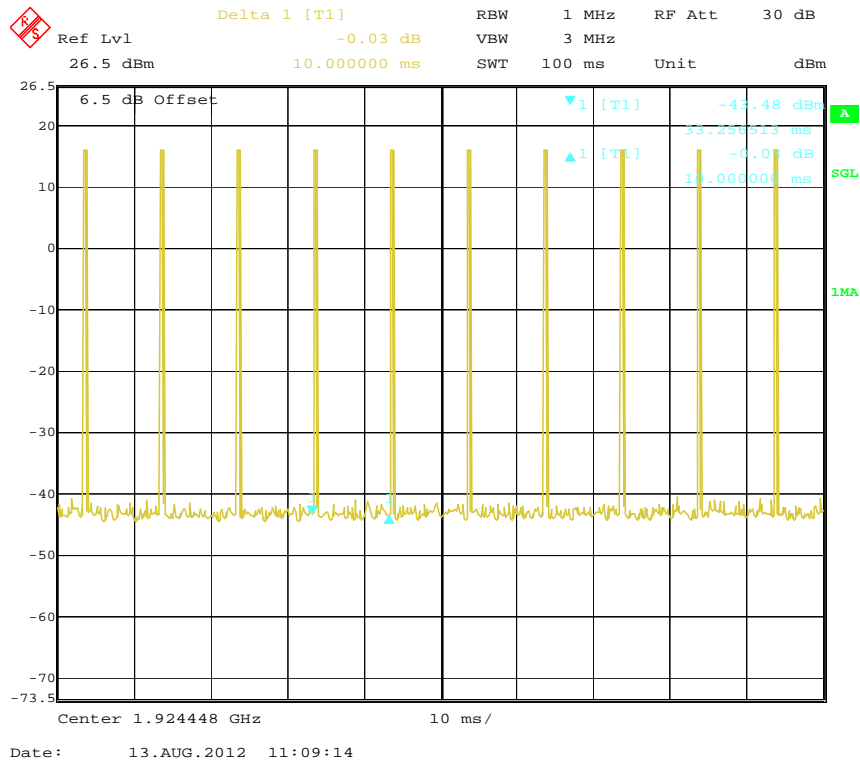

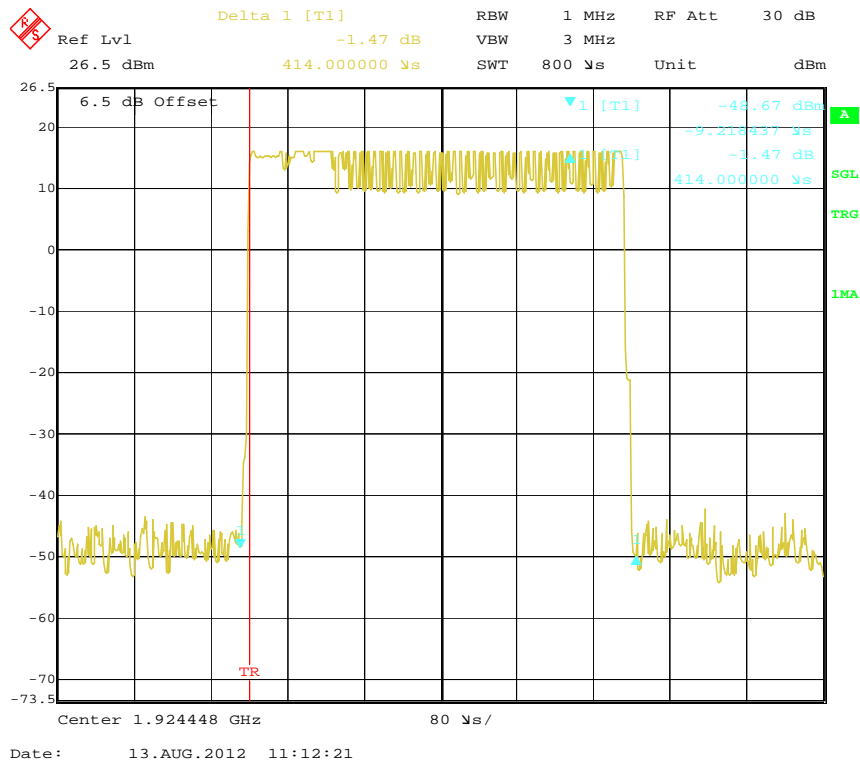
