This is perfectly acceptable. A copy of the dismissal letter and an explanation that the FCC will allow TCBs to do this sort of HAC with user adjustable T-coil frequency response is fine. Point out in the explanation that FCC reversed themselves in policy less than 30 days from the dismissal, consequently we allowed this to continue as original application.

I guess this is also setting a policy: If FCC reverses themselves on policy within 30 days of issuing a dismissal, then we will go through with the original filing with no finding of fault on our part, and no (or nominal) extra charges to customer.
