3.2. Test method and setup

The measurement was made according to the MO&O FCC 06-96.

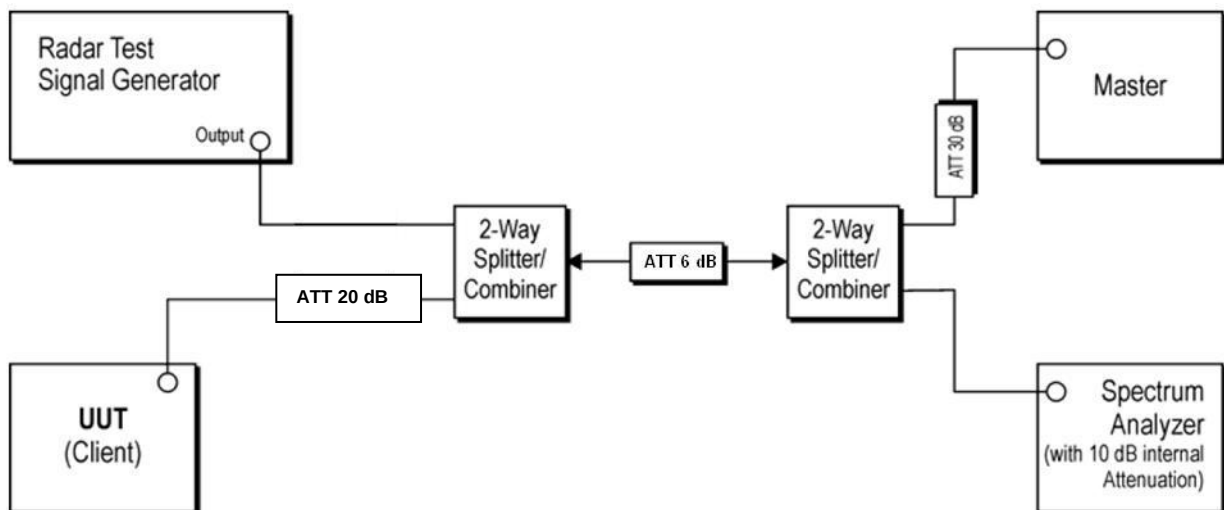
The master used was Cisco AIR-AP1262N-A-K9, FCCID: LDK102073. The 5 GHz B Rx-Tx antenna port was connected to the test setup, others were left unconnected.

The output power of the radar signal test generator was 15 dBm.

The radar signal generator was set to simulate radar type 4: pulse width 16 us, PRI 300 us and number of pulses 15.

There was traffic between the EUT and master by means of the commonly available 'iperf' tool. A PC was connected to the master via Ethernet to serve as a remote endpoint. Unlimited rate up-link (from EUT to the remote endpoint) TCP protocol data transfer was generated with the 'iperf' tool.

The test was repeated four times to record the four graphs, shown in section

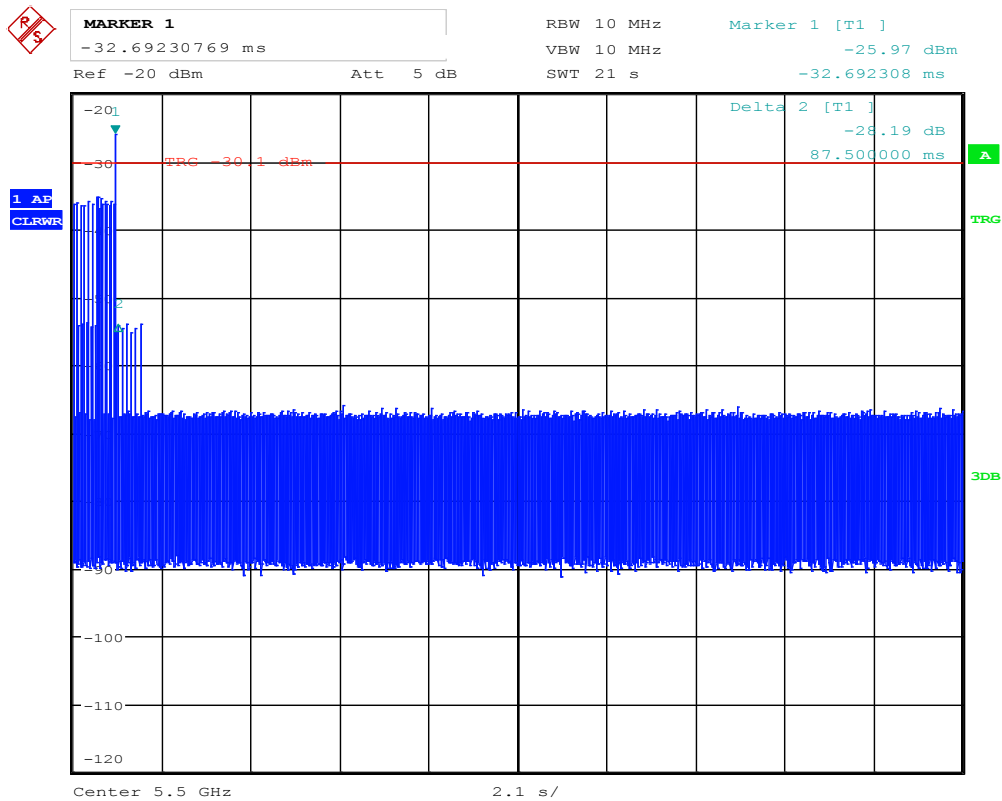

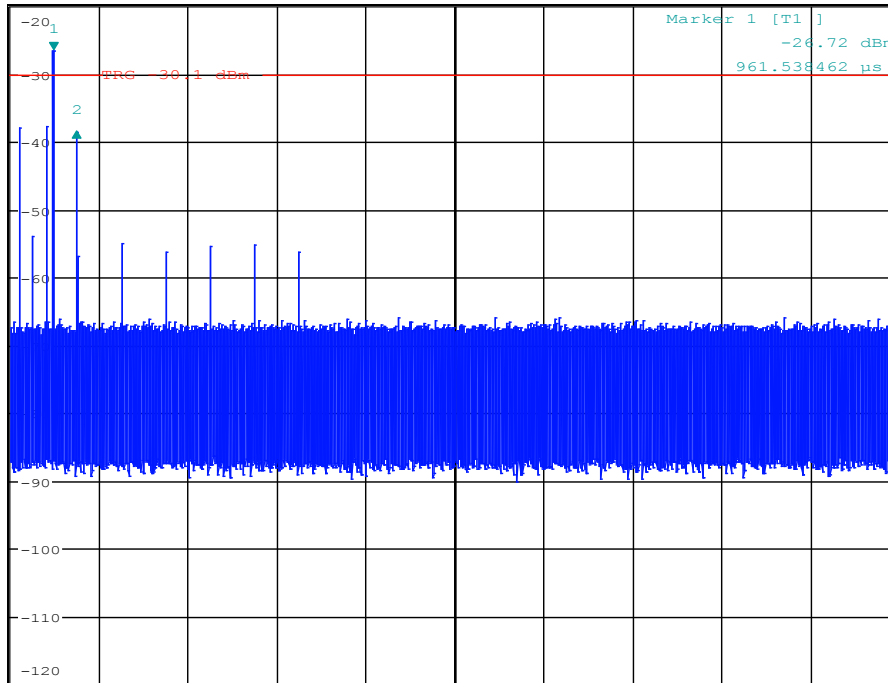

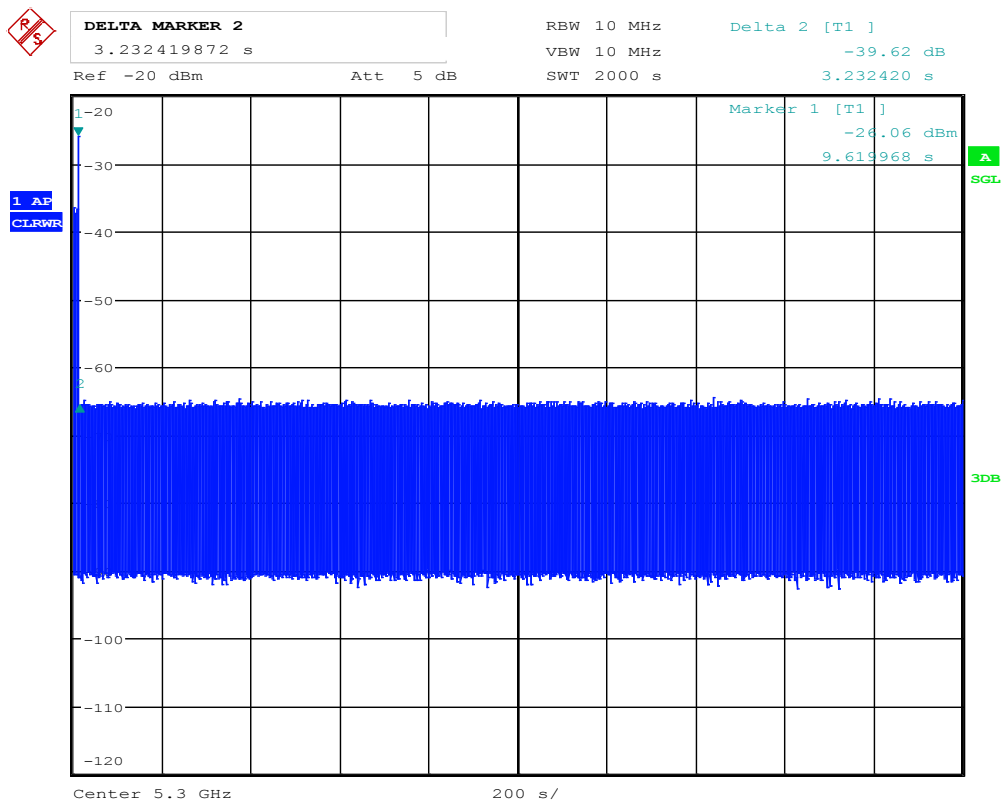
