

During the test, each emission was maximized by: having the EUT continuously working, investigated all operating modes, rotated about all 3 axis (X, Y & Z) and considered typical configuration to obtain worst position, manipulating interconnecting cables, rotating turntable, varying antenna height from 1m to 4m in both horizontal and vertical polarizations. 



Duty Cycle Correction During 100msec


Each function key sends a different series of characters, but each packet period (16msec) never exceeds a series of 3 long (1.5msec) and 10 short (500µsec) pulses. Assuming any combination of short and long pulses may be obtained due to encoding the worst case transmit duty cycle would be considered 3x1.5msec per 16msec=59.3% duty cycle. Figure A through C show the characteristics of the pulse train for one of these functions.

Remarks:

Duty Cycle Correction = 20Log(0.593) =-4.5dB

Figure B [Long Pulse]





Figure C [Short Pulse]


