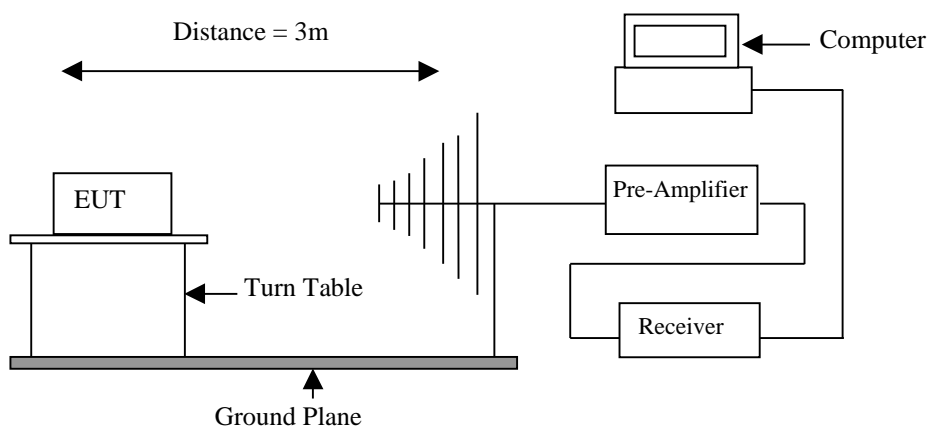

The sample was placed 0.8m above the ground plane on the OATS *. Measurements in both horizontal and vertical polarities were performed. During the test, each emission was maximized by: having the EUT continuously working, investigated all operating modes, rotated about all 3 axis (X, Y & Z) and considered typical configuration to obtain worst position, manipulating interconnecting cables, rotating turntable, varying antenna height from 1m to 4m in both horizontal and vertical polarizations. The emissions worst-case are shown in Test Results of the following pages.

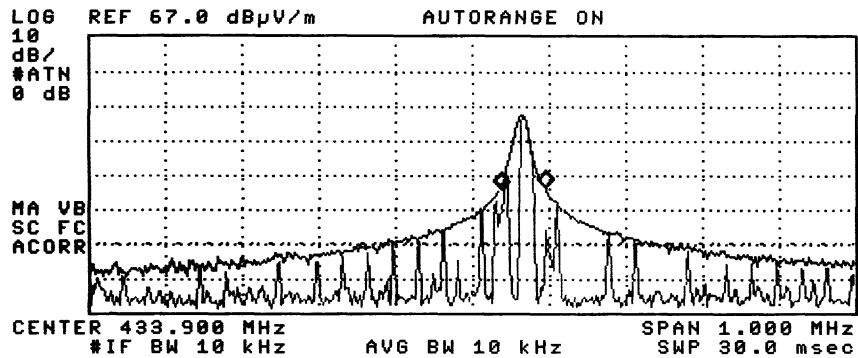

Appendix B

Duty Cycle Correction During 100msec

Each function key sends a different series of characters, but each packet period (16msec) never exceeds a series of 3 long (1.5msec) and 10 short (500µsec) pulses. Assuming any combination of short and long pulses may be obtained due to encoding the worst case transmit duty cycle would be considered 3x1.5msec per 16msec=59.3% duty cycle. Figure A through C show the characteristics of the pulse train for one of these functions.

Remarks:

Duty Cycle Correction = $20\text{Log}(0.593) = -4.5\text{dB}$

Figure A [Pulse Train]

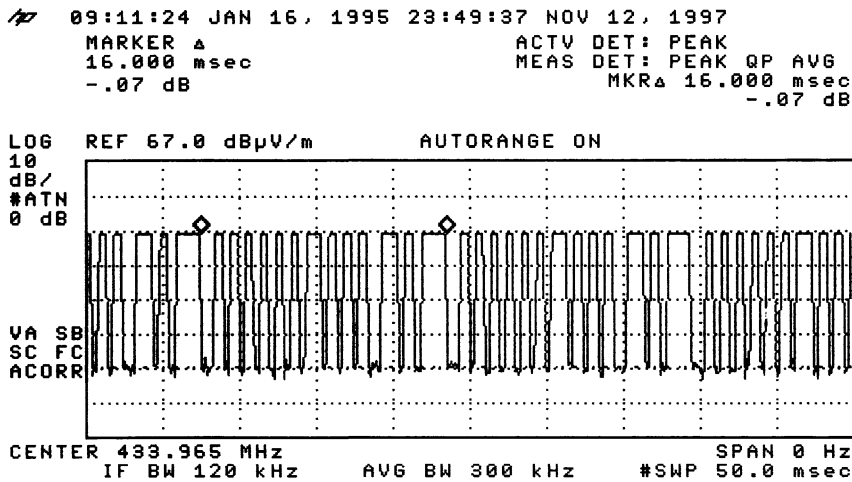


Figure B [Long Pulse]

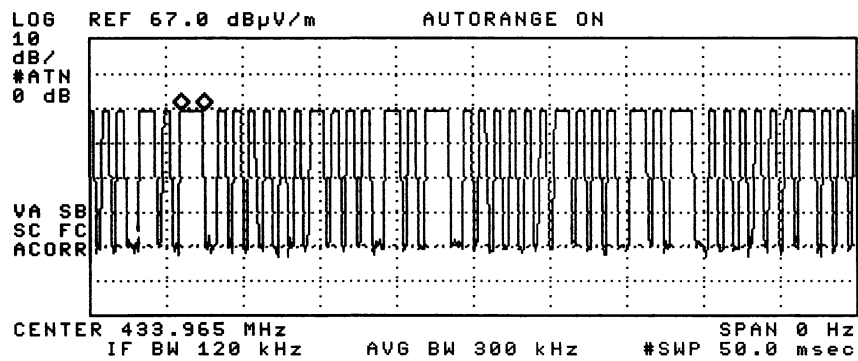
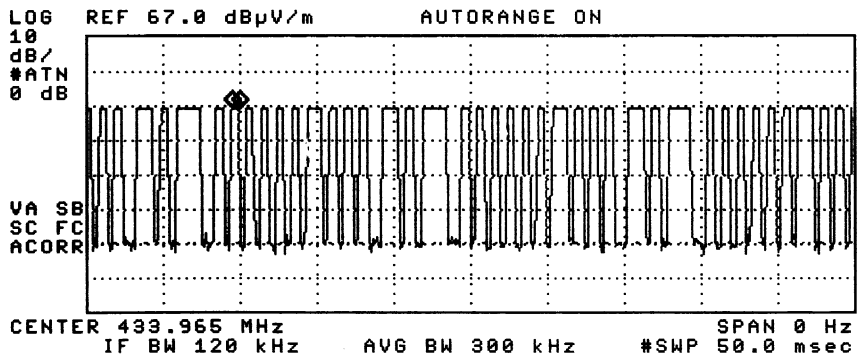


Figure C [Short Pulse]

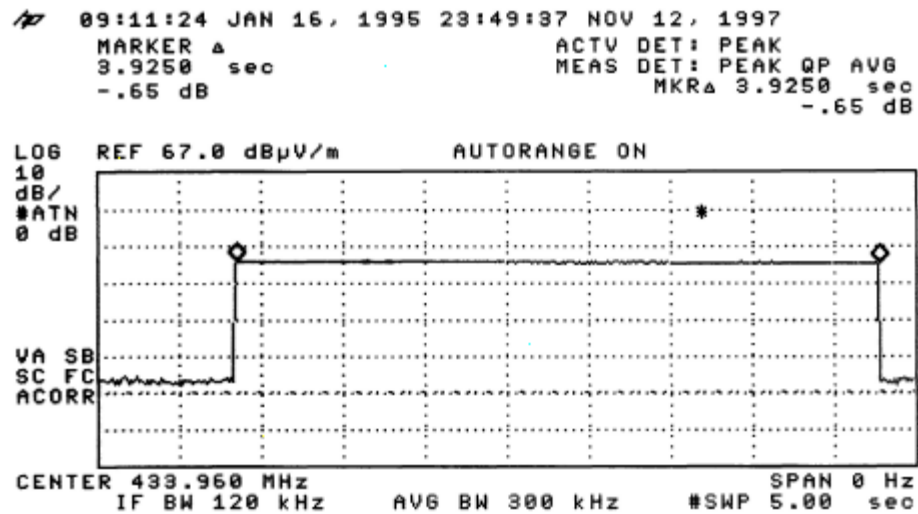


Appendix C

Periodic Operation [FCC 47CFR 15.231a]

According to FCC 47CFR15.231a. A transmitter manually activated must automatically deactivate within not more than 5 seconds of being released. The transmitter is a 4 button transmitter. The EUT to transmit while each button is being pressed. The EUT ceases transmission almost immediately upon being released and appears to finish the current packet being transmitted 3.925sec. as shown in Figure D
