4.1 Requirements

4.3 MPE Calculation Method

$$E (V/m) = \frac{\sqrt{30 \times n}}{dt}$$

 $\frac{P \times \overline{G}}{P}$ Power Density: Pd (W/m²) = $\frac{E^2}{377}$

E = Electric field (V/m)

P = Peak RF output power (W)

G = EUT Antenna numeric gain (numeric)

d = Separation distance between radiator and human body (m)

The formula can be changed to

$$Pd = \frac{30 \times P \times G}{377 \times d^2}$$

From the peak EUT RF output power, the minimum mobile separation distance, d=0.2m, as well as the gain of the used antenna, the RF power density can be obtained
