#### 3. CHARACTERISTICS OF THE TEST

#### 3.1 TEST REQUESTED

Radiated measurements of spurious emissions (Emission limitations for transmitter and radiated emissions limits for receiver) for frequency hopping spread spectrum equipment (Bluetooth) operating in the 2400 MHz -2483.5 MHz band, according to FCC Part 15.247.

The equipment incorporates the RF Bluetooth board-to-board module Bluegiga model WRAP THOR 2022-1-b2b which results are shown in report number 19807RET.101 dated 2004-05-31.

## 3.2 REQUIREMENTS AND METHOD

The test has been carried out according to FCC parts 15.33, 15.35, 15.109, 15.205, 15.209, 15.247 and the document DA 00-705: "Filing and Measurement Guidelines for Frequency Hopping Spread Spectrum Systems".

The testing was performed according to the procedure in ANSI C63.4 (1992). Radiated testing was performed in Cetecom's semi-anechoic chamber. This site has been fully described in a report submitted to the FCC and was accepted in a letter dated July 25, 2002.

The test set-up was made in accordance to the general provisions of ANSI C63.4-1992.

## **RADIATED MEASUREMENTS**

All radiated tests were performed in a semi-anechoic chamber. The measurement antenna is situated at a distance of 3 m for the frequency range 30 MHz-1000 MHz (30 MHz-1000 MHz Bilog antenna) and at a distance of 1m for the frequency range 1 GHz-25 GHz (1 GHz-18 GHz Double ridge horn antenna and 18 GHz-40 GHz horn antenna).

For radiated emissions in the range 1 GHz-25 GHz that is performed at a distance closer than the specified distance, an inverse proportionality factor of 20 dB per decade is used to normalize the measured data for determining compliance.

The equipment under test was set up on a non-conductive (wooden) platform one meter above the ground plane and the situation and orientation was varied to find the maximum radiated emission. It was also rotated 360° and the antenna height was varied from 1 to 4 meters to find the maximum radiated emission.

Measurements were made in both horizontal and vertical planes of polarization.

The emission limits shown in the above table are based on measurements employing CISPR quasi-peak detector except for the frequency bands 9-90 kHz, 110-490 kHz and above 1000 MHz. Radiated emission limits in these three bands are based on measurements employing an average detector.

For average radiated emission measurements above 1000 MHz, there is also a limit corresponding to 20 dB above the indicated values in the table is specified when measuring with peak detector function.

#### **RESULTS:**

The field strength is calculated by adding correction factor to the measured level from the spectrum analyser. This correction factor includes antenna factor, cable loss and preamplifiers gain.

The equipment transmits continuously in the selected channel so it is not necessary a duty cycle correction factor.




## FREQUENCY RANGE 30 MHz-1000 MHz.

#### CHANNEL: MIDDLE (2441 MHz).



## CHANNEL: HIGHEST (2480 MHz).





## CHANNEL: Lowest (2402 MHz).



## CHANNEL: Middle (2441 MHz).



## CHANNEL: Highest (2480 MHz).








## CHANNEL: Highest (2480 MHz).

## FREQUENCY RANGE 12.75 GHz to 18 GHz.





## FREQUENCY RANGE 30 MHz-1000 MHz.




## FREQUENCY RANGE 2.9 GHz-12.75 GHz.


## FREQUENCY RANGE 12.75 GHz-18 GHz.
