## Product Description



Hawkeye 4 is battery powered Wi-Fi connected security camera. It requires no wires for either power or communication and is therefore extremely easy to install.

All that is required is two non-rechargeable AA sized lithium batteries and a Wi-Fi access point with an internet connection. A free application available for iPhone and Android enabled smart phones is used to arm and disarm the camera (or cameras) in your home or office. Once armed if movement is detected with the inbuilt infrared detector a video is taken and the user is notified. The user may then view the video directly on their smartphone and respond accordingly.
