## A7.2. WCDMA Measurement Method and test procedures

The following steps outline the procedure used to measure the conducted emissions from the EUT.

1. Determine frequency range for measurements: From CFR 2.1057 the spectrum should be investigated from the lowest radio frequency generated in the equipment up to at least the 10th harmonic of the carrier frequency. For the equipment of WCDMA Band II, this equates to a frequency range of 30 MHz to 19.1 GHz , data taken from 30 MHz to 20 GHz . For WCDMA Band V, data taken from 30 MHz to 10 GHz .
2. The sweep time is set automatically by instrument itself. That should be the optimal sweep time for the span and the RBW. If the sweep time is too short, that is sweep is too fast, the sweep result is not accurate; If the sweep time is too long, that is sweep is too low, some frequency components may be lost. The instrument will give a optimal sweep time according the selected span and RBW.
3. The procedure to get the conducted spurious emission is as follows:

The trace mode is set to MaxHold to get the highest signal at each frequency;
Wait 25 seconds;
Get the result.
4. Determine EUT transmit frequencies: below outlines the band edge frequencies pertinent to conducted emissions testing.

## A 7.2.1. Measurement Limit

Part 24.238 and Part 22.917 specify that the power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power $(\mathrm{P})$ by a factor of at least $43+10 \log (P) d B$.
The specification that emissions shall be attenuated below the transmitter power (P) by at least 43 $+10 \log (\mathrm{P}) \mathrm{dB}$, translates in the relevant power range ( 1 to 0.001 W ) to -13 dBm . At 1 W the specified minimum attenuation becomes 43 dB and relative to a $30 \mathrm{dBm}(1 \mathrm{~W})$ carrier becomes a limit of -13 dBm . At $0.001 \mathrm{~W}(0 \mathrm{dBm})$ the minimum attenuation is 13 dB , which again yields a limit of -13 dBm . In this way a translation of the specification from relative to absolute terms is carried out.

## A.8.1. EIRP

## A.8.1.1. GSM EIRP

## A.8.1.1.1. Description

This is the test for the maximum radiated power from the EUT.
Rule Part 24.232(c) specifies, "Mobile/portable stations are limited to 2 watts e.i.r.p. Peak power" and 24.232(c) specifies that "Peak transmit power must be measured over any interval of continuous transmission using instrumentation calibrated in terms of an rms-equivalent voltage. "Rule Part 22.913(a) specifies " The ERP of mobile transmitters and auxiliary test transmitters must not exceed 7 Watts."

## A.8.1.1.2. Method of Measurement

The measurements procedures in TIA-603E-2016 are used.

1. EUT was placed on a 1.5 meter high non-conductive stand at a 3 meter test distance from the receive antenna. A receiving antenna was placed on the antenna mast 3 meters from the EUT for emission measurements. The height of receiving antenna is 1.5 m . The test setup refers to figure below. Detected emissions were maximized at each frequency by rotating the EUT through $360^{\circ}$ and adjusting the receiving antenna polarization. The radiated emission measurements of all transmit frequencies in three channels (High, Middle, Low) were measured with peak detector.

2. The EUT is then put into continuously transmitting mode at its maximum power level during the test. And the maximum value of the receiver should be recorded as (Pr).
3. The EUT shall be replaced by a substitution antenna. The test setup refers to figure below.


In the chamber, an substitution antenna for the frequency band of interest is placed at there reference point of the chamber. An RF Signal source for the frequency band of interest is connected to the substitution antenna with a cable that has been constructed to not interfere with the radiation pattern of the antenna. A power ( $\mathrm{P}_{\mathrm{Mea}}$ ) is applied to the input of the substitution antenna, and adjust the level of the signal generator output until the value of the receiver reach the previously recorded ( Pr ). The power of signal source ( $\mathrm{P}_{\text {меа) }}$ ) is recorded. The test should be performed by rotating the test item and adjusting the receiving antenna polarization.
4. A amplifier should be connected to the Signal Source output port. And the cable should be connect between the Amplifier and the Substitution Antenna.
The cable loss ( $\mathrm{P}_{\mathrm{cl}}$ ) ,the Substitution Antenna Gain ( $\mathrm{Ga}_{\mathrm{a}}$ ) and the Amplifier Gain ( $\mathrm{PAg}_{\mathrm{Ag}}$ ) should be recorded after test.
The measurement results are obtained as described below:
Power(EIRP)=PMea+ $\mathrm{PAg}^{-}$- $\mathrm{Pcl}^{\mathrm{cl}} \mathrm{Ga}_{\mathrm{a}}$
5. This value is EIRP since the measurement is calibrated using an antenna of known gain ( 2.15 dBi ) and known input power.
6. ERP can be calculated from EIRP by subtracting the gain of the dipole, ERP = EIRP -2.15 dBi .

## A.8.1.2.1. Description

This is the test for the maximum radiated power from the EUT.
Rule Part 24.232(c) specifies, "Mobile/portable stations are limited to 2 watts e.i.r.p. Peak power" and 24.232(c) specifies that "Peak transmit power must be measured over any interval of continuous transmission using instrumentation calibrated in terms of an rms-equivalent voltage. "Rule Part 22.913(a) specifies " The ERP of mobile transmitters and auxiliary test transmitters must not exceed 7 Watts."

## A.8.1.2.2. Method of Measurement

The measurements procedures in TIA-603E-2016 are used.

1. EUT was placed on a 1.5 meter high non-conductive stand at a 3 meter test distance from there receive antenna. A receiving antenna was placed on the antenna mast 3 meters from the EUT for emission measurements. The height of receiving antenna is 1.5 m . The test setup refers to figure below. Detected emissions were maximized at each frequency by rotating the EUT through $360^{\circ}$ and adjusting the receiving antenna polarization. The radiated emission measurements of all transmit frequencies in three channels (High, Middle, Low) we remeasured with peak detector.

2. The EUT is then put into continuously transmitting mode at its maximum power level during the test. And the maximum value of the receiver should be recorded as (Pr).
3. The EUT shall be replaced by a substitution antenna. The test setup refers to figure below.


In the chamber, an substitution antenna for the frequency band of interest is placed at the reference point of the chamber. An RF Signal source for the frequency band of interest is connected to the substitution antenna with a cable that has been constructed to not interfere with the radiation pattern of the antenna. A power ( $\mathrm{PMea}_{\mathrm{Mea}}$ ) is applied to the input of the substitution antenna, and adjust the level of the signal generator output until the value of the receiver reach the previously recorded ( Pr ). The power of signal source ( Pmea ) is recorded. The test should be performed by rotating the test item and adjusting the receiving antenna polarization.
4. A amplifier should be connected to the Signal Source output port. And the cable should be connect between the Amplifier and the Substitution Antenna.
The cable loss ( $\mathrm{P}_{\mathrm{cl}}$ ) ,the Substitution Antenna Gain $\left(\mathrm{G}_{\mathrm{a}}\right)$ and the Amplifier Gain ( $\mathrm{PAg}_{\mathrm{Ag}}$ ) should be recorded after test.
The measurement results are obtained as described below:
Power(EIRP)=PMea+ $\mathrm{PAg}_{\mathrm{Ag}}-\mathrm{P}_{\mathrm{cl}}+\mathrm{G}_{\mathrm{a}}$
5. This value is EIRP since the measurement is calibrated using an antenna of known gain (2.15 dBi ) and known input power.
6. ERP can be calculated from EIRP by subtracting the gain of the dipole, ERP = EIRP -2.15 dBi .

## A.8.2 EMISSION LIMIT (§2.1051/§22.917§24.238)

## A.8.2.1 GSM Measurement Method

The measurement procedures in TIA-603E-2016are used.
The spectrum was scanned from 30 MHz to the 10th harmonic of the highest frequency generated within the equipment, which is the transmitted carrier that can be as high as 1910 MHz . The resolution bandwidth is set as outlined in Part 24.238 and Part 22.917. The spectrum is scanned with the mobile station transmitting at carrier frequencies that pertain to low, mid and high channels of PCS1900 and GSM850.

## A.8.2.2 The procedure of radiated spurious emissions is as follows:

1. EUT was placed on a 1.5 meter high non-conductive stand at a 3 meter test distance from the receive antenna. A receiving antenna was placed on the antenna mast 3 meters from the EUT for emission measurements. The height of receiving antenna is 1.5 m . The test setup refers to figure below. Detected emissions were maximized at each frequency by rotating the EUT through $360^{\circ}$ and adjusting the receiving antenna polarization. The radiated emission measurements of all non-harmonic and harmonics of the transmit frequency through the $10^{\text {th }}$ harmonic were measured with peak detector.

2. The EUT is then put into continuously transmitting mode at its maximum power level during the test. And the maximum value of the receiver should be recorded as (Pr).
3. The EUT shall be replaced by a substitution antenna. The test setup refers to figure below.

dBi ) and known input power.
6. ERP can be calculated from EIRP by subtracting the gain of the dipole, ERP = EIRP -2.15dBi

## A.8.2.3 Measurement Limit

Part 24.238 and Part 22.917 specify that the power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power $(\mathrm{P})$ by a factor of at least $43+10 \log (P) d B$.
The specification that emissions shall be attenuated below the transmitter power (P) by at least 43 $+10 \log (P) \mathrm{dB}$, translates in the relevant power range $(1$ to 0.001 W$)$ to -13 dBm . At 1 W the specified minimum attenuation becomes 43 dB and relative to a $30 \mathrm{dBm}(1 \mathrm{~W})$ carrier becomes a limit of -13 dBm . At $0.001 \mathrm{~W}(0 \mathrm{dBm})$ the minimum attenuation is 13 dB , which again yields a limit of -13 dBm . In this way a translation of the specification from relative to absolute terms is carried out.

## A.8.2.4 Measurement Results

Radiated emissions measurements were made only at the upper, middle, and lower carrier frequencies of the PCS1900 band ( $1850.2 \mathrm{MHz}, 1880 \mathrm{MHz}$ and 1909.8 MHz ) and GSM850 band $(824.2 \mathrm{MHz}, 836.6 \mathrm{MHz}, 848.8 \mathrm{MHz})$. It was decided that measurements at these three carrier frequencies would be sufficient to demonstrate compliance with emissions limits because it was seen that all the significant spurs occur well outside the band and no radiation was seen from a carrier in one block of the PCS1900,GSM850 into any of the other blocks. The equipment must
still, however, meet emissions requirements with the carrier at all frequencies over which it is capable of operating and it is the manufacturer's responsibility to verify this

## A.8.3 WCDMA Measurement Method

The measurements procedures in TIA-603E-2016 are used.
The spectrum was scanned from 30 MHz to the 10th harmonic of the highest frequency generated within the equipment. The resolution bandwidth is set as outlined in Part 24.238 and Part 24.917. The spectrum is scanned with the mobile station transmitting at carrier frequencies that pertain to low, mid and high channels of WCDMA Band V.
The procedure of radiated spurious emissions is the same like GSM.

## A.8.3.1 Measurement Limit

Part 24.238 and Part 22.917 specify that the power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power $(\mathrm{P})$ by a factor of at least $43+10 \log (\mathrm{P}) \mathrm{dB}$.
The specification that emissions shall be attenuated below the transmitter power ( P ) by at least 43 $+10 \log (\mathrm{P}) \mathrm{dB}$, translates in the relevant power range ( 1 to 0.001 W ) to -13 dBm . At 1 W the specified minimum attenuation becomes 43 dB and relative to a $30 \mathrm{dBm}(1 \mathrm{~W})$ carrier becomes a limit of -13 dBm . At $0.001 \mathrm{~W}(0 \mathrm{dBm})$ the minimum attenuation is 13 dB , which again yields a limit of -13 dBm . In this way a translation of the specification from relative to absolute terms is carried out.

## A.8.3.2 Measurement Results

Radiated emissions measurements were made only at the upper, middle, and lower carrier frequencies of the WCDMA Band V ( $826.4 \mathrm{MHz}, 836.6 \mathrm{MHz}$ and 846.6 MHz ) . It was decided that measurements at these three carrier frequencies would be sufficient to demonstrate compliance with emissions limits because it was seen that all the significant spurs occur well outside the band and no radiation was seen from a carrier in one block of the WCDMA Band V into any of the other blocks. The equipment must still, however, meet emissions requirements with the carrier at all frequencies over which it is capable of operating and it is the manufacturer's responsibility to verify this.
