



The electrical power strip and the LISN is calibrated as a system to be in compliance with ANSI 63.10:2009. The power cables of all other units of the EUT were connected to a second LISN 2, which was bonded to the ground reference plane in the same way as the LISN 1 for the unit being measured. 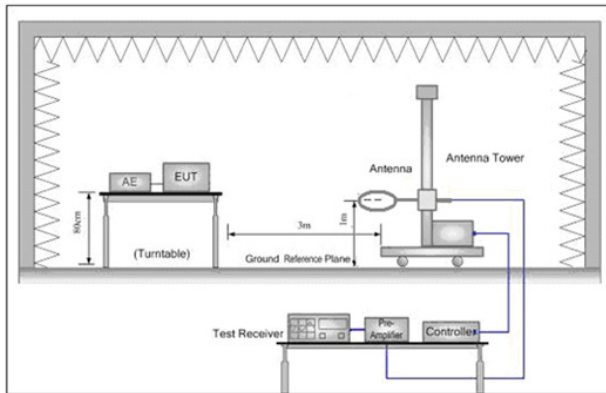


Figure 1. Below 30MHz

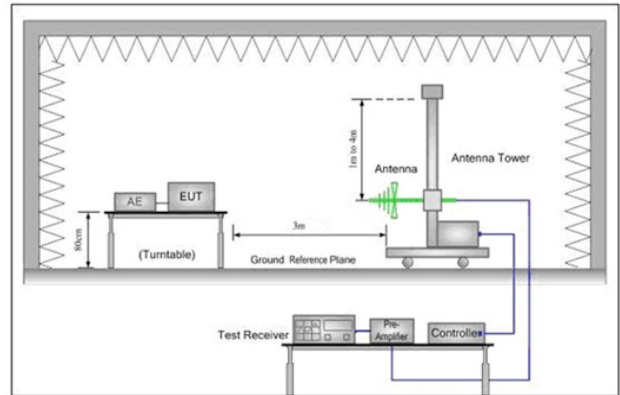


Figure 2. 30MHz to 1GHz

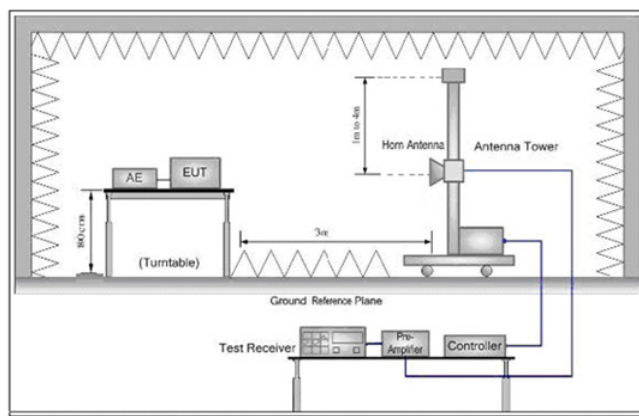


Figure 3. Above 1 GHz

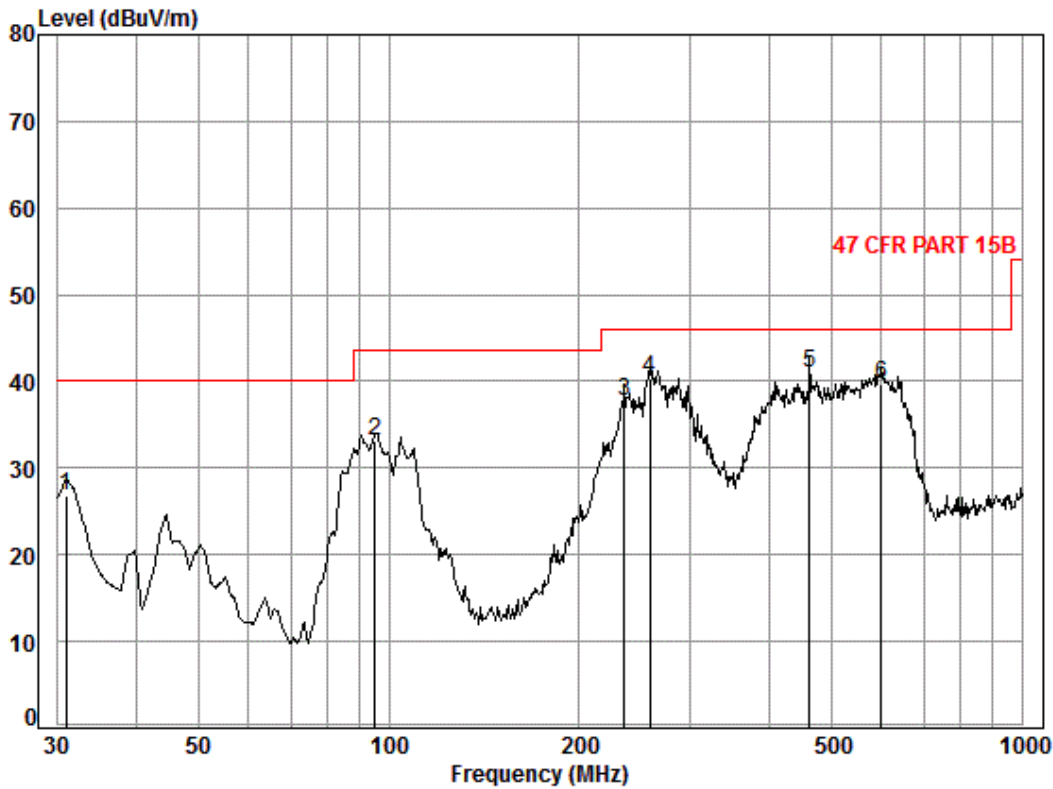

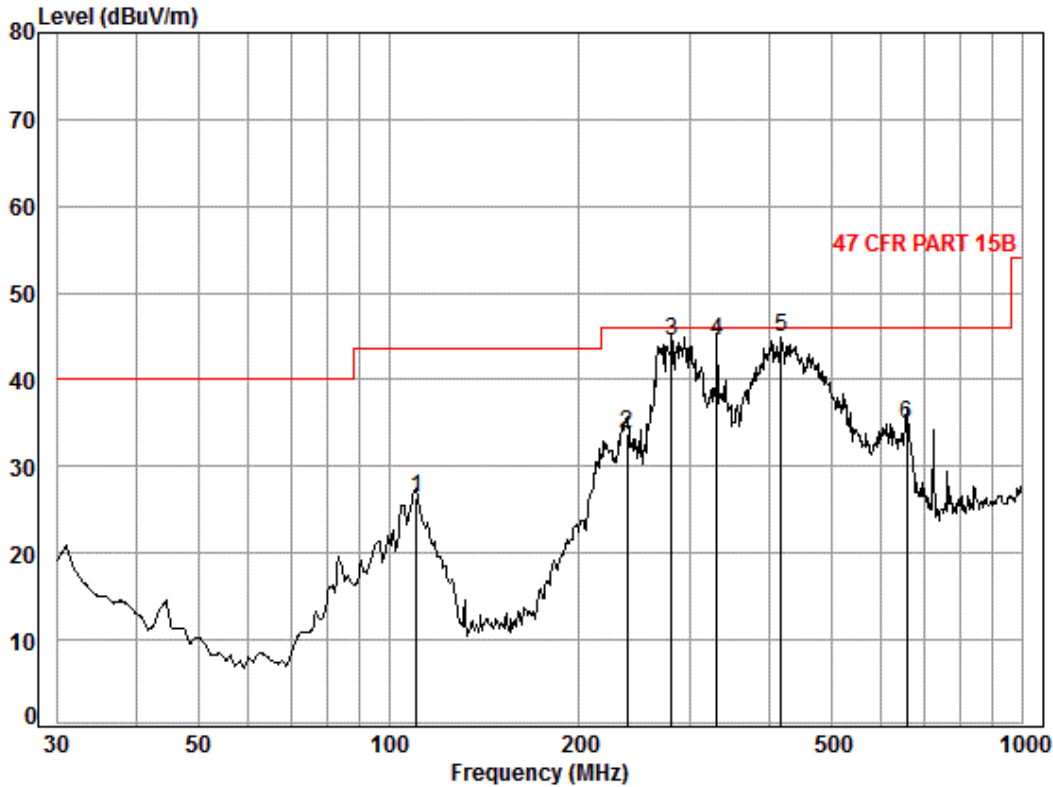

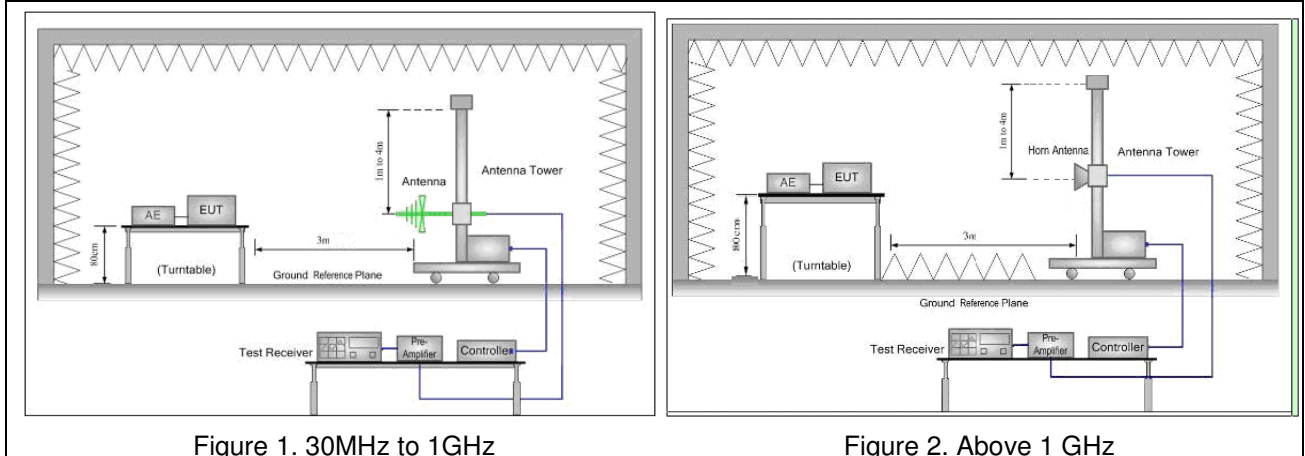


Figure 1. 30MHz to 1GHz

Figure 2. Above 1 GHz





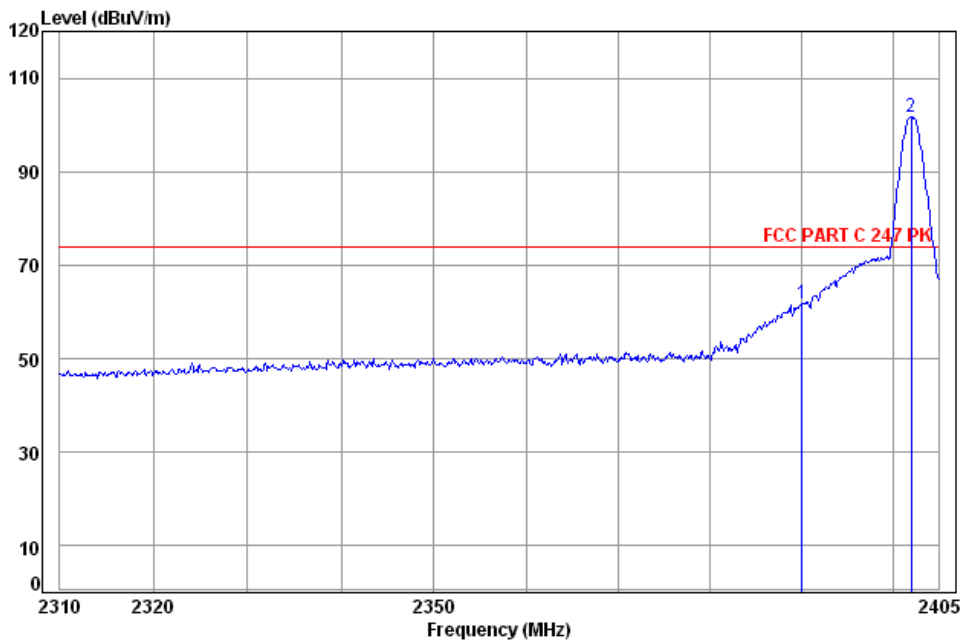
