Test Graphs Peak

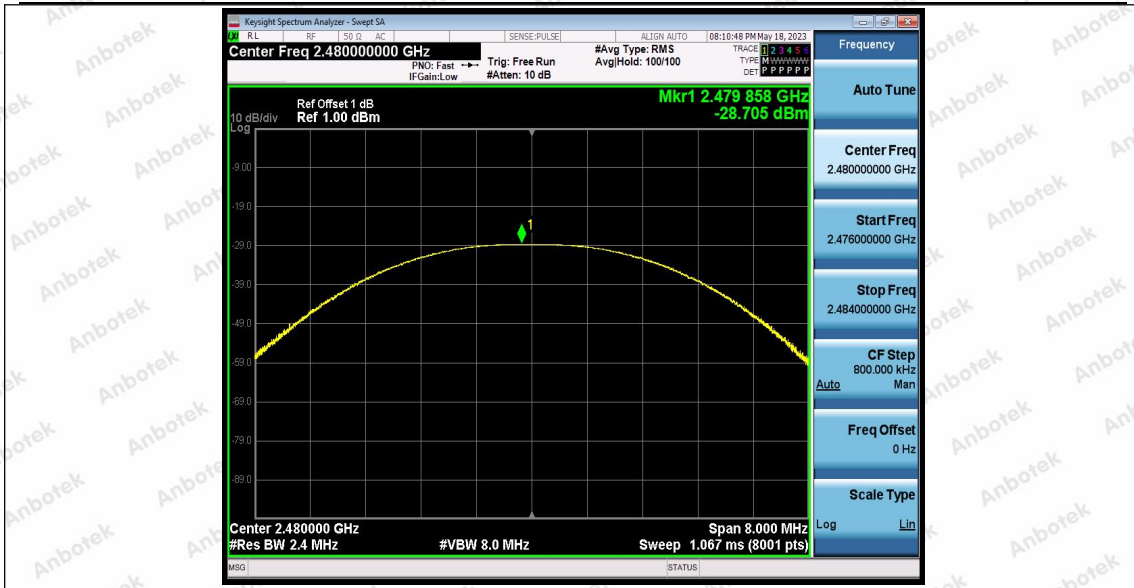
