#### 4 TEST RESULTS

#### 4.1 CONDUCTED EMISSIONS AT AC MAINS

Standard FCC Part 15 Subpart C

## The test was performed according to:

ANSI C63.10

#### 4.1.1 TEST DESCRIPTION

The test set-up was made in accordance to the general provisions of ANSI C 63.10 The Equipment Under Test (EUT) was setup in a shielded room to perform the conducted emissions measurements in a typical installation configuration. The EUT was powered from  $50\mu\text{H}$  || 50 Ohm Line Impedance Stabilization Network (LISN). The LISN's unused connections were terminated with 50 Ohm loads.

The measurement procedure consists of two steps. It is implemented into the EMI test software EMC-32 from R&S.

### Step 1: Preliminary scan

Intention of this step is, to determine the conducted EMI-profile of the EUT. EMI receiver settings:

- Detector: Peak Maxhold & Average
  Frequency range: 150 kHz 30 MHz
- Frequency steps: 2.5 kHzIF–Bandwidth: 9 kHz
- Measuring time / Frequency step: 100 ms (FFT-based)
- Measurement on phase + neutral lines of the power cords

On basis of this preliminary scan the highest amplitudes and the corresponding frequencies relative to the limit are identified. Emissions above the limit and emissions which are in the 10 dB range below the limit are considered.

#### Step 2: Final measurement

Intention of this step is, to determine the highest emissions with the settings defined in the test specification for the frequencies identified in step 1.

EMI receiver settings:

- Detector: Quasi-PeakIF Bandwidth: 9 kHz
- Measuring time: 1 s / frequency

At each frequency determined in step 1, four measurements are performed in the following combinations:

- 1) Neutral lead reference ground (PE grounded)
- 2) Phase lead reference ground (PE grounded)
- 3) Neutral lead reference ground (PE floating)
- 4) Phase lead reference ground (PE floating)

The highest value is reported.



#### 4.2.1 TEST DESCRIPTION

The Equipment Under Test (EUT) was set up to perform the occupied bandwidth measurements.

The reference level is the level of the highest amplitude signal observed from the transmitter at either the fundamental frequency or first-order modulation products in all typical modes of operation, including the unmodulated carrier, even if atypical.

The results recorded were measured with the modulation which produce the worst-case (widest) emission bandwidth.

The EUT was connected to spectrum analyzer via a short coax cable with a known loss.

Analyzer settings:

Resolution Bandwidth (RBW): 1% to 5 % of the OBW

• Video Bandwidth (VBW): 3 x RBW

• Span: 2 to 5 times the OBW

Trace: MaxholdSweeps: 2000Sweeptime: 8.5 msDetector: Peak

Since the Bluetooth technology defines a fixed channel separation of 1 MHz this design parameter defines the maximum allowed occupied bandwidth depending on the EUT's output power:




Radio Technology = Bluetooth BDR, Operating Frequency = mid 30 MHz - 1 GHz, Setup = S01\_ad01






Radio Technology = Bluetooth BDR, Operating Frequency = high 1 GHz - 26 GHz, Setup = S01\_ad01






