



# Frequency Response of E-Field (TEM-Cell:ifi110 EXX, Waveguide: R22)




Uncertainty of Frequency Response of E-field:  $\pm$  6.3% (k=2)


# Receiving Pattern ( $\phi$ ), $\vartheta = 0^{\circ}$



Uncertainty of Axial Isotropy Assessment: ± 0.5% (k=2)


# Dynamic Range f(SAR<sub>head</sub>) (TEM cell , f<sub>eval</sub>= 1900 MHz)






Uncertainty of Linearity Assessment:  $\pm$  0.6% (k=2)




