## Request for Modular Approval

The modular transmitter (Model: MBH2BT01) is designed by Fujitsu Media Devices Limited.

The modular transmitter complies the module basic requirement (Item 1 to 8) in FCC Public Notice: Part 15  
Unlicensed Modular Transmitter Approval as indicated below:

### [Module basic requirement]

- (1) **Have its own RF shielding.: This modular transmitter has its own RF shielding. Whole part of this module is shielded by cover. Please find attached Photo A1.**
- (2) The modular transmitter must have buffered modulation/data inputs.: Data input to Modular transmitter is controlled as not generating excessive data speed and abnormal modulation.
- (3) The modular transmitter must have its own power supply regulation.: The module can regulate Power Supply by itself. (See Schematic)
- (4) The modular transmitter must comply with the antenna requirements of Section 15.203 and 15.204(c).: The antenna of this equipment is installed into the chassis. So, it is impossible for users to disconnect it. Accordingly, it is complied.
- (5) The modular transmitter must be tested in a stand alone.: The modular transmitter has been performed the testing as a stand alone and then confirmed the compliance. Please refer to the Test report (No. 23FE0027-YK-1)
- (6) The modular transmitter must be labeled with its own FCC ID number, and, if the FCC ID is not visible when The module is installed inside another device, then the outside of the device into which the module is installed must also display a label referring to the enclosed module.: This modular transmitter is complied with this requirement. Please refer to the file of Label drawing and location.
- (7) The modular transmitter must comply with any specific rule or operating requirements applicable to the transmitter and the manufacturer must provide adequate instructions along with the module to explain any such requirements.: The necessary explanation to be complied with this requirement is contained in the manual.
- (8) The modular transmitter must comply with any applicable RF exposure requirements.: The modular transmitter complies with FCC radiation exposure requirement specified in the FCC Rules 15.247(b)(4). Please refer to the RF exposure statement.


