2.0 General Description

2.1 Product Description

CP3503L is subscriber equipment in the GSM/UMTS/LTE system. The GSM frequency band includes GSM850 and DCS1800 and PCS1900. but only GSM850/1900 test data included in this report. The UMTS frequency band is band I and band II and band IV and band V, but only band II and Band IV and Band V test data included in this report. The LTE frequency band is Band I and Band II and band III band IV and band V and band VII and Band XII and Band XIII and Band XVII and Band XXVIII, but only Band II and band IV and band V and band VII and Band XII and Band XIII and Band XVII test data included in this report. The Mobile Phone implements such functions as RF signal receiving/transmitting, LTE/UMTS and GSM/GPRS/EDGE protocol processing, voice, video MMS service, GPS, Bluetooth and Wi-Fi etc. Externally it provides micro SD card interface, earphone port (to provide voice service) and USIM card interface. It also provides Bluetooth module to synchronize data between a PC and the phone, or to use the built-in modem of the phone to access the Internet with a PC, or to exchange data with other Bluetooth devices. Bluetooth and Wi-Fi transmitters are share one antenna while they can't transmit simultaneously. The EUT is powered by DC 3.8V by rechargeable battery and charged by AC 120V/60Hz. For more detailed features description, please refer to the user's manual.

2.3 Test Methodology

Both AC mains line-conducted and radiated emission measurements were performed according to the procedures in ANSI C63.10 (2013). Radiated emission measurement was performed in Semi-anechoic chamber and conducted emission measurement was performed in shield room. For radiated emission measurement, preliminary scans were performed in the semi-anechoic chamber only to determine the worst-case modes. All radiated tests were performed at an antenna to EUT distance of 3 meters, unless stated otherwise in the "Justification Section" of this Application. All other measurements were made in accordance with the procedures in part 2 of CFR 47.

3.0 System Test Configuration

3.1 Justification

For emissions testing, the equipment under test (EUT) setup to transmit continuously to simplify the measurement methodology. Care was taken to ensure proper power supply voltages during testing. During testing, all cables were manipulated to produce worst case emissions. The EUT is powered by DC 3.8V by rechargeable battery and charged by AC 120V/60Hz, only the worst data was reported in this report.

Intertek Report No.: 200810035SZN-003

For maximizing emissions, the EUT was rotated through 360°, the EUT was placed on the styrene turntable with 0.8m up to 1GHz and 1.5 m above 1GHz. The antenna height and polarization are varied during the search for maximum signal level. The antenna height is varied from 1 to 4 meters. Radiated emissions are taken at three meters unless the signal level is too low for measurement at that distance. If necessary, a preamplifier is used and/or the test is conducted at a closer distance.

All readings are extrapolated back to the equivalent three meters reading using inverse scaling with distance. Analyzer resolution is 100 kHz or greater for frequencies below 1000 MHz. The resolution is 1 MHz or greater for frequencies above 1000 MHz. The spurious emissions more than 20 dB below the permissible value are not reported.

The rear of unit was flushed with the rear of the table.

Radiated emission measurement was performed the lowest radio frequency signal generated in the device which is greater than 9 kHz to the tenth harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower.

3.2 EUT Exercising Software

The EUT exercise program (provided by client) used during radiated and conducted testing was designed to exercise the various system components in a manner similar to a typical use. The worst case configuration is used in all specified testing.

The parameters of test software setting:

During the test, Channel and power controlling software provided by the applicant was used to control the operating channel as well as the output power level. The RF output power selection is for the setting of RF output power expected by the application and is going to be fixed on the firmware of the end product.

4.0 Emission Results

Data is included worst-case configuration (the configuration which resulted in the highest emission levels).

4.1 Radiated Test Results

A sample calculation, configuration photographs and data tables of the emissions are included.

4.1.1 Field Strength Calculation

The field strength is calculated by adding the reading on the Spectrum Analyzer to the factors associated with preamplifiers (if any), antennas, cables, pulse desensitization and average factors (when specified limit is in average and measurements are made with peak detectors). A sample calculation is included below.

FS = RA + AF + CF - AG + PD + AV

Where $FS = Field Strength in dB\mu V/m$

RA = Receiver Amplitude (including preamplifier) in $dB\mu V$

CF = Cable Attenuation Factor in dB

AF = Antenna Factor in dB AG = Amplifier Gain in dB

PD = Pulse Desensitization in dB

AV = Average Factor in -dB

In the radiated emission table which follows, the reading shown on the data table may reflect the preamplifier gain. An example of the calculations, where the reading does not reflect the preamplifier gain, follows:

$$FS = RA + AF + CF - AG + PD + AV$$

Assume a receiver reading of 62.0 dB μ V is obtained. The antenna factor of 7.4 dB and cable factor of 1.6 dB is added. The amplifier gain of 29 dB is subtracted. The pulse desensitization factor of the spectrum analyzer was 0 dB, and the resultant average factor was -10 dB. The net field strength for comparison to the appropriate emission limit is 32 dB μ V/m. This value in dB μ V/m was converted to its corresponding level in μ V/m.

9.0 Miscellaneous Information

This miscellaneous information includes details of the measured bandedge, 20dB Bandwidth, the test procedure and calculation of factor such as pulse desensitization.

9.1 Bandedge Plot

The test plots are attached as below. From the below plots, the field strength of any emissions outside of the specified frequency band are attenuated to the general radiated emission limits in section 15.209. It fulfils the requirement of 15.249(d).

Peak Measurement

Bandedge compliance is determined by applying marker-delta method, i.e (Bandedge Plot).

(i) Lowest frequency channel (2402MHz):





Lowest frequency Channel




Highest frequency Channel






9.2 20dB bandwidth

Pursuant to FCC part 15 Section 15.215(c), the 20dB bandwidth of the emission was contained within the frequency band designated (mentioned as above) which the EUT operated. The effects, if any, from frequency sweeping, frequency hopping, other modulation techniques and frequency stability over excepted variations in temperature and supply voltage were considered. The EUT antenna output port was connected to the input of the spectrum analyzer. The analyzer center frequency was set to EUT RF channel carrier. The SWEP function on the analyzer was set to ZERO SPAN. The Transmitter ON time was determined from the resultant time-amplitude display:

9.5 Emissions Test Procedures

The following is a description of the test procedure used by Intertek Testing Services in the measurements of transmitters operating under Part 15, Subpart C rules.

The test set-up and procedures described below are designed to meet the requirements of ANSI C63.10 - 2013.

The transmitting equipment under test (EUT) is placed on a styrene turntable which is four feet in diameter and approximately 0.8 meter up to 1GHz and 1.5 meter above 1GHz in height above the ground plane. During the radiated emissions test, the turntable is rotated and any cables leaving the EUT are manipulated to find the configuration resulting in maximum emissions. The EUT is adjust through all three orthogonal axes to obtain maximum emission levels. The antenna height and polarization are varied during the testing to search for maximum signal levels.

Detector function for radiated emissions is in peak mode. Average readings, when required, are taken by measuring the duty cycle of the equipment under test and subtracting the corresponding amount in dB from the measured peak readings. A detailed description for the calculation of the average factor can be found in section 9.4.

The frequency range scanned is from the lowest radio frequency signal generated in the device which is greater than 9 kHz to the tenth harmonic of the highest fundamental frequency or 40 GHz, whichever is lower.

Detector function for conducted emissions is in QP & AV mode and IFBW setting is 9 kHz from the frequency band 150 kHz to 30MHz.

9.5 Emissions Test Procedures (cont'd)

The EUT is warmed up for 15 minutes prior to the test.

AC power to the unit is varied from 85% to 115% nominal and variation in the fundamental emission field strength is recorded. If battery powered, a new, fully charged battery is used.

Conducted measurements are made as described in ANSI C63.10 - 2013.

The IF bandwidth used for measurement of radiated signal strength was 10 kHz for emission below 30 MHz and 120 kHz for emission from 30 MHz to 1000 MHz. Where pulsed transmissions of short enough pulse duration warrant, a greater bandwidth is selected according to the recommendations of Hewlett Packard Application Note 150-2. Above 1000 MHz, a resolution bandwidth of 1 MHz is used (RBW 3MHz used for fundamental emission).

Transmitter measurements are normally conducted at a measurement distance of three meters. However, to assure low enough noise floor in the restricted bands and above 1 GHz, signals are acquired at a distance of one meter or less. All measurements are extrapolated to three meters using inverse scaling, but those measurements taken at a closer distance are so marked.
