What is the FDA's role concerning the safety of wireless phones?
 Under the law, the FDA does not review the safety of radiation-emitting consumer products such as wireless phones before they can be sold, as it does with new drugs or

medical devices. However, the agency has authority to take action if wireless phones are shown to emit Radio Frequency (RF) energy at a level that is hazardous to the user. In such a case, the FDA could require the manufacturers of wireless phones to notify users of the health hazard and to repair, replace, or recall the phones so that the hazard no longer exists. Although the existing scientific data does not justify FDA regulatory actions, the FDA has

While these base stations operate at higher power than do the wireless phones themselves. ## 4. What kinds of phones are the subjects of this update?

ss phones with built-in antenna Here the term "wireless phone" refers to handheld wireless phones with built-in antennas often called "cell" or "mobile" phones. These types of wireless phones can expose the user to measurable Radio Frequency (RF) energy because of the short distance between the phone and the user's head. These RF exposures are limited by FCC safety guidelines that were developed with the advice of the FDA and other federal health and safety agencies. When the phone is located at greater distances from the user, the exposure to RF is drastically reduced due to a person's RF exposure rapidly decreasing with Increasing distance from the source. The so-called "cordless phones," which have a base unit connected to the telept wiring in a house, typically operate at far lower power levels, thus producing RF exposures far below the FCC safety limits.

The project has also resulted in a series of public information documents on EMF issues. The FDA provides the scientific oversight, obtaining input from experts in government, industry, and academic organizations. CTIA-funded research will include both laboratory studies and tudies of wrieless phone users. The CRADA will also include a broad assessment of additional research needs in the context of the latest research developments around the world. developments around the world.

## 6. What research is needed to decide whether RF exposure from wireless phones poses earth risk? combination of laboratory studies and epidemiological studies of people actually using

A combination of laboratory studies and epidemiological studies of people actually us vireless phones would provide some of the virtal data. Lifetime animal exposure studie could be completed in a few years. However, very large numbers of animals would be veeded to provide reliable proof of a cancer-promoting effect, if one exists. Epidemiological studies can provide data that is directly applicable to human populations, but ten or more years of follow-up research may be needed to provide

populauous but ten or more years of follow-up research may be needed to provide answers about certain health effects, such as cancer. This is due to the interval between exposure time to a cancer-causing agent and the rate for which tumors develop - if they do. This could take severed years into the future. The interpretation of epidemiological studies is hampered by difficulties in measuring actual RF exposure during day-to-day use of wireless phones. Many factors affect this measurement, such as the angle at which the phone is held, or which model of phone is used.

## 7. What has the FDA done to measure the Radio Frequency energy coming from wireless phones? The Institute of Electrical and Electronic Engineers (IEEE) is developing a technical

The institute of Electrical and Electronic Engineers (IEEE) is developing a technical standard for measuring the Radio Frequency (RF) energy exposure from wireless phones and other wireless handsets with the participation and leadership of FDA scientists and engineers. The standard, "Recommended Practice for Determining the Spatial-Peak Specific Absorption Rate (SAR) in the Human Body Due to Wireless Communications Devices: Experimental Techniques", sets forth the first consistent test methodology for measuring the rate at which RF is deposited in the heads of wireless phone users. The test method uses a tissue-simulating model of the human haad. Standardized SAR test and different laboratories on the same phone. energy absorbed in tissue, either by the whole body or a small part of the body. It is measured in watts/kg (or mill-watts/g) of matter. This measurement is used to determine whether a wireless phone complies with safety guidelines.

## 8. How can I find out how much Radio Frequency energy exposure I can get by using

my wireless phone? All phones sold in the United States must comply with Federal Communications Commission (FCC) guidelines that limit Radio Frequency (RF) energy exposures. The established these guidelines in consultation with the FDA and the other federal health and safety agencies. The FCC limit for RF exposure from wireless phones is set at a Specific Absorption Rate (SAR) of 16 watts per kilogram (16W/Kg). The FCC limit is consistent with the safety standards developed by the institute of Electrical and Electronic Engineering (IEEE) and the National Council on Radiation Protection and Measurement. The exposure limit takes into consideration the body's ability to remove heat from the tissues that absorb energy from the wireless phone and is set well below levels known to have effects.
