


5.1.1 Limit & Test Method

KDB447498D01 General RF Exposure Guidance v06

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances ≤ 50 mm are determined by:

$[(\text{max. power of channel, including tune-up tolerance, mW}) / (\text{min. test separation distance, mm})] \cdot [\sqrt{f(\text{GHz})}] \leq 3.0$ for 1-g SAR and ≤ 7.5 for 10-g extremity SAR, where

- $f(\text{GHz})$ is the RF channel transmit frequency in GHz
- Power and distance are rounded to the nearest mW and mm before calculation¹⁷
- The result is rounded to one decimal place for comparison

The test exclusions are applicable only when the minimum test separation distance is ≤ 50 mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is < 5 mm, a distance of 5 mm is applied to determine SAR test exclusion

General RF Exposure = $(3.027 \text{ mW} / 5 \text{ mm}) \times \sqrt{2.480 \text{ GHz}} = 0.953$;
SAR requirement: $S = 3.0$;

$0.953 < 3.0$ the SAR report is not required.

4.22 dBm logarithmic terms convert to numeric result is nearly 2.642 mW
 $[(\text{max. power of channel, including tune-up tolerance, mW}) / (\text{min. test separation distance, mm})] \cdot [\sqrt{f(\text{GHz})}]$
General RF Exposure = $(2.642 \text{ mW} / 5 \text{ mm}) \times \sqrt{2.441 \text{ GHz}} = 0.826$;
SAR requirement: $S = 3.0$;

$0.826 < 3.0$ the SAR report is not required.
