Re: Single Limited Modular Approval Request

To whom it may concern,

We **Mobile Aspects Inc** are applying for a **single limited modular approval** for our device with;  
**FCC ID: R4FIRISPRINT10**

Please note that, this module is to be installed only by **Mobile Aspects Inc** in its end products, and will not be marketed to any other party.

The following information is being provided regarding **limited modular approval** per the requirements of CFR 47 FCC 15.212(b).

This transceiver is a complete RF module with an integral reference oscillator.  
External connections are provided for power and data communication.

The following numbered items correspond to requirements listed in 15.212 of the FCC rules.

*1) The radio elements of the modular transmitter must have their own shielding. The physical crystal and tuning capacitors may be located external to the shielded radio elements.*

→ Our device does not meet this and this is the reason we are requesting limited modular approval. Our device will be installed by our trained personnel in a computer which shall provide the shielding. This device is only used by Mobile Aspects in its product. It will not be made available or sold to a third party. It will be professionally installed by trained Mobile Aspects employees to ensure requirements listed in 15.212 of the FCC rules.

*2) The modular transmitter must have buffered modulation/data inputs (if such inputs are provided) to ensure that the module will comply with part 15 requirements under conditions of excessive data rates or over-modulation.*

→ Our module has buffered/data inputs so we comply with this requirement.

*3) The modular transmitter must have its own power supply regulation.*

→ Our device does not meet this and this is the reason we are requesting limited modular approval. The computer that the device will be installed will have a regulated power supply.

*4) The modular transmitter must comply with the antenna and transmission system requirements of Sec. 15.203, 15.204(b) and 15.204(c). The antenna must either be permanently attached or employ a "unique" antenna coupler (at all connections between the module and the antenna, including the cable). The "professional installation" provision of Sec. 15.203 is not applicable to modules but can apply to limited modular approvals under paragraph (b) of this section.*

→ Our device meets this requirement.

5) *The modular transmitter must be tested in a stand-alone configuration, i.e., the module must not be inside another device during testing for compliance with part 15 requirements. Unless the transmitter module will be battery powered, it must comply with the AC line conducted requirements found in Sec. 15.207. AC or DC power lines and data input/output lines connected to the module must not contain ferrites, unless they will be marketed with the module (see Sec. 15.27(a)). The length of these lines shall be the length typical of actual use or, if that length is unknown, at least 10 centimeters to insure that there is no coupling between the case of the module and supporting equipment. Any accessories, peripherals, or support equipment connected to the module during testing shall be unmodified and commercially available (see Sec. 15.31(i)).*

→ Our device meets this requirement.

6) *The modular transmitter must be equipped with either a permanently affixed label or must be capable of electronically displaying its FCC identification number.*

→ Our device meets this requirement.

7) *If using a permanently affixed label, the modular transmitter must be labeled with its own FCC identification number, and, if the FCC identification number is not visible when the module is installed inside another device, then the outside of the device into which the module is installed must also display a label referring to the enclosed module. This exterior label can use wording such as the following: ``Contains Transmitter Module FCC ID: XYZMODEL1" or ``Contains FCC ID: XYZMODEL1." Any similar wording that expresses the same meaning may be used. The Grantee may either provide such a label, an example of which must be included in the application for equipment authorization, or, must provide adequate instructions along with the module which explain this requirement. In the latter case, a copy of these instructions must be included in the application for equipment authorization.*

→ Our device meets this requirement. Both the device and the computer that it is installed in will have the FCC ID.

8) *The modular transmitter must comply with any applicable RF exposure requirements in its final configuration.*

→ Our device meets this requirement.
