

Click to select the preferred language and the FM broadcasting region onscreen to enter main UI. Hold the Power button while M7 is on, a shutdown dialogue will pop up, and you can select to power off or reboot the player.</div> <div>Charging</div> <div>Charges to full in about 2.5 hours using a DC 5V/2A adapter (2A or above is recommended).</div>	<div>English</div> <div>Portable High Resolution Music Player</div> <div>FM radio</div> <div>Please insert earphones before using the FM radio on the M7; for the first time of use, it will search available radio channels automatically.</div> <div>Gestures</div> <div>Return to previous menu: swipe up from the bottom-left area of the screen.
