 $Pd = (Pout^{*}G) / (4^{*}pi^{*}r^{2})$

where

 $Pd = power density in mW/cm^2$

Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

R = distance between observation point and center of the radiator in cm

2.3 Classification

2.4GHz Band: =3.32dBi + 10log(2)= 6.33dBi 5GHz: Directional Gain = 6.11dBi + 10log(2)=9.12dBi BT antenna gain: 3.32dBi

Conclusion:

The formula of calculated the MPE is: CPD1 / LPD1 + CPD2 / LPD2 +etc. < 1 CPD = Calculation power density LPD = Limit of power density

The simultaneous operation mode was determined by client.

1. WLAN 2.4G+ 5GHz =0.335/1+0.424/1=0.759

2. WLAN 2.4G+ BT =0.335/1+0.020/1=0.355

3. WLAN 5G+ BT =0.424/1+0.020/1=0.444

Therefore the maximum calculations of above situations are less than the "1" limit.
