




Duty Cycle Correction During 100msec


Each function key sends a different series of characters, but each packet period (40.875msec) never exceeds a series of 4 long (1.25msec) and 40 short (350µsec) pulses. Assuming any combination of short and long pulses may be obtained due to encoding the worst case transmit duty cycle would be considered 4x1.25msec+40x350µsec per 40.875msec=46.4% duty cycle. Figure A through C show the characteristics of the pulse train for one of these functions.

Remarks:

Figure B [Long Pulse]





Figure C [Short Pulse]


