2. MPE Calculation Method

 $E (V/m) = (30^{\circ}P^{\circ}G)^{0.5}/d$ Power Density: $Pd(W/m^2) = E^2/377$

E=Electric Field (V/m)

P=Peak RF output Power (W)

G=EUT Antenna numeric gain (numeric)

d= Separation distance between radiator and human body (m)

The formula can be changed to

 $Pd= (30^{*}P^{*}G)/(377^{*}d^{2})$

From the peak EUT RF output power, the minimum mobile separation distance, d=0.2m, as well as the gain of the used antenna, the RF power density can be obtained.
