



5.3.1 TEST DESCRIPTION

The Equipment Under Test (EUT) was set up to perform the output power measurements. The results recorded were measured with the modulation which produces the worst-case (highest) output power. The reference level of the spectrum analyzer was set higher than the output power of the EUT.

The EUT was connected to the spectrum analyzer via a short coax cable with a known loss.






BTLE 1Mbps CH19 30 MHz - 1000 MHz



Drawing 1: Setup in the Anechoic chamber. For measurements below 1 GHz the ground was replaced by a conducting groundplane.




Drawing 2: Setup for conducted radio tests.
