

2.4. Related Submittal(s) / Grant (s)

This submittal(s) (test report) is intended to comply with Section 15.247 of the FCC Part 15, Subpart C Rules.

2.5. Modifications

No modifications were implemented to meet testing criteria.

2.6. Receiver Input Bandwidth

The input bandwidth of the receiver is 1.3MHZ,In every connection one Bluetooth device is the master and the other one is slave. The master determines the hopping sequence. The slave follows this sequence. Both devices shift between RX and TX time slot according to the clock of the master. Additionally the type of connection(e.g. single of multislot packet) is set up at the beginning of the connection. The master adapts its hopping frequency and its TX/RX timing according to the packet type of the connection. Also the slave of the connection will use these settings.

Repeating of a packet has no influence on the hopping sequence. The hopping sequence generated by the master of the connection will be followed in any case. That means, a repeated packet will not be send on the same frequency, it is send on the next frequency of the hopping sequence.

2.8. Equally Average Use of Frequencies and Behaviour

The generation of the hopping sequence in connection mode depends essentially on two input values:


- 1. LAP/UAP of the master of the connection.
- 2. Internal master clock

The LAP(lower address part) are the 24 LSB's of the 48 BD_ADDRESS. The BD_ADDRESS is an unambiguous number of every Bluetooth unit. The UAP(upper address part) are the 24MSB's of the 48BD_ADDRESS

The internal clock of a Bluetooth unit is derived from a free running clock which is never adjusted and is never turned off. For ehavior zation with other units only offset are used. It has no relation to the timeof the day. Its resolution is at least half the RX/TX slot length of 312.5us. The clock has a cycle of aboutone day(23h30). In most case it is implemented as 28 bit counter. For the deriving of the hopping sequence the entire. LAP(24 bits), 4LSB's(4bits)(Input 1) and the 27MSB's of the clock(Input 2) are used. With this input values different mathematical procedures (permutations, additions, XOR-operations) are performed to generate teSequence. This will be done at the beginning of every new transmission.

Regarding short transmissions the Bluetooth system has the following8ehavior:

The first connection between the two devices is established, a hopping sequence was generated. For Transmitting the wanted data the complete hopping sequence was not used. The connection ended. The second connection will be established. A new hopping sequence is generated. Due to the fact the Bluetooth clock has a different value, because the period between the two transmission is longer(and it Cannot be shorter) than the minimum resolution of the clock(312.5us). The hopping sequence will always Differ from the first one.

3. Peak Output Power


3.1. Measurement Procedure

For peak power test:

- 1. Connect EUT RF output port to the Spectrum Analyzer through an RF attenuator
- 2. Span: Approximately five times the 20 dB bandwidth, centered on a hopping channel.
- 3. RBW > 20 dB bandwidth of the emission being measured.
- 4. VBW ≥RBW.
- 5. Sweep: Auto.
- 6. Detector function: Peak.
- 7. Trace: Max hold.

Allow trace to stabilize. Use the marker-to-peak function to set the marker to the peak of the emission. The indicated level is the peak output power, after any corrections for external attenuators and cables.








4. 20dB Bandwidth

4.1. Measurement Procedure

- 1. Connect EUT RF output port to the Spectrum Analyzer through an RF attenuator
- 2, Set the EUT Work on the top, the middle and the bottom operation frequency individually.
- 3. Set Span = approximately 2 to 5 times the 20 dB bandwidth, centered on a hoping channel
 The nominal IF filter bandwidth (3 dB RBW) shall be in the range of 1% to 5% of the OBW and video
 bandwidth (VBW) shall be approximately three times RBW; Sweep = auto; Detector function = peak
- 4. Set SPA Trace 1 Max hold, then View.



TEST PLOT OF BANDWIDTH FOR LOW CHANNEL






TEST PLOT OF BANDWIDTH FOR MIDDLE CHANNEL

5. Conducted Spurious Emission

5.1. Measurement Procedure

- 1. Connect EUT RF output port to the Spectrum Analyzer through an RF attenuator
- 2. Set the EUT Work on the top, the Middle and the bottom operation frequency individually.
- 3. Set the Span = wide enough to capture the peak level of the in-band emission and all spurious emissions from the lowest frequency generated in the EUT up through the 10th harmonic.
 RBW = 100 kHz; VBW= 300 kHz; Sweep = auto; Detector function = peak.
- 4. Set SPA Trace 1 Max hold, then View.

TEST PLOT OF OUT OF BAND EMISSIONS WITH THE WORST CASE OF GFSK MODULATION IN LOW CHANNEL








TEST PLOT OF OUT OF BAND EMISSIONS OF GFSK MODULATION IN MIDDLE CHANNEL







TEST PLOT OF OUT OF BAND EMISSIONS OF GFSK MODULATION IN HIGH CHANNEL






TEST RESULT FOR BAND EDGE










GFSK MODULATION IN HIGH CHANNEL








