3. Go to the Bluetooth settings menu on your phone. Make sure that Bluetooth is turned on. Connect to the device listed as 'MUZ6005.'




4. The speaker will emit another audio tone to indicate that it is paired with your phone.


# **USING YOUR SPEAKER**




1. Slide the ONIOFF Switch to the ON position to power on your speaker. Slide the ONIOFF Switch to the off position to power off your speaker.



2. Press the Play/Pause Button to play a track. Press it again to pause a track.




3. Tap the \* Button to advance to the next track in a playlist. Tap the - Button to return to the last track in a playlist.




4. Press and hold the + Button to increase the volume. Press and hold the - Button to decrease the volume.
