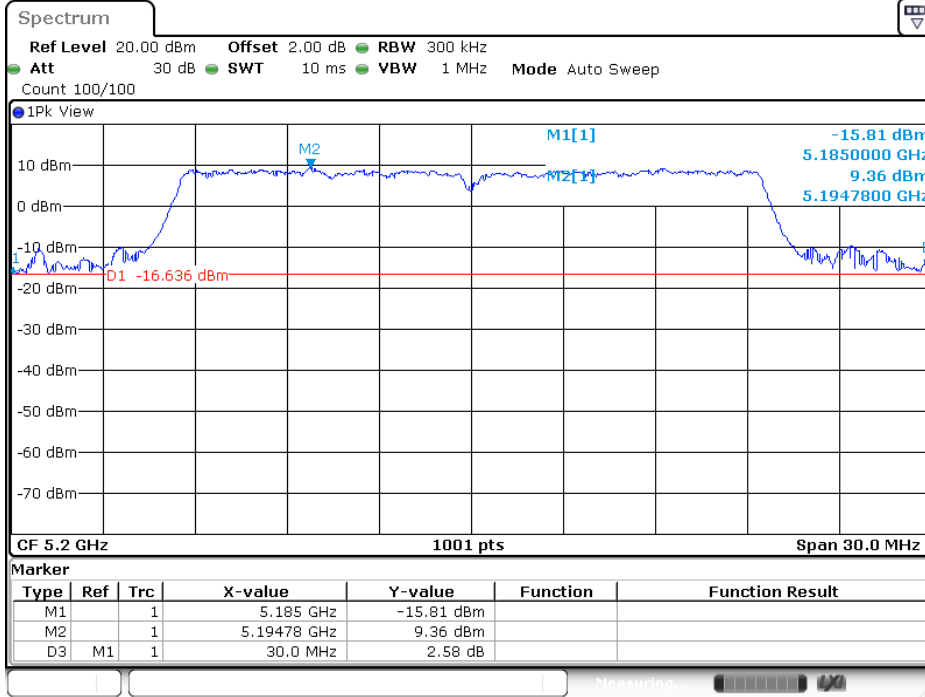
Test Plots For 6dB Emission Bandwidth
