



4.2 Other requirements Frequency Hopping Spread Spectrum System Hopping Sequence

4.2.1 Test Requirement:

47 CFR Part 15, Subpart C 15.247(a)(1),(g),(h)

4.2.2 Conclusion

Standard Requirement:

The system shall hop to channel frequencies that are selected at the system hopping rate from a Pseudo randomly ordered list of hopping frequencies. Each frequency must be used equally on the average by each transmitter. The system receivers shall have input bandwidths that match the hopping channel bandwidths of their corresponding transmitters and shall shift frequencies in synchronization with the transmitted signals. Frequency hopping spread spectrum systems are not required to employ all available hopping channels during each transmission. However, the system, consisting of both the transmitter and the receiver, must be designed to comply with all of the regulations in this section should the transmitter be presented with a continuous data (or information) stream. In addition, a system employing short transmission bursts must comply with the definition of a frequency hopping system and must distribute its transmissions over the minimum number of hopping channels specified in this section.

The incorporation of intelligence within a frequency hopping spread spectrum system that permits the system to recognize other users within the spectrum band so that it individually and independently chooses and adapts its hopsets to avoid hopping on occupied channels is permitted. The coordination of frequency hopping systems in any other manner for the express purpose of avoiding the simultaneous occupancy of individual hopping frequencies by multiple transmitters is not permitted.

Compliance for section 15.247(a)(1):

According to Technical Specification, the pseudo random sequence may be generated in a nine-stage shift register whose 5th and 9th stage outputs are added in a modulo-two addition stage. 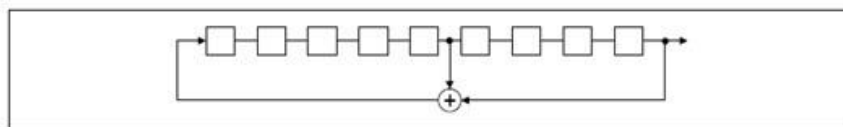

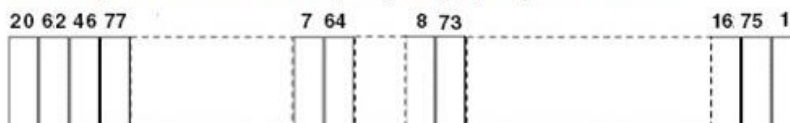
Linear Feedback Shift Register for Generation of the PRBS sequence

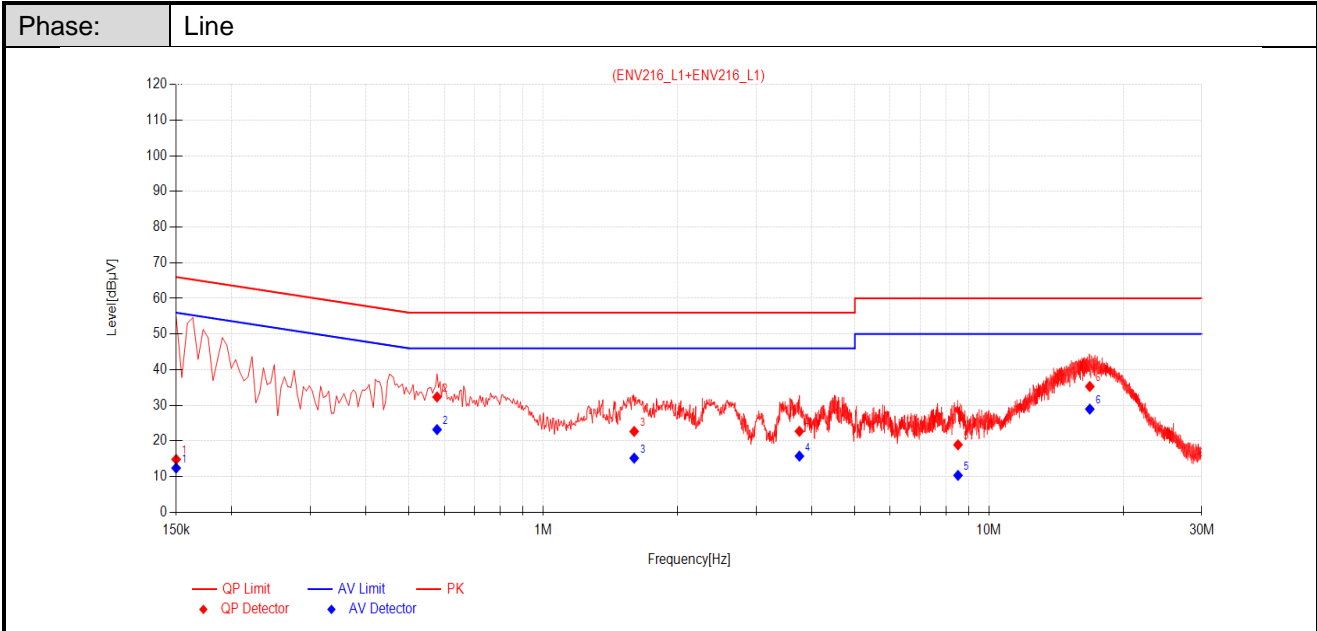

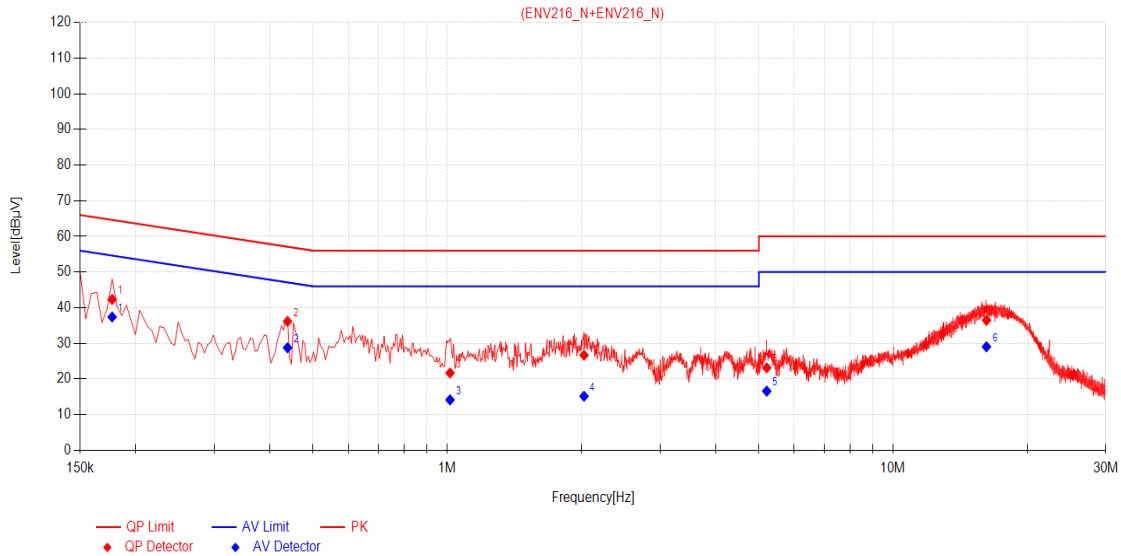

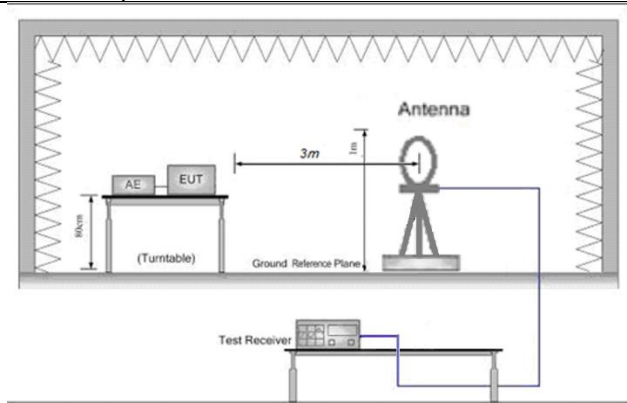


Figure 1. Below 30MHz

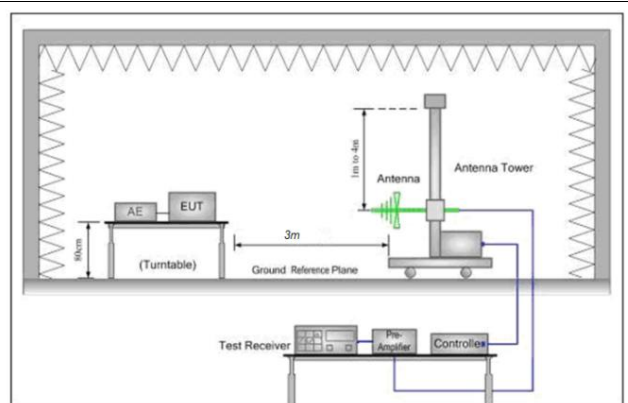


Figure 2. 30MHz to 1GHz



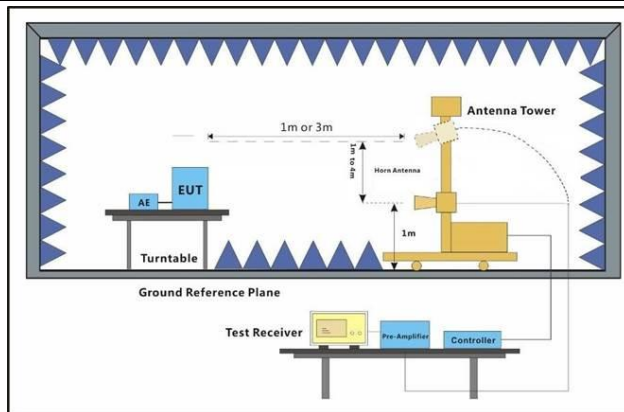


Figure 3. Above 1 GHz

<p>Test Procedure:</p>	<ol style="list-style-type: none"> For below 1GHz, the EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 or 10 meter semi-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation. For above 1GHz, the EUT was placed on the top of a rotating table 1.5 meters above the ground at a 3 meter semi-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation (Distance from antenna to EUT is 1m for measurements >18GHz). The EUT was set 3 or 10 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower. The antenna height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters (for the test frequency of below 30MHz, the antenna was tuned to heights 1 meter) and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode. Test the EUT in the lowest channel, the middle channel, the Highest channel. The radiation measurements are performed in X, Y, Z axis positioning for Transmitting mode, And found the Z axis positioning which is worse case. Repeat above procedures until all frequencies measured was complete. The low frequency, which started from 9 kHz to 30MHz, was pre-scanned and the result which was 20dB lower than the limit line was not reported The disturbance above 18GHz was very low, and the harmonics were the highest point could be found when testing, so only the harmonics had been displayed. At a measurement distance of 1 meter the limit line was increased by $20 \cdot \text{LOG}(3/1) = 9.54 \text{ dB}$.

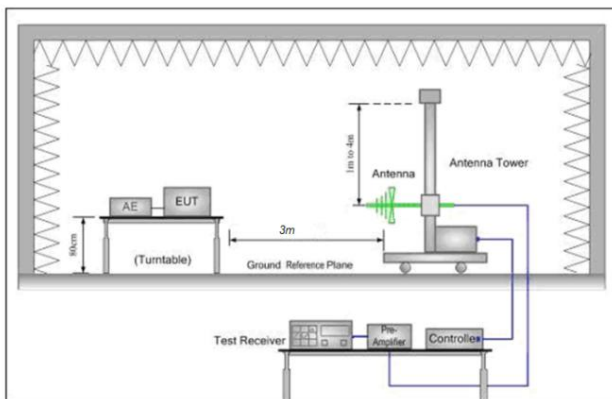


Figure 1. 30MHz to 1GHz

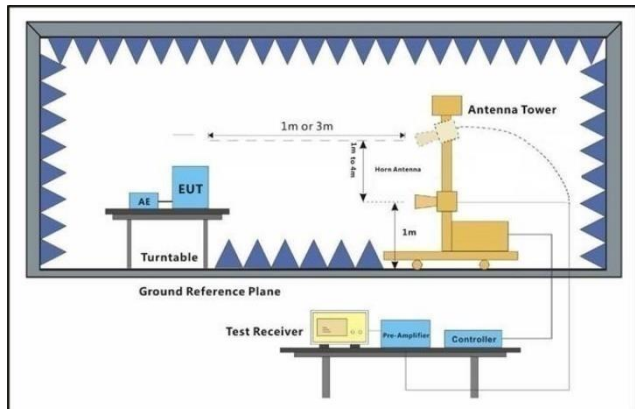


Figure 2. Above 1 GHz
